5.H. 058-2023 State Grant to the City for the Law Enforcement Specialized Units Program

Adopted Resolution R2023-022 authorizing the City Manager to execute a Grant Subaward Agreement, and any applicable amendments or related subaward documents, for the Law Enforcement Specialized Units Program Grant #LE22 06 7400 to fund services provided to survivors of domestic violence and their children from the California Office of Emergency Services, in the amount of \$203,143 with a local match from the City of \$67,715; and approving a transfer of \$67,715 from the General Fund to the Non-Recurring General Fund and increases to the Non-Recurring General Fund revenue and expenditure budgets in the total amount of \$270,858, as documented in Council Budget Amendment 3P09.



- Received a grant from the Bay Area Air Quality Management District in 2021
- Completed a regional greenhouse gas (GHG) inventory and forecast in 2022
- Carbon sequestration analysis and memo on short-lived climate pollutants are in process
- Continued discussions on a Regional Climate Action Plan
- The County and RCD are applying for a planning grant to develop a Regional Climate Action & Adaptation Plan

Near-Term GHG Reduction Opportunities

On-Road Transportation

- •Work with Public Works to research and apply for Federal funding to add electric vehicle (EV) charging stations at the Corporation Yard
- Assess opportunities for EV charging at other City of Napa facilities (public and/or fleet)
- Work with Community Development Department to research opportunities to restrict expansion of gas stations and drive through restaurants

Building Energy

- •Analyze opportunities for an electrification reach code for new construction and begin stakeholder outreach
- •Promote incentives and educational opportunities for energy efficiency and electrification (regional, State, Federal)
- •Work with partners (MCE Clean Energy, Bay Area Regional Energy Network (BayREN) and the CAC to explore opportunities for improved stakeholder access to information

Off-Road Vehicles

- •Promote Education and Incentives for gas powered garden equipment
- •Transition City of Napa landscaping equipment to electric where feasible

Solid Waste

- •Support the Utilities Department with two projects: (1) dry anaerobic digestion to renewable biofuel for use by refuse and recycling vehicles and (2) biomass gasification plant to produce renewable energy to run City's recycling & composting facility as well as for sale back to the power grid and create biochar.
- •Review the City's Sustainable Purchasing Policy and update it as needed.



"Napa Pipe" Overview

- 2013: County of Napa certified Environmental Impact Report
- 2014/2015: County of Napa approved a Master Tentative Map, Development Plan, Design Guidelines, and Development Agreement
- 2015: 109-acres [entire east and portions of west] of Napa Pipe site annexed to the City of Napa
- 2018: Applicant request modifications to the project requiring amendments to the Master Tentative Map, Development Plan, Design Guidelines, and Development Agreement
 - Changes mostly related to shifting more of the residential from the 63-acre portion west of the railroad tracks to the 91-acre portion east of the tracks
- 2020: 49-acres [remaining portions] of Napa Pipe site annexed to the City of Napa
- 2022: Site preparation begins (i.e. utilities & grading)
- 2023: First residential project for consideration
 - Planning Commission: February 2, 2023
 - City Council: March 7, 2023 (today)



"Napa Pipe" Overview

- 154-acre site developed in two phases
 - Phase 1: 91-acre (east) site
 - Phase 2: 63-acre (west) site
- Phase 1 includes the following:
 - 350 moderate and market-rate residential units
 - 70 very-low and low-income residential units
 - Approx. 90,000 square feet of office space
 - Approx. 75,000 square feet of warehouse space
 - A membership-based retail store (i.e. Costco)
- Phase 2 includes the following:
 - 455 moderate and market-rate residential units
 - 70 very-low and low-income residential units
 - Approx. 40,000 square feet of ground-floor neighborhood serving retail
 - Approx. 150 room hotel
 - Congregate care facility



Development Agreement


- Current version of Development Agreement approved (recorded) 2020, and limits scope of review to procedures set forth in the agreement
- Per Exhibit F of the approved Development Agreement, Design Review "...shall be submitted to the Director." "...Director will review the application as expeditiously as practicable."
- PL22-0100 for the home designs was approved by the Community Development Director on November 18, 2022, and therefore not part of the consideration for PL22-0055 per the Development Agreement
- Per the Development Agreement "The City shall not disapprove, require changes from or impose conditions inconsistent with Project Approvals it has previously approved."
 - In other words, the design guidelines and development plan were previously approved, and the Director has determined the home designs were consistent with adopted Napa Pipe Guidelines.

Project Overview

First residential project of Napa Pipe

- Project is requesting approval of a tentative subdivision map for the development of 79 single-family parcels within Blocks 16, 19, & 22 of the Napa Pipe Development Plan
 - Block 16: 28 parcels
 - Block 19: 28 parcels
 - Block 22: 23 parcels
- The proposed map is consistent with the approved Napa Pipe Development Plan and Design Guidelines as it relates to lot configuration and size

Napa Pipe Development Plan assumed unit counts, however, some variation in unit count per block was anticipated. Total unit count of 945 residential units would not be exceeded.

CEQA

In January 2020, the City of Napa adopted an addendum to the original EIR that evaluated the updated Napa Pipe Development Plan and associated documents. The development of property proposed by this tentative map is within the scope of analysis evaluated by the certified EIR and the addenda; thus, no further environmental review is necessary.



Planning Commission Meeting

- At its regularly scheduled hearing, the Napa Planning Commission unanimously recommended approval of the project in a 5-0 vote
- Planning Commission discussion related to general questions and comments
- Other than the applicant and their team, no members of the public spoke regarding the project



Summary

- Proposed Tentative Map complies with the development standards of the Napa Pipe Development Plan and Design Guidelines as it relates to lot sizes and configuration, and therefore <u>is consistent</u> with the approved Development Agreement, Development Plan, and Design Guidelines
- Because it is consistent and therefore analyzed under prior CEQA analysis, no further CEQA is required



City Council Actions

Staff and Planning Commission recommends that the City Council adopt a resolution:

- (1) approving a Tentative Subdivision Map for the Napa Pipe-Brookfield Subdivision; and
- (2) determining that the actions authorized by this resolution were adequately analyzed by a previous CEQA action.








