D. Corey provided comments in opposition of the ordinance and shared concerns with the data previously presented. He suggested postponement of the approval until the traffic calming program had been completed.

Mayor Sedgley and member of Council read the proclamation. Lilea Heine, representative of the Napa Valley Black History Month Celebration Steering Committee, joined by Quinn Thompson, accepted the proclamation and provided remarks.

Community Recovery Bank - City Manager's Funding Recommendations

Mayor Sedgley introduced the item.

Mayor Sedgley and Councilmembers disclosed individual conflicts of interest among individual recipients of the proposed funding. Mayor Sedgley and Councilmember Alessio shared they would need to recuse from any action to fund the Napa County Historical Society as they both served on the Board. Additionally, Councilmember Narvaez shared he would need to recuse from any action to fund the Boys & Girls Clubs Napa Valley as he served on the Board. Councilmember Painter had no conflicts.

Assistant City Manager Liz Habkirk and Finance Management Analyst Linda Zvarcova provided the staff report.

Assistant City Manager Habkirk shared that, due to a lack of quorum of Councilmembers available to vote on the grant recommendation for the Napa County Historical Society item, staff would remove the recommendation from the resolution, and that the total amount of funding recommended that afternoon would be \$1,125,000. Staff would bring the recommendation for the Napa County Historical Society back for future consideration at a meeting when a quorum of Councilmembers would be in attendance.

Mayor Sedgley announced that Council would move forward with review of the Boys & Girls Clubs of Napa Valley funding recommendation and asked Councilmember Narvaez, who had to recuse, to leave the room.

Councilmember Narvaez left the room at 7:03 P.M.






# International Property Maintenance Code

# What is the IPMC?

 The International Property
Maintenance
Code, (IPMC)
establishes
maintenance
requirements for
existing buildings.





# Why adopt the IPMC?



 The IPMC provides a reasonable level of health, safety, property protection, and general welfare for occupied and unoccupied structures.



# Benefits of the IPMC Adoption

- Compliments existing Building Standards Codes.
- Holds property owners accountable for:
  - Substandard structures
  - Vermin infestations
  - Substandard sanitation
  - Lacking heating facilities
  - Lacking access to water
- Establishes boarding standards for abandoned properties.
- Allows Code Officials to issue notices to responsible persons to abate nuisances, take emergency measures, and/or vacate the premises.



# City of Napa Community Recovery Bank Funding Recommendations

# **Community Recovery Bank**



- City of Napa received \$12.15M in American Rescue Plan Act Funds
- A "Community Recovery Bank" with \$1.15M of ARPA funds was designated for a community grant process as part of the FY22-23 Budget
- A community survey was conducted last spring to identify community priorities for funding



# **Community Survey**

In April 2022, the City of Napa conducted an online survey to gather input from the community regarding potential CRB funding priorities

The survey was available from April 1<sup>st</sup> - 22<sup>nd</sup> in English and Spanish and there was a total of 402 respondents

Consistent with City Council discussion, the survey focused on the following areas:


- Housing Assistance
- Addressing Homelessness
- Childcare
- Support for Local Businesses
- Workforce Development

Under each of the above areas, respondents were also asked to rank areas for funding, as well as types of potential assistance programs

# **CRB Grant Process**

- Non-profits and small businesses had the opportunity to apply for CRB funds via a grant application process last fall
- A review panel comprised of City staff and community members reviewed the applications and have made a recommendation to the City Manager
- The City Manager has reviewed the panel's recommendations and concurs
- Next step in process is for City Council review and approval

# **CRB Applications**

- The City received 78 applications for funding totaling over \$9M in funding requests
- 48 applicants passed the initial screening for eligibility based on the grant requirements
- These applicants moved forward in the process and were scored by the CRB Review Panel
- Following an extensive review and scoring process,
   21 applicants have been recommended for funding



# **CRB Scoring Criteria**

- Organizational need
- Alignment of the proposed project or program with the results of the community survey
- Level of community benefit
- Extent to which the funds would go toward those disproportionately impacted by the pandemic
- Whether use of the funds could be accomplished by December 2025
- Whether the proposed budget was reasonable
- Whether the organization or small business demonstrated the necessary capacity to effectively administer the proposed use of funds



# **Funding Considerations**

It should be noted that given the funding available (\$1.15 million) was greatly exceeded by the total funding requests (over \$9 million), only one applicant is recommended to receive their total amount of requested funding.

Every effort was made to align level of funding with both the applicant's total score, as well as consideration for the needed funds for the proposed project or program.

The total funding recommended is equivalent to the amount allocated to the Community Recovery Bank (\$1.15M)



# **Next Steps**

- Council to take action to approve the CRB funding recommendations as presented and authorize the City Manager to enter into funding agreement, or direct staff to make any needed modifications
- Following Council action, staff will work with the CRB fund recipients to execute funding agreements and craft reporting mechanisms for each project/program

SUBJECT: Item 15.A - ARPA Community Recovery Bank Grant Descriptions

The City Council will consider funding recommendations for the American Rescue Plan Act (ARPA) Community Recovery Bank at your February 21, 2023 Council Meeting. In addition to the background materials provided in the agenda report, below are details regarding the agencies and programs recommended for grant funding:

#### Mentis

Funds will cover the cost of personnel, operating, and indirect expenses for the first year of the program while Mentis work with Napa County Mental Health Department to transition the program to Medi-Cal funding for long term sustainability. The ARPA dollars will be used as bridge funding to allow Mentis time to develop a permanent and sustainable funding stream. Recommended Grant Award: \$110,000

#### **Abode Services**

Funds will assist with one-time costs, the sober living program, and ongoing operations. Grant funds will help enhance Abode's Napa programs as follows: Subsidize 6 months of rent for clients in active addiction recovery programs, cover one-time costs to house people or keep them housed, and fill operational needs raised by the South Napa Shelter expansion from 69 to 104 beds.

Recommended Grant Award: \$185,000

#### NEWS

Funds will fund one-time homeless prevention costs for NEWS' Domestic Violence Housing First (DVHF) program. The DVHF program provides case management and assistance to survivors and children who identify as having significant housing and trauma-related mental health needs.

Recommended Grant Award: \$100,000



#### On the Move

Funds will help On The Move (OTM) pay for overhead and personnel costs to provide outreach through their Homelessness Prevention Program. OTM will conduct outreach activities at community events, in schools and faith communities, and via other local service providers with the aim to build relationships and reach the hardest to serve populations within Napa. Individuals will receive information and referrals to various community services that exist within the City.

Recommended Grant Award: \$150,000

### Community Action of Napa Valley

Funds will help support the Napa Valley Food Bank (a pre-existing program) in expanding outreach into remote, rural, and low-income areas that are otherwise underserved through free markets, food pantries, and USDA deliveries to those in need.

Recommended Grant Award: \$20,000

### Wayfinder Family Services

Funds will allow Wayfinder to purchase food, pay outstanding utility bills, increase housing security by paying rent and/or deposits, childcare costs and help with other emergency monetary needs for their Kinship Support Services Program in Napa County. Funding from the Community Recovery Bank will enable Wayfinder to continue delivering high-quality programs to their kinship families and make a deep and lasting impact on the children and families they serve in Napa County, particularly those who are experiencing food insecurity and housing instability.

Recommended Grant Award: \$15,000

### Feeding It Forward, Inc.

Funds will help complete the permitted kitchen remodel to increase food access, process food to safely prolong shelf life, prepare meals for shelters by Abode and CBOs, and provide a backup kitchen in emergencies.

Recommended Grant Award: \$125,000

#### Downtown Napa Farmer's Market

Funds will help cover personnel costs allowing for other funds to be used to strategically plan activities, which may include small business vendor training to increase sales, marketing/community engagement to increase underrepresented customers attendance, and hiring additional operations staff to support food assistance programs and vendor management.

Recommended Grant Award: \$25,000



### Napa County Historical Society

Funds will support the Napa County Historical Society design and mount two exhibits in 2023 (Pioneering Women of Napa Valley [Spring 2023] and A City of Immigrants [Fall 2023]). Each exhibit will run for 6 months and have a virtual component extending the reach of the exhibits to larger audiences both locally and globally. The funding may also be used to provide enriched programing that augments the exhibits and showcases the talent and diversity of the communities of the Valley. The programs will include winter lecture series, summer walking tours, and educational events.

Recommended Grant Award: \$25,000

### Napa County Bicycle Coalition

Funds will help bridge a funding gap in the existing Safe Routes to School program which encourages walking or biking to school, providing education on traffic safety, how to properly wear bike helmets, bike handling skills, and providing opportunities to practice these safety skills. Additionally, the Coalitions program works with school sites to reduce barriers to walking and riding and partners with them and the City of Napa to bring about infrastructure change.

Recommended Grant Award: \$15,000

### Teacher Resource Center of the North Bay

Funds will help the Teachers Resource Center of the North Bay (TRCNB) to expand its community outreach program, allowing more public-school teachers to join and have access to free classroom supplies.

Recommended Grant Award: \$10,000

#### Napa Downtown Merchants

Funds will help Downtown Napa Association cover existing programs and community events and reinstate Napa City Nights, a Friday night free music event held in Veterans Park.

Recommended Grant Award: \$25,000

### Solano County Private Industry Council, Inc.

Funds will help Solano-Napa Small Business Development Center provide rebates of up to \$1,000 per business for the purchase of commercial grade battery-powered leaf blowers for landscaping service businesses licensed by the City of Napa. This new program will leverage funding provided by the state through the Clean Off-Road Equipment Voucher Incentive Project (CORE) and allow Napa's small landscaping service businesses to transition to non-polluting equipment at a very low cost.

Recommended Grant Award: \$85,000

### Wine Country Bicycle Adventures, Inc.

Funds will help Napa Valley Bike Shop start a new program that will offer 50 to 100% subsidies (up to \$2,000 per qualified resident) on electric bikes to low-income households to provide ebikes as a means to get to work. This program would also help subsidize bike repair services to these low-income residents.

Recommended Grant Award: \$35,000

### Boys & Girls Club of Napa Valley

Funds will help the Boys & Girls Clubs of Napa Valley launch "The Pop Up STEM Lab", a special mobile STEM program that will service Napa and provide youth access to science programs to reinforce math, science, logic, and communication skills.

Recommended Grant Award: \$100,000

#### Nahar Montessori, LLC

Funds will be used to offset the increase in rental costs allowing the business to maintain operations, as well as to offset costs incurred due to COVID restrictions.

Recommended Grant Award: \$15,000

### Dreher Family Childcare

Funds will be used to provide tuition assistance to low-income families while also assuring teachers receive professional development and a fair living wage to meet their basic needs. *Recommended Grant Award*: \$15,000

#### Napa Valley (Cooperative) Nursery School

Funds will help Napa Valley Nursery School cover current school year expenses and offer tuition assistance, purchase educational materials as needed, offer fields trips and sensory-rich in-school experiences, as well as offer child development-focused lectures and seminars by field experts to the NVNS families and to the larger Napa community.

Recommended Grant Award: \$15,000

### The First Presbyterian Church and Congregation of Napa

Funds will help Presbyterian Day School renovate three main areas used by the preschool (kitchen, concrete courtyard, and main toddler room) and expand their program to offer care for toddlers.

Recommended Grant Award: \$15,000

#### Hopper Creek Napa Valley, LLC

Funds will help Hopper Creek Montessori develop new activities and curricula for families at home and publish these learning activities on their website as well as help them setup a scholarship program for families who are unable to afford quality early childhood education. *Recommended Grant Award*: \$15,000







PLAN 1 - TRADITIONAL PLAN 3 - CONTEMPORARY









# Has Napa City Abandoned Slow Down Napa, Increasing Housing Opportunities and Better Architecture?

After three years of working with Napa City, Edenbridge Homes is poised to have its subdivision map approved for 11 houses on a 3.7 acres site on Browns Valley Road. When the project was first conceived in 2021 The site is in the County and needs to be annexed while the zoning was limited to three houses per acre at that time. The new city General Plan calls for 3–8 unit/acre and could have been an excellent opportunity to create up to 25 affordable homes. That will never happen.

While I am a strong advocate of higher density housing, I can't hold Edenbridge responsible for not pursuing higher density here. Neither the City Housing Element or the Zoning ordinance have been modified to accommodate the increased densities. It's nice to wish for higher density, but not providing the mechanisms to fulfill the need is a disappointment. While I mourn the lost opportunity to create more affordable housing, I recognize it's too late.

This project should've been approved years ago. The pandemic, loss of staff and budget constraints has slowed the process, but it is my belief, there are still errors in this proposal and the City Public works has only made it worse. Traffic calming and good traffic design is not on their agenda.

Here is an example of where the engineers have failed the city.

First, if you review the proposed plans, the opposite side of the Browns Valley Road is not exhibited anywhere in these applications. Nowhere is the parking lot access into the Westwood Hills Park parking lot shown which is far to the East of the new subdivision entry. Westwood park is becoming extremely popular and the two road entrances should lineup. This is a fundamental public safety concern since it would be extremely difficult for the subdivision access to move eastward to line up with the existing park access. Instead, the park access should be moved to line up with the new street. There could be a four-way stop intersection here or if not, at the very least, a pedestrian crosswalk with lights and landscaped bulb outs.

This is a perfect example of how we can help slow traffic down in Napa. I will guarantee there will be incidents and consequences for the city with the two not in line.

A second issue is a design exception request by the client to allow sidewalks to be attached to the street, rather than separated by a planter, an essential Napa City planning requirements is Pedestrian Friendly streets for at least 15 years. I could not find the exception request as part of this application. I am very much against the granting of the exception as it stands. If we're not going to have a separated sidewalk, then we should have Bulb-out landscape pockets at individual driveways with trees to both slow traffic and create a more interesting streetscape. We did that right down the street at Napa Villas and there's no reason why it won't work here.

My last issue: is this architecture appropriate?



While the existing residence has limited historic value, it is one of the oldest houses in the community and has significant character. None of the architecture that Edenbridge has produced reflects a Browns Valley character or has the stone and farmhouse charm. The present house plans could be anywhere and don't reflect Edenbridge's quality development.

The floor plans are gigantic boxes, without character or flair. I understand the fundamental challenge of the costs and improvements required. Still these 3000 to 3500 square foot homes will be selling in the \$2 Million and more range they deserve a better sense of place. *The designs should be a gift to the street and community.* 

I wish to be clear that I support annexing, approving the EIR and subdividing this property. However, the site and architectural designs are there yet. I believe that Edenbridge can do a valuable service for the city in creating quality homes and an excellent community addition to Browns Valley. I believe that with patience and attention to detail, it can become a true asset.

Dear Mayor Sedgley and City Council Members,

I am Napa resident and a volunteer with Moms Demand Action for Gun Sense in America, which has a local Napa Valley presence. Moms Demand Action is a non-partisan grassroots organization made up of both non-gun owners and gun owners with the goal of reducing gun violence and improving gun safety for everyone. We believe the 2nd Amendment can be respected while simultaneously better protecting people through common sense gun legislation.

We support Napa moving forward to adopt a Safe Storage Ordinance which would require all firearms in a residence be securely stored in a locked container or disabled with a trigger lock. One small child dies almost every day in this country after finding an unsecured firearm in their own home or in a relative's home or while playing at a friend's house. Two older children, particularly teens, die every day in this country by suicide from an unsecured firearm they obtain from their home or another family member's home. In addition, 80% of school mass shootings are done by current or former students, using an unsecured firearm obtained from their own home or a relative's home.

Research shows that keeping guns securely stored does NOT hinder self-protection- - a gun can be accessed within seconds- but it DOES prevent unintentional deaths of children and teen suicides, by as much as 85% depending on the type of storage. Storing firearms in a securely locked container can also prevent guns from being easily stolen in a home robbery. A DOJ-approved safe storage device can be obtained for as little as \$40 so the cost is not at all prohibitive, and trigger locks are often given out free at police stations.

Some people are under the impression that the California Penal Code (25100) already addresses this issue but it definitely does not. It does not define how to safely store a firearm and it doesn't apply to all homes. For example,

parents often hide their guns (feeling this makes them safe) rather than locking them up, but studies show 70% of children know the location of these hidden guns in their own home and many have even handled them.

Many cities and towns up and down California have already adopted Safe Storage ordinances, including our neighbors Yountville and St. Helena. We hope that Napa will do the same soon.

When considering the penalty for violating the Safe Storage Ordinance, Moms Demand Action supports a civil penalty, rather than a criminal penalty. We suggest a fine or community service. This is because we feel people of color may be disproportionately affected by this law and we also think a criminal penalty is unnecessary. Most firearm owners are law abiding and will follow the law if it is simply in place. We feel having this ordinance on the books will ultimately help to change our culture, much like the seat belt law did in the 1980's. Towns early on in the process of adopting safe storage ordinances did often adopt a criminal penalty – that is, a misdemeanor-- but more recent towns have adopted a civil only penalty. We therefore ask that if you move forward with this ordinance, that a civil penalty be adopted.

Dear Mayor Sedgley, and Council Members Alessio, Luros, Narvaez and Painter,

I am a community member, parent of teenagers, former educator, current NVUSD Trustee, and a Napa Valley Moms Demand Action volunteer. Although I will not be able to attend your council meeting in person as you consider the Safe Firearm Storage Ordinance, I am writing in advance to urge you to move forward to adopt a safe storage ordinance that requires all firearms in a residence to be securely stored in a locked container or disabled with a trigger lock.

It is indisputable that access to unsecured firearms leads to many tragic and traumatic incidents of gun violence every year. Here are a few devastating statistics from the most recently available data on gun violence:

- Every year 350 children in America gain access to a firearm and unintentionally shoot themselves or someone else.
- Every year, nearly 700 chidren die by suicide with a gun.
- 80% of school shooters acquire their firearm from the home of a parent or close relative.
- 4.6 million children in our country live in a home with at least one loaded, unsecured firearm.

It is also indisputable that our country is in the throes of a gun violence pandemic. The onslaught of tragic news day after day can be overwhelming. Just this past weekend, February 17-19, there were 10 mass shootings (4 or more people shot, not including the shooter). Meanwhile we're still reeling from multiple mass shootings in California in recent weeks, and the latest school shooting at Michigan State University last week, along with the heartbreaking fifth anniversary of the horrific shooting in Parkland Florida on Valentine's Day. It's relentless and scary. It can sometimes seem like there's nothing we can do about it. But that's not true.

While no single act will resolve the gun violence crisis, we cannot let that stop us from taking meaningful actions that will save lives whenever we can. Passing a safe storage ordinance is one of the meaningful actions that will make our community safer. Current statutes on the books do not apply to all households, nor do they specify what safe firearm storage means. (For the record, to be safely stored, a firearm must be unloaded, locked in a secure container or disabled with a trigger lock, and stored separate from ammunition.)

I urge you all to support the passage of the safe firearm storage ordinance. The towns of St. Helena and Yountville have already passed safe firearm storage ordinances. In addition, Calistoga, St. Helena and Napa Valley Unified School Districts have all passed safe storage resolutions. Please add to the Napa Valley's momentum for safety and public education and support passage of this ordinance. You may never know how many lives you save.

Thank you for your consideration, and for your service to our community.
