RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NAPA, STATE OF CALIFORNIA, APPROVING AND AUTHORIZING THE POLICE CHIEF TO EXECUTE ON BEHALF OF THE CITY AMENDMENT NO. 1 TO AGREEMENT NO. C2025-831 (CHP AGREEMENT NO. 24C325000), INCLUDING AN AMENDMENT TO THE UNDERLYING LICENSE AGREEMENT INCLDUED IN THE AGREEMENT, WITH THE CALIFORNIA HIGHWAY PATROL ("CHP") TO EXTEND THEIR USE OF THE CITY'S SHOOTING RANGE THROUGH JUNE 30, 2026 AND DETERMINING THAT THE ACTIONS AUTHORIZED BY THIS RESOLUTION ARE EXEMPT FROM CEQA.

WHEREAS, the Police Department operates and maintains a firearms training facility ("City's Shooting Range") for conducting and maintaining required training for police officers; and

WHEREAS, the City Council approved Resolution R2505-014 on February 18, 2025, authorizing the Chief of Police to enter into an agreement with the California Highway Patrol (CHP) for the use of the City's Shooting Range through December 31, 2025, at the facility use rate of \$2,000.00 per month; and

WHEREAS, the CHP has requested an extension of this license agreement through June 30, 2026; and

WHEREAS, the CHP requires this license agreement to be approved by a resolution by this City Council; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Napa, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct and establish the factual basis for the City Council's adoption of this Resolution.
- 2. The City Council hereby determines that the actions authorized by this Resolution are not subject to CEQA, pursuant to CEQA Guidelines Section 15060(c). In the alternative, and on a separate and independent basis, the actions authorized by this resolution are exempt from environmental review pursuant to

ATTACHMENT 1

CEQA Guideline 15301 as the licensing of an existing facility involving no or negligible expansion of use.

- 3. The City Council hereby approves and authorizes the Police Chief to execute Amendment No. 1 to agreement (C2025-831)with CHP for the use of the City's Shooting Range through June 30, 2026, including the underlying License Agreement.
- 4. This Resolution shall take effect immediately upon its adoption.
