






5-Year Collection Rate Revenue by Line of Service

Programmatic Status



- Weekly Residential Curbside Service Trash (Landfill), Recycling & Compost Service (including Food Scraps/Soiled Paper since 2015)
- <u>4 streams of Commercial Service</u> Trash (Landfill), Recycling, Greenwaste (Yard Trimmings) & Food Scraps Composting (since 2015)
- Roll-Off Debris Box Trash and Multiple Recyclable/Compostable Materials (includes Clean Wood, Concrete, Dry Wall, Carpet, Metals, Cardboard, Mixed Recyclables, Dirt, Pomace & Yard Trimmings)
- <u>City Diversion Rate</u> 65% overall landfill diversion (recycling and composting) for 2024 (70% by State formula). City and State goal is 75% level (or more).

Tonnage Processed at MDF in 2024

- Recycling = 49,400 tons
- Composting = 93,800 tons
- Construction & Demolition = 18,500 tons
- Wood = 10,000 tons
- Other Materials (e-waste, tires, bulky items) = 600 tons
- Facility Residue (disposal) = 13,900 tons
- 94% overall facility diversion (recovery) rate
 - (Note: 2% improvement vs. 2023)
- Total Inbound Tons = 172,300 (vs.103,500 in 2006; 66% increase!)










2. FINANCIAL POSITION OF SWR FUND




SWR Fund Overview – FY25/26 Expenditures

FY 2025/26 Budgeted Expenditures (Total = \$52,605,885)




SWR Fund Overview—FY25/26 Revenue

Why are Rate Increases Needed?





- Last increase was January 2022
- For proposed FY2025/26 budget, expenditures will exceed revenues (\$5.2M in FY 25/26; \$12M in FY29/30)
- With no rate increase, current reserves would be exhausted by end of FY2026/27

2022 NRWS Contract Amendment

Approved in October of 2022, this NRWS Contract Amendment addressed and accomplished the following:

- (1) Operating & emission testing costs for \$10M Covered Aerated Static Pile (CASP) composting system at MDF
- (2) Ongoing operating & maintenance costs for \$2.5M stormwater management system at MDF
- (3) Fixed annual labor cost increases at 3.5% per year to CY2031
- (4) Fixed non-labor annual increases at 2.5% per year to CY2031

 * Non-labor annual increases have a 50/50 shared "safety valve" provision when Bay Area CPI exceeds 5% in a given year as occurred in 2023
- (5) Set up an every-other-year "Reconciliation Review" process when residential, commercial and/or roll-off service growth exceed certain thresholds (currently a combined payment to NRWS of \$972K/year).

Added together, the amendment increased the base contract payment to NRWS by approximately \$1.87M/year (\$900K/year + \$972K variable payment based on growth in service).

SB 1383 – Current Compliance Status

Current Overall SB 1383 Compliance Score:



- 99% of commercial accounts subscribed to organics collection service
- 31 out of 47 multi-family (apartment) complexes with no organics collection service now subscribed (11 remaining by end of CY2025)
- **Need Biomass Gasification** or Anaerobic Digestion to fulfill SB 1383 procurement requirement for use of organic derived renewable energy and/or fuel.



HIGHLIGHTS OF A'S SB 1383 CONTRACT AMENDMENT:







New Collection Truck & Driver:

- New commercial compost collection vehicle (\$523k less \$113k SB 1383 grant = \$410k)
- New Thursday through Monday route
- 1600 new wheeled cart for organics (200 lockable)
- Quarterly cleaning of organics equipment
 - * Note: Proposed 2025/26 budget includes increased cleaning schedule for commercial food carts from quarterly to monthly cleaning by NRWS.



HIGHLIGHTS OF AT SB 1383 CONTRACT AMENDMENT:







New NRWS Staff:

- Two NRWS Recycling Outreach Specialists
- 1.5 new NRWS CSRs (0.5 NCRWS/County)
- Two NRWS Compost Equipment Operators
- New staff to educate, support, monitor, conduct route reviews/audits & report on SB 1383 progress; operate new organics processing equipment



HIGHLIGHTS OF A'S SB 1383 CONTRACT AMENDMENT:







New Processing Equipment:

- \$1.45M optical sorter (85% City/15% NRWS)
- SB 1383-required quarterly facility audits
- \$2.6M in new organics processing equipment (\$1.5M grant-funded)
- In FY24/25, projected to add \$216k new material sales revenue; avoid \$460k in disposal costs & reduce transportation costs by \$154k (\$830k total)

SB 1383 NRWS Contract Amendment

Total Impact = Approximately \$2.8M per year

- Reset NRWS Contract Base: current collection rates at just over \$31M per year, \$2.8M translates into 9% of added cost per year. Contract terms are through 2031.
 - 3.5% per year in labor cost escalations
 - 2.5% per year in non-labor costs
 - "Safety Value" 50/50 shared cost provision if Bay Area CPI is above 5%
- Unfunded State Mandate: SB 1383 is state law and generally an unfunded mandate. Napa is ahead of many jurisdictions in implementing SB1383 and also understanding costs of full compliance with SB 1383.
- Key Local Climate Action Step: SB 1383 a key local program for Countywide Climate Action goals since methane is 30-50 times GHG impact vs. CO2.



2. Capital Improvements at MDF

- In 2016, the City issued \$12.5M in Solid Waste Revenue Bonds for the following:
 - \$10.0M "Covered" Composting system to comply with State regulations to process food scraps and air district regulations for emissions
 - \$2.5M Stormwater system improvement to comply with Statewide "Compost Order" from Regional Board
 - \$2.0M Covered processing and storage area for recyclables to comply with stormwater discharge permits
- Increased annual expenses by approximately \$900/year for debt service
- Requires a minimum 1.25x coverage ratio which must be considered for rate-setting



- Program in place since since 2019 at \$10/month for up to 1,250 households
- Recommended Increase to \$15/month for up to 1,500 households (1,222 households currently participating in SWR's RateShare program)
- Revenue source is material sales (not rate revenue)

65 Gallon Monthly Residential Service Cost Comparison




10-year Average Material Sales Price Per Ton for Residential Recyclables





5-year "phase-in" for Commercial Compostable Compostab

- Current commercial organics collections rates have a 75% of MSW (landfill) charge for commercial food scrap collection and "no charge" for commercial yard trimmings service.
- SB 1383 requires all commercial generators (including multi-family served as commercial accounts) to subscribe and be provided access to collection of compostable organics.
- Attachment 2 to staff report is a detailed study for phased-in consolidation of current commercial compostable organics service.

Solid Waste & Recycling Proposed Rates to Meet Requirements

Residents can be proud of Napa's solid waste program that diverts approximately 65% of collected materials from landfill. Clean Compressed Natural Gas (CNG) vehicles collect materials that are processed at our robust recycling, food scrap and composting facility. What has changed? State Senate Bill 1383 requires recovery of organic materials. Initiatives have been implemented with Napa Recycling and Waste Services (NRWS) to ensure compliance.

Rates have not increased since 2022 and changes are proposed to meet the costs of the Citv's successful materials diversion program. If approved, residential customers can expect to see the following in their future monthly solid waste bills from NRWS:


