Three things the City of Napa is doing well: 1) Preservation of Napa's Historic Character: Napa has done an excellent job of preserving its historic downtown and creating a vibrant, charming atmosphere that attracts visitors while maintaining the city's unique character. The city has invested in efforts to protect its historic buildings, which helps retain its small-town charm while supporting tourism and local businesses. 2) Wine Industry and Tourism: Napa is globally recognized for its wine industry, and the city has effectively leveraged this asset to build a thriving tourism economy. The city's partnerships with local wineries and hospitality businesses help drive both economic growth and job creation. Napa's investment in tourism infrastructure, such as the Napa Riverfront and outdoor activities like biking and hiking, has further enhanced its appeal. 3) Commitment to Sustainability: The City of Napa has made strides in promoting sustainability and environmental responsibility, including efforts to improve waste management, reduce carbon emissions, and promote renewable energy initiatives. The city's focus on preserving natural resources and promoting green building practices reflects a forward-thinking approach to sustainability. Three things the City of Napa could do better: 1) Affordable Housing: Like many cities in California, Napa faces a growing need for affordable housing. The cost of living is high, and many residents struggle to find housing that is both affordable and suitable for their needs. While there have been efforts to address this issue, there is still more work to be done in ensuring that housing development meets the needs of all income levels, particularly for working families, seniors, and low-income individuals. 2) Traffic and Infrastructure Improvements: Traffic congestion, particularly along Highway 29 and other key corridors, can be a significant issue in Napa, especially during peak tourist seasons. While Napa has made efforts to improve its transportation infrastructure, there is a need for more innovative solutions to alleviate congestion, improve public transportation options, and enhance pedestrian and bicycle pathways to reduce reliance on cars. 3) Homelessness Services: While Napa has taken steps to address homelessness, there remains a critical need for more comprehensive services and housing options for individuals experiencing homelessness. Expanding shelter capacity, providing more mental health resources, and increasing supportive services for homeless residents could help address this growing issue, ensuring that people are not only housed but also supported in rebuilding their lives.

4. Please describe what you believe are major concerns of the City of Napa residents and businesses. What could we do better to meet these concerns?

Affordable Housing Crisis Concern: One of the most pressing concerns for residents, particularly those with moderate to low incomes, is the high cost of housing. Napa's housing market is increasingly unaffordable, which puts pressure on working families, seniors, and young people trying to settle in the city. Many individuals and families are being forced to move out of Napa or face long commutes to work. How to Address It: The City could accelerate efforts to create more affordable housing units by incentivizing the development of low- and moderate-income housing. This could include offering tax incentives to developers, revising zoning laws to allow for higher-density housing near transit hubs, and exploring opportunities for affordable housing in underutilized commercial properties. Additionally, expanding affordable rental options and assisting first-time home buyers through subsidies or down payment assistance programs could help ease the housing burden. Business Retention and Economic Development Concern: Napa businesses, particularly small businesses, are facing pressures from rising operational costs, including rent, wages, and materials. While tourism is a significant driver of the local economy, there are concerns about over-reliance on the hospitality industry, especially during off-peak seasons. Local businesses want to see more support for diversifying the economy and promoting year-round economic activity. How to Address It: The City could create programs to support small businesses, such as grants, low-interest loans, or technical assistance for entrepreneurs. Expanding the local economy beyond tourism by attracting diverse industries—such as tech, healthcare, and green innovation—could provide more job opportunities for residents. Additionally, the City could work on improving the commercial and retail infrastructure, making it easier for new businesses to open and thrive in Napa, while also fostering an environment that supports existing businesses through tax incentives and reduced regulatory burdens.

I would prioritize supporting small businesses, entrepreneurs, and local job creation through incentives, grants, and programs that reduce red tape for startups. Additionally, I would work to develop strategies for attracting industries like clean energy, technology, and healthcare that provide stable, well-paying jobs year-round. Supporting the growth of Napa's small businesses and making the city an attractive place for new enterprises will help ensure that our economy remains robust and dynamic. Improve Transportation Infrastructure and Reduce Traffic Congestion Traffic congestion is a major concern for Napa residents, and it is only expected to worsen as the city grows. My goal as a councilmember would be to develop solutions that improve the flow of traffic, reduce congestion, and promote alternative transportation options. The pressure of rising housing costs would be mitigated by the creation of diverse housing types—ranging from affordable apartments to family-sized homes ensuring that Napa remains an accessible and inclusive place to live for people from all walks of life. A Connected, Walk-able, and Transit-Oriented City Napa would have a modern, interconnected transportation network that reduces congestion, promotes public transit, and encourages walking and cycling. The streets of Napa's downtown would be bustling with people on foot, enjoying the vibrant shops, restaurants, and cultural attractions. A robust public transportation system, with frequent bus routes, bike lanes, and pedestrian-friendly spaces, would ensure that residents can easily access everything the city has to offer, reducing traffic and fostering a healthier, more sustainable way of life. A Diverse and Resilient Economy While Napa will always be known for its world-class wine and tourism industry, the city would have successfully diversified its economy to offer a wider range of career opportunities. By attracting new industries, such as clean energy, technology, and healthcare, Napa would have created a well-rounded economic base. Small businesses would thrive alongside large enterprises, and the city's commitment to supporting entrepreneurs would have helped foster a dynamic startup ecosystem. It can be confusing for Citizens to navigate a municipality that sometimes is confused amongst its own departments. The pending "traffic plan" that was conducted before COVID, but is still being relied upon to somewhat restructure parking in Napa (specifically the downtown area) seems to be a bit short sighted given that COVID changed the global landscape for the retail industry (something vital to this City).

4. Please describe what you believe are major concerns of the City of Napa residents and businesses. What could we do better to meet these concerns?

Better advocacy and protection of our youth. Napa is a tourist town. There is very little for locals, especially kids, to do in Napa for fun. Drug use is pervasive amongst our youth, more than I think the City leaders are willing to admit. We need to develop more City programs that support and provide healthy and fun environments for our youth. More transparency in how voter approved initiatives are managed. While I realize many initiatives are on the County level (such as the various education bonds), there seems to be virtually zero communication once an election cycle ends as to what has happened or is happening with voter approved initiatives. As a Civically conscience voter, I often feel lost after the election cycle ends. Being a part of Napa County, I believe the City could collaborate with County representatives to provide more accountability and feedback on what is happening after the election cycles end. Actively seek more community input on everything. Employ someone who can provide outreach and gather Citizen input in a way that Citizens understand things, not in the way a politician speaks.

I look at Cities like New Orleans that have a culture of art and inclusivity that draw hundreds upon thousands of tourists every day without there being one specific reason for their visit. If we continue to hang everything on wine, we are destined to lose any hint of the other great things that Napa residents offer this City.

When I was in the South Napa Shelter I help create some changes in their rules about racism, unfairness and uplifting the spirit of my fellow homeless individuals wanting better for themselves while being an example for them by volunteering in the shelter kitchen, cleaning it, helping others, going back to school, staying healthy by working out daily and following the rules of the shelter. I am very interested in becoming a member in the City Council because I know I can do an awesome job setting great examples of what a changed person look like. I want to assist in continuation of making Napa a better place to live and visit by help our fellow Napa communities learn about their rights and responsibilities as a native and citizens of Napa. I want to add to the strong support that the City Council continue giving to the Napa's Mayor and providing assistance to the homeless community as well as making sure they're housed. I have an extinctive background in working with the financially challenged communities all over the Bay Area in all walks of lives; ethnicity, culture and background because of my passion for helping others see their values and the values in the place where they call home also a place they can always come back to. I am a diverse person who believe in fairness for all who have worked for it; I have been an organizer for over 20 years and will continue to be an organizer. I want to bring my award winning experiences; in skills in showing people how change is good, my abilities in providing tangible support to fix the problems vs bringing band aids to get rid of the symptoms that are temporary to lead us to real solutions. my experience in organizing, working with others, help create better environments to uplift the people living there, and to be a role model for those who are looking to change their lives for the better. I am currently attending Napa Valley College for their highly sawt after two year Culinary Program since March of 2024, during my first semester, I was so happy that I can contribute to my community in Napa to provide healthier choices for myself and neighbors. In January, 2023 I became homeless with no one to turn to for help and I went to the South Napa shelter where I was able to get a bed within a week and I was so grateful because I didn't know where I would of ended up. However; I used that opportunity to get the real help that I needed which was mental health issues, severe PTSD and physical health to get myself back to being a healthy individual to help make a healthier environment for future generations. I stayed in the shelter until March of 2024: I moved to my own place at the Heritage House (district 1) and I have been living there since with my puppy, two kitties, a fish, a flog and some plants to help me stay healthy and active.

2. What strengths would you bring to the City Council?

My many strengths are; 1. being able to get people to get involved in making changes and improving their environment. 2. I am a great leader that can lead people to recognize their own strengths and how best to use them. 3. I am tenacious, resilient, a people person, a superb communicator, etch... I will also bring a sense of peace and safety to the rest of my colleagues in any place I am. I am a great organizer who get results, I set realistic goals and get to the finish line, I work hard to see my plans to the end, I follow the rules and make sure that I get things done that I put my name on. I fight for what's right and for those with no voice and who are afraid to speak, I will be the one 1 fan of the City Council Members by encouraging them to keep going when things look hopeless. I can connect with everyone and everything, I connect with my school mates, the elderly, children, parents, animals and the list goes on.

3. Name three things the City of Napa is doing well and three things the City of Napa could do better.

Here are three things I believe City of Napa is doing right; the way city of napa take care of their homeless community as I was one of these fortunate souls who was given grace to in the homeless community. Climate Action & Sustainability, Traffic Safety, Housing & Homelessness, General Plan Implementation and Public Infrastructure - reflect both the City's immediate challenges and long-term vision for the future. Here are some more detail accomplishments; 1. Received full funding California Air Resources Board (CARB) for a Planning Grant award of \$439,796 to support implementation of the City of Napa Electric Vehicle and ebike Charging Plan. City staff will work closely with our sub-applicants, the Napa County Resource Conservation District and the Napa County Bike Coalition on this grant. Work on the Regional Climate Action & Adaptation Plan (RCAAP) is continuing and is expected to be completed in 2025. The RCAAP will be roadmap for reducing greenhouse gas (GHG) emissions in the City and in all jurisdictions within the County. Awarded technical assistance for fleet electrification planning through the Local Public Fleet Electrification Planning Program from Metropolitan Transportation Commission. Exploring the potential impacts of a food ware ordinance to reduce single use plastic food ware, improve waste management, and support the transition to more reusable and sustainable alternatives. Supported local business efforts to address climate change by distributing over \$26,000 in American Rescue Plan Act (ARPA) funding to 27 landscaping businesses in the City of Napa to upgrade to electric leaf blowers. Hosted two California Climate Action Corp Fellows who served from February through mid-September. The Fellows focused on furthering the City's climate action goals through outreach and education. The Fellows hosted numerous educational events, workshops and volunteer events during their term. Completed a comprehensive inventory of Napa's public trees as part of the Urban Forestry Management Plan. The City's 21.5% tree cover generates benefits including: 2.1 million gallons of stormwater runoff avoided, 11 tons of air pollutants removed, and 378.3 tons of cardon directly sequestered. Completed \$2.6 million in upgraded organics processing equipment at the City's Materials Diversion Facility leveraging a \$1.5 million grant from the State of California. The improvements allow the City to fulfill the requirements of SB 1383 (Mandatory Organics Recovery) and maintain the facility's status as of one of the best compost facilities in the nation.

4. Please describe what you believe are major concerns of the City of Napa residents and businesses. What could we do better to meet these concerns?

One major issue is the homelessness which mostly contribute to drugs, alcohol and mental illness that causes lack of mental compacity on how to handle life as what deem normal. Many homeless individuals got there duo to losing control of their livelihood or as they knew it and mostly have giving up on themselves therefore, they aren't sure of how to get it back. I know that the goal is to housed the homeless and provide the care that we think they will need to stay housed but the problem and the solution isn't that quiet cut and dry or black and white. We have to look at what some of the homeless people as they are; where some may be drugs and alcohol addicts, financially challenged and/or mental illness. All of that of which can cause homelessness and being incapable to care for themselves but with the proper support, resources and services they can get it done, not saying that the services and resources are in place now isn't working however; if we truly desire better results then we should survey the recipients of these services on how best to support them. For example, instead of getting drugs and alcohol abusers, mental illness/PTSD sufferers and financially challenged individuals in the same building with communicating that with them is not the way to deal with this situation because most of them don't have the capability to handle that form of betrayal or outsider's control of their lives will not stay housed and may bring the some things they are used to out in the street to their home which will lead to them losing their space and back to being homeless. Now if we communicate to them what it is we can or willing to provide to them and they get to chose while we also provide classes to help them to prepare themselves for their new life. There should also be classes in how to take care of their finances, personal hygiene, cooking healthy meals, Echt... so that they can have a successful transition and they wouldn't want to leave or do things to lose their homes back to being homeless.

5. Explain your current and past community involvement and/or service on City, nonprofit, or public boards, committees, task forces, or commissions, and how this has contributed to the City of Napa community. Address its relevance to the position of City of Napa Councilmember.

My current community involvement is helping my neighbors with food, clothes and access to personal products. Continue to be a model neighbor by continuing with school although it can get discouraging, cook for some community events, help transport some of my neighbors to and from shopping, food bank and other places and study. I worked as a caregiver and a trainer for newly hired caregivers for a company I though was an awesome employer until I got hurt while training. I was off worked due to my injuries and after year and half I was declared permanent and stationary which mean I had to be retrained for a different type of job during which time I used to volunteer at the Christian Help Center as a teacher, a cook and other services as needed the would be a perfect match for me to do and learn some new skills to add to my many experiences and skill as a community supporter. My prior community involvements has been on my stay at the South Napa shelter I volunteered at the shelter with whatever was needed to be done; serving in the kitchen, cleaning the kitchens, dining room, bathrooms, the dorm areas, the lobby and supporting my neighbor with whatever they need and I could and willing to do that wouldn't be an encroachment with my beliefs. Before that I was an activist, a community leader and an organizer to help improve my communities. I started a nonprofit (Destiny Organic Center Inc.) to educate financially challenged individuals from all different type of communities in the Bay Area, teach them the difference between conventional food and organic food, how to cook their food without losing their nutrients and how to more and better quality food for their household. I'd provided a bag of groceries consists of vegetables, fruits and grains and have them save that money to buy healthier meat, fish and poultry free of hormones, antibodies, and chemicals that changes them into a weapon that damages the body. I have won many awards for it starting with The Most Entrepreneur of the Year (2010) by eBay and CEO Women, The Palms Awards by the Dolores Street Community Services for the LGBTQ+, Hispanic and Latino communities. I received one from former speaker of the house Nancy Polesi, Senator Mark Leono, Leelan Yee, the San Francisco Supervisors and many other awards from different organizations and communities I have worked with. I have worked with the Asian community, the Native American community, the African Advocacy Network with revamping their organization to include other groups such as Caribbean and other African organizations in the Bay Area because many of them had the same goals and was fighting for small amount of funding when working together as a team will create a bigger impact for bigger and more funding to help those communities. 

Seventeen years ago, I moved to Napa to further my career in the wine industry, a journey that has given me the opportunity to work with some of the most distinguished names in the field, including Francis Ford Coppola and Jean Charles Boisset. Over the years, I have cultivated a deep understanding of the unique character of Napa as both a world-renowned luxury tourist destination and a cherished hometown community. Napa holds a special place in my heart, not only as the center of my professional life but as the community my family and I proudly call home. My wife, a Napa native, and I have both been small business owners in this town. Through our entrepreneurial endeavors, I've gained firsthand insight into the challenges and opportunities local businesses face, and I've developed a profound appreciation for the interconnectedness of Napa's residents, economy, and culture. As someone with over two decades of experience in wine and tourism marketing and strategic business development, I bring a unique perspective to the City Council. My career has been defined by finding innovative solutions to complex challenges, crafting compelling narratives, and fostering meaningful connections—skills that I believe are highly transferable to the work of a councilmember. These efforts aim to cut emissions by 20% over five years and have enhanced waste management practices. Adoption of the Napa 2040 General Plan: In October 2022, the City Council unanimously adopted a comprehensive plan addressing land use, housing, transportation, and climate change. Promotion of Arts and Culture: Napa hosts numerous cultural events, such as the annual Napa Valley Wine Auction, Festival Napa Valley, and the Napa Valley Film Festival. These events celebrate the region's heritage and contribute to its vibrant cultural scene. Three opportunities for improvement: Cultural Preservation: Celebrating and preserving Napa's unique heritage while embracing forward-thinking approaches to growth and development. For example, I would work to promote adaptive reuse of historic buildings, ensuring their integrity is maintained while repurposing them to meet modern needs such as affordable housing or community spaces. This approach balances heritage preservation with sustainable growth, ensuring Napa's character remains intact as the city evolves. Economic Vitality and Sustainability: Supporting local businesses by fostering an environment where they can thrive while exploring innovative solutions to promote long-term sustainability. For instance, I would advocate for the creation of a publicprivate partnership to establish a business incubator program, focused on helping small businesses and entrepreneurs develop strategies to succeed in Napa's competitive market while prioritizing sustainable practices. Residents are increasingly worried about issues like water conservation, waste management, and the environmental footprint of tourism. Napa's unique ecological landscape is integral to its identity, and addressing these concerns is critical to preserving the area for future generations.

While I have not always had the time for traditional volunteer roles, I have always answered the call when Napa needed me.

1. Please explain why you are interested in being appointed to the City Council and what you, as a councilmember, would offer to the Council and the community.

The current City Council has done a great job in being transparent in their leadership while growing the dialogue with the community. This has created a level of trust in leadership across the board that has not always existed. It is my belief that without the sense of belief and trust in our leaders that Measure G would not have passed. This leadership of trust and service also flows to three City of Napa Departments I am super impressed with and offer in the doing well category: The City of Napa Economic Development Division lead by Neal Harrison is doing a great job in really digging into how to diversify the revenues and business in the City beyond traditional tourism. Their work in supporting Napa Makes and exploration and development in the area of placemaking is very exciting, it is continued work in this area that will ensure growth and success even as we see some of our more traditional businesses and international tourism hit some bumps in the road. Homes and Homelessness Services under the leadership of Molly Rattigan and Stephanie Gaul has been innovative in finding solutions to a complex problem with an unbelievable care for those they serve. This is also a great example of City Staff's collaboration with County of Napa and their leadership in this area to get problems solved and people housed. Parks and Rec under the leadership of Katrina Gregory has done a phenomenal job of creating programs that serve our entire community. The creation of The Napa Lighted Arts Festival which has not only served as a must do for locals but has also cemented itself as an example of the power of cultural tourism is an accomplishment that we should all applaud. The sensitivity and care that went into creating the Napa Dia de los Muertos as a community celebration that is culturally appropriate is equally impressive. Three areas I think can be improved are: Though Economic Development has started the work the City as a whole needs to fast track and support other drivers of economic success beyond food and wine tourism. The seeds are planted to really super charge cultural and wellness driven businesses here and now the city needs to connect the dots so that if we do see a down turn in the wine industry we are insulated in other areas. The City of Napa needs to find creative ways to make the community affordable and livable for young families and our working class. This means not only creative housing solutions but holding NVUSD accountable for providing an educational system that serves our families. It means creating more child care and supporting our youth serving organizations to offer more for our families. it also means digging into emplyment development and increased wages. In this time of deep cracks in the political beliefs across the board I believe the only place where progress can start in bridging these large cracks is at the city and county level. I believe that as a city we have more in common then we have in differences and we need to rebuild and acceptable dialogue at this level if we hope to move forward. Lastly, and most difficult is we have to bury the "old" Napa. I feel politically we constantly fight a memory of a City of Napa that may have never truly existed and has become a fairy tail that we are judging ourselves by. We need to find away to accept that those times are gone and if we want to have a say in a right future we need to move beyond that conversation.

4. Please describe what you believe are major concerns of the City of Napa residents and businesses. What could we do better to meet these concerns?

Cost of living, workforce shortages, political climate, fentanyl, climate change, NVUSD shortcomings, wine business decline, federal immigration status fear are a short list of major concerns that I have heard from the residents in Napa. I think not only City of Napa Leaders but all community leaders can do a better job of stepping out of our own points of view and talking with as many people who think differently from us as possible. Elected's used to be able to have productive conversation both with each other and constituents who thought differently than them and now it has devolved to mud slinging and name calling. I believe the only place currently where we can begin to change that dynamic is at the local level. We live in a very special place and making it better is what can unite us all. These issues are so complicate and nuanced that it is not about doing better it is more about being diligent in seeking solutions to the problems in order to make the constituents who are hurt by these problems have better. The hard work is driven through relationships both with County as well as with the boots on the ground nonprofits, trade organizations, and other government agencies.

It will be a pleasure to provide input and review of projects and staffing needs as a City Council member.


7. Twenty years from now what would the City of Napa look like with the vision you have for Napa?

1. Please explain why you are interested in being appointed to the City Council and what you, as a councilmember, would offer to the Council and the community.

I want to join the City Council from a personal perspective because I want to give back to a community that has given me so much, and from a professional perspective because I believe the City of Napa needs to make it easier for members of the community to participate in our community. From a personal perspective, I bought my first home and had my kids in Napa. I have been so grateful to live in District 1, taking advantage of the great amenities and meeting wonderful people. I would love to expand my horizons and get to know more about how we can improve our city. From a professional perspective, I believe we need to make civic engagement easier to happen in our community: - Improve our website so it is easier to follow; - Simplify our ability to request changes to community issues such as parks and roads; - Encourage more public engagement on many topics of citizen concern; and - Improve the family friendliness of our community. I run a program at the Aspen Institute training subject matter experts how to get involved in policy (https://aspenpolicyacademy.org/). I have also first-hand experienced the frustrations of trying to make simple changes in our community, like getting a sign at a dangerous corner in my District neighborhood. (My request has been passed to three different agencies and then died without a response.) I'd love to bring these skills to help us improve the way we all engage with each to other.

2. What strengths would you bring to the City Council?

I am admittedly a nontraditional applicant. I am a relatively recent member of the Napa community and, since I relocated here during the pandemic and had two children in the past 4 years, I have had very limited opportunities to get involved so far. The main strengths that I bring are: - Deep professional experience helping people figure out how to get involved in government. I worked for more than a decade in public policy, and for the past six years have run a civic engagement training program. - Legal expertise, having worked as a criminal defense attorney and as a policy and legal advisor at the Department of Homeland Security. In the latter role, I worked with FEMA on building a resilience program, and I have also worked with our program fellows to support fire safety. - Networks inside and outside Napa, including through Napa Moms and the broader Bay Area communities in which I work. - Nontraditional background. I am a young mom and recent transplant to Napa, which will bring a different perspective than most council members.

3. Name three things the City of Napa is doing well and three things the City of Napa could do better.

1) Business development: the City's downtown is vibrant and beautification is going well. The January art installations, Christmas parade, and drove shows all help keep us engaged! 2) Safety: With the exception of drunk driving, the city does not have the same issues with safety as others in the Bay Area 3) Public Servants: the people who work for the city are really committed to it and very responsive. 1) Making it easier for ordinary citizens to give feedback. See explanation above. 2) Encouraging family friendly open space alongside development. The City recently sold Dwight Murray Plaza, one of the only open spaces in downtown, for less than the cost of my modest North Napa home, with designs that will remove all of the open space. The city also opened Main St to traffic, eliminating another space. 3) Improving parks. Our local Monarch Park has no paved pathway to get strollers to the playground, nor any seating areas for families. While I know there are bigger changes afoot for bigger parks, there should be easier ways to request simpler changes in the interim. I'd also add one area of uncertainty, which is fire resilience. Since I moved to Napa we have had no significant fire activity in the city, but I remain deeply concerned (as a former Department of Homeland Security official) that we may just be getting lucky. I'd like to learn more before passing judgment on the city's work in this area.

4. Please describe what you believe are major concerns of the City of Napa residents and businesses. What could we do better to meet these concerns?

I think ordinary citizens, frankly, do not know how to engage with the City Council, and thus struggle to know how to voice their concerns. The population of Napa has changed significantly in the pandemic (myself included) but I think participation still is mainly limited to established groups in the area. This makes it hard to evaluate what concerns the population actually has. Issues I have heard voiced, in addition to the ones I cited above: - Managing worldwide decreasing wine consumption and its effects on Napa businesses; - Fire safety and preparedness, as well as evacuation management; - Decreasing school enrollment and the effects on school closures; - Limiting the use of devices in schools for young children; and - School safety, in light of increasing gun violence

5. Explain your current and past community involvement and/or service on City, nonprofit, or public boards, committees, task forces, or commissions, and how this has contributed to the City of Napa community. Address its relevance to the position of City of Napa Councilmember.

Bluntly, I am a young, COVID-cautious mom who has only returned to participating in society in the past 6 months, after our daughter finally got her COVID shots. So I have had limited opportunities to participate since moving to Napa in September 2020. Before even moving to Napa, I regularly participated as a volunteer at the Ride for ALS that occurs on Justin-Siena's campus. I also managed traffic flow for an 8,000 person bike ride in my home town of Buffalo, NY. As a professional, I run a training program helping folks who have never been involved in public policy get involved. We run free training programs teaching people skills such as how to write a public comment and how to deliver a government briefing. I believe that if we create better systems within government to help people engage more easily, AND train them so that they can effectively engage, we can have better community involvement. If I am unsuccessful in this application, I'd be interested in working with the City to develop these ideas in some separate capacity (for instance a new task force on citizen engagement).

6. What do you wish to accomplish during the appointed term as a City of Napa Councilmember?

Personally, I want to learn. I want to better understand our government structures and challenges, so that I can better help improve our community from inside out. Substantively, I want to make progress on the issues above: - I want to create mechanisms for more citizens to participate and voice their thoughts on the issues the city is considering. For instance, I have a strong relationship with the leaders of a key project at New America and Harvard on cogovernance (https://cityleadership.harvard.edu/resources/collection/city-leader-guide-civic-engagement/); I would love Napa to be a leader in piloting some of this work. - I want to make progress on family friendly development, ensuring that as Dwight Murray Plaza and Napa Yard go away that there are new open-space opportunities for children to play with their families. - I want us to continue to make progress on fire resilience so that every fall is not a panic. - And I want our existing resources like parks and recreation facilities to continue to improve.

7. Twenty years from now what would the City of Napa look like with the vision you have for Napa?

Napa would continue to be the vibrant place that it is today, and our downtown would remain very active. Major changes would include: - More open space in the downtown area so families have somewhere to go within walking distance of restaurants. - More family friendly restaurants and bars, limiting the number of 21+ only spaces in downtown - More accessible parks with up to date equipment. - Schools that are serving a variety of student needs, including bilingual education. - Fire safety being so strong that we don't even need to think about it. - World-leading civic engagement that makes it easy for citizens to report issues in the community, in both Spanish and English, and internal mechanisms to help the city prioritize its needs. Let's make sure the squeaky wheel doesn't always get the grease.

I am passionate about building a Napa that honors our rich history, while preparing for the opportunities and challenges of the next 20 years. 2. What strengths would you bring to the City Council?

I would bring a broad range of strengths to the City Council, including strong communication, problem-solving, and adaptability. However, I believe my collaborative leadership, commitment to equity, and focus on community engagement are where I can make the greatest impact in driving meaningful progress for our city. Through my corporate and volunteer experience, I've learned that collaboration yields the best results. 3. Name three things the City of Napa is doing well and three things the City of Napa could do better.

The three things the City of Napa is doing well is having trust set in with the community, the Economic Development Division's efforts, and the liveliness of Downtown Napa. I want to congratulate the City for the passing of Measure G, even with strong opposition. This is a clear testament to the trust that Napa residents have in their city government. It demonstrates a shared belief in the City's leadership and commitment to investing in our communities' future. Secondly, the City's Economic Development Division's Core Programs are working to strengthen the City's traditional business sectors and also help diversify the city's economy. Thirdly, the vibrancy of Downtown Napa, as the hub of the city, is a place of pride for locals and a draw for tourists. I enjoy spending time in Downtown, as well as seeing tourists and taking my out-of-town guests to experience Napa in a safe and pedestrian-friendly environment. The main things that the City of Napa could do better is tell their story more, diversify its local economy and improve its housing supply. Napa has made remarkable strides in improving its public infrastructure between paving, sidewalk and pothole repairs, and many other Public Works projects. These all enhance the quality of life of residents, visitors, and support local businesses. While this work is in full effect, the community may not be fully aware of the scope or why they are being prioritized in a certain way. I believe that by additional effective communication of Napa's successes, the City can help its residents feel more connected. Napa has a great story to tell. Also, on controversial issues, there is always a side who feels that they lost, whether it's because a project they were opposed to was approved, or the passing of Measure G. It's important to keep those parties engaged as well. I think my strong communications background can help the City do this. One thing I would love to hear is a podcast that features city staff talking about hot topics in a more casual way, than perhaps a City Council meeting. How does "Napa CityTalks" sound to you for a podcast (title can be a work in progress)? I recently attended the Napa Chamber of Commerce's Economic Outlook Conference, and I was astonished to see the actual dependency the local economy has on the wine and tourism sectors. I am optimistic that with the great work of the Economic Development team, we can attract new businesses to look at Napa as a location for their operations. Napa is not immune to needing more housing, including affordable housing. It's reassuring that the City was able to meet its share of the Bay Area's Regional Housing Needs Allocation (RHNA), per the 2023-2031 Housing Element of the General Plan it adopted. I know that if this continues to be a priority, the City of Napa will keep tackling its limited housing supply.

4. Please describe what you believe are major concerns of the City of Napa residents and businesses. What could we do better to meet these concerns?

Traffic safety and homelessness are the major concerns of the City of Napa residents and businesses. I am glad to see that the number of individuals experiencing homelessness in Napa dropped by 18% between the point-in-time counts of 2024 and 2023; however, it is still a major concern. The City needs to continue working with Napa County and non-profits to get people housed or give them the proper services they need. Traffic safety is also a major concern with people I talk to, and for my family as well. My family and I like to walk a lot, and I constantly see cars that are driving at levels beyond speed limit or taking red lights. It's reassuring to know that the Neighborhood Traffic Calming Program has been developed. Also, I know that Napa Police does social media outreach, but I would like to know if the people seeing the message are the ones who are causing these concerns, and make sure we are talking to the right audience.

5. Explain your current and past community involvement and/or service on City, nonprofit, or public boards, committees, task forces, or commissions, and how this has contributed to the City of Napa community. Address its relevance to the position of City of Napa Councilmember.

I am currently the Board President of Providence Community Health Foundation Napa Valley (PCHFNV), formerly Collabria Care. We provide end-of-life services, such as Hospice and Palliative Care, to community members and grief support to surviving loved ones. By supporting aging residents to remain in their homes for as long as possible, PCHFNV helps prevent unnecessary hospitalizations and nursing home placements, allowing seniors to age at home with dignity and remain connected to their community. This organization also helps reduce health disparities and ensures that all members of the community, regardless of their income, have access to quality care. Through my involvement, I have gained valuable experience and knowledge to a vulnerable population, community health and senior services, and nonprofit governance. I am also a Board Member Advisor with the Napa County Hispanic Chamber of Commerce organization that I have been serving on since 2018. As a Board Member, I have a deeper understanding of the needs Napa's Hispanic business and community that can I directly convey as a Napa City Councilmember. I have also been on the Boards for di Rosa Center for Contemporary Art and the Friends of Napa County Animal Shelter. I am also a member of Sunrise Rotary and a graduate of Leadership Napa Valley.
