RESOLUTION R2008 80

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NAPA, STATE OF CALIFORNIA, AUTHORIZING THE PURCHASE OF INSURANCE AND THE SETTLEMENT OF CLAIMS, UPDATING RESERVE FUNDING LEVEL STANDARDS, INCREASING APPROPRIATIONS AND RESCINDING RESOLUTION NUMBERS 96 018 AND R1999 166

WHEREAS, the City of Napa has been self-insured for Workers' Compensation since July 1, 1983, and self-insured for liability since July 1, 1985; and

WHEREAS, as a result of a review of the risk management program and evolving changes in the Workers' Compensation and liability claims administration and funding requirements, it is desirable to rescind Resolution Nos. 96 018 and R1999 166; and update risk management program authorities and guidelines, and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by city staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Napa, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this resolution are true and correct, and establish the factual basis for the City Council's adoption of this resolution.
- 2. The City Manager is hereby authorized to purchase and renew insurance coverage on behalf of the City in conformance with the City of Napa Schedule of Insurance Coverage set forth on Exhibit A, attached hereto and incorporated herein by reference, subject to the limitations set forth herein. For the property insurance coverage, the insured structures are identified on Exhibit B, attached hereto and incorporated herein by reference. The City Council hereby authorizes the City Manager to acquire insurance on behalf of each separately identified "entity covered," as identified on Exhibit A; provided that the authority to acquire insurance on behalf of the Housing Authority of the City of Napa (HACN) is conditioned upon HACN's authorization of the City to acquire insurance on its behalf. The Finance Director will establish a cost allocation plan so that each separately identified "entity covered" compensates the City for the proportionate share of the costs of insurance coverage, and this cost allocation plan shall be documented in the respective budgets of the City and each entity covered. The City Manager shall have the authority subject to the following:
 - a) All insurance policy purchases and renewals shall adjust to statutory limits and be within the City's fiscal year budget and within available appropriations.

- b) The City Manager shall adjust the list of structures covered by property insurance as new facilities are added or deleted from inventory (Exhibit "B").
- Property policy limits may increase year over year based on insurable value of listed structures.
- 3. The Risk Reserve funding goal for the self-insured Workers' Compensation and liability programs shall each be set at the actuarially determined "Target Level" of 80% confidence level appropriately discounted for investment income, with actuarial evaluations being performed no less than every two years.
 - 4. The City Manager, or designee, is hereby authorized to:
 - 4.1. Settle any claim made against the City (whether based on liability or workers' compensation), provided that: (a) the settlement is documented in a writing approved as to form by the City Attorney, (b) the settlement is covered by sufficient unencumbered funds appropriated in the adopted budget and endorsed by the City Auditor, and (c) the amount of the settlement is less than or equal to the City Manager's Settlement Authority of \$50,000.
 - 4.2. Settle any claim the City may have against any third party, provided that: (i) the settlement is documented in a writing approved as to form by the City Attorney, and (ii) the estimated value of the claim (as determined by the City Manager) is less than or equal to the City Manager's Settlement Authority of \$50,000
 - 4.3. Reject any pre-litigation claim filed against the City.
- 5. The City Manager is hereby authorized to establish and maintain written administrative regulations which implement the authority set forth in this resolution. The administrative regulations shall be subject to review and approval as to form by the City Attorney, and a copy of the administrative regulations shall be maintained on file in the Office of the City Clerk. The City Manager may delegate, in writing, the authority set forth in this resolution to other qualified City employees.
- 6. The City Council hereby approves increases to the following 2008/09 appropriations:

Revenue from HACN (21-4601-002) \$ 3,700 Expenditure for Premiums (21-5531-2-001-55) \$11,535

- 7. Resolution Numbers 96 018 and R1999 166 are hereby rescinded.
- 8. This Resolution shall take effect immediately upon its adoption.
