### Amendment Application to City of Napa PL16-0124

This Amendment is submitted per the original application PL16-0124 and as extended per PL22-0102. The original application was approved for a use and design review permit that authorized the construction of a 74-room hotel included in two four-story hotel buildings totaling 184,106 square feet in size on two lots bisected by the Wine Train railroad at the southeast corner of the intersection of First Street and Soscol Avenue and bounded by First Street, Soscol Avenue, the Napa River, and the Water Street right-of-way (the "Site"), APNs 003-235-003, -004, -005, -006, 003-241-003, -006 (the "Project").

To make this project economically feasible and attract a national franchise firm, more rooms are required. This has been achieved by reconfiguring the internal space and removing the third-party retail space. The square footage of the project, the footprint of the buildings, the number of stories and the height remain the same. See Table 1 below.

With the additional room, the annual revenue to the City of Napa is increased. See Table 2 below for the comparison of the projected revenues from the original application with 74 rooms and this amended application that includes 123 rooms.
