RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NAPA, STATE OF CALIFORNIA, AUTHORIZING THE POLICE CHIEF TO EXECUTE AN AGREEMENT WITH AXON ENTERPRISES, INC., IN THE AMOUNT OF \$1,594,238.43, FOR A FIVE-YEAR TERM TO PURCHASE BODY WORN CAMERAS, A DIGITAL EVIDENCE MANAGEMENT SYSTEM, AND TASER ELECTRONIC CONTROL DEVICES AND RESCINDING RESOLUTION R2023-115

WHEREAS, on October 17, 2023, the City Council authorized an agreement with Axon Enterprises, Inc. to purchase body worn cameras (BWC), digital evidence management, and Taser energy weapons for a five-year term; and

WHEREAS, the Master Services and Purchasing Agreement was inadvertently excluded from the documentation provided to the City Council for consideration of Resolution R2023-115; and

WHEREAS, the Police Chief has determined that body worn cameras are a necessary component of contemporary law enforcement to ensure interactions with the public are captured, maintained, and distributed in accordance with state law and department policy, and promote accountability and transparency while supporting the police department mission to safeguard the public's welfare, safety, civil rights, and civil liberties; and

WHEREAS, the Napa Police Department has identified Axon Enterprises, Inc., as the preferred vendor, which includes services provided through Evidence.com, and Axon and Evidence.com are industry leaders that have demonstrated the ability to meet the needs of the department; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Napa, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.
- 2. The City Council hereby authorizes the Police Chief to execute an

agreement with Axon Enterprises, Inc., in the amount of \$1,594,238.43, to purchase body worn cameras, a digital evidence management system, and Taser energy weapons.
