Cindy Watter - provided comments in regard to the Grand Jury Report on gangs in Napa County.

Yolanda Ayala - provided comments regarding the Grand Jury Report on gangs in Napa. Noted significant number in youth gang activity in the years following the closure of the educational program the Legacy Youth Project, and provided comments regarding the Legacy Youth Project.

Carlos Hagedorn - provided comments regarding the Legacy Youth Project and submitted supplemental informational packet to members of Council.

Homeless Services Report and Review of Encampment Management Policy

Deputy City Manager Molly Rattigan provided the report. She also shared that Compliance Programs Manager Tony Valadez was in attendance and available to answer questions.

Following the report Mayor Sedgley called for public comment.

Concerned Neighbor - provided comments regarding the draft policy. Shared various concerns over the conditions near her home from homeless encampments. Would like to see the plan include verbiage that clearly addresses vehicles on streets.

Margaret - shared concerns with people living in cars and in RV's in her neighborhood. Asked if City could look at providing a designated area for those who lived in vehicles that also provided access to facilities and services nearby.

Matt Zax - provided comments regarding homeless services. Suggested City Council and staff watch a video as seen on Bloomberg Business Channel regarding Z Modular. In particular, on www.z-modular.com's YouTube channel there is a video titled "Z Modular Fully Integrated Real Estate Development" which suggests a cheaper way to build permanent housing.

Mark Gardner - applauded idea of compassionate approach to what is a serious problem. Shared his own concerns regarding camping in his neighborhood. Posed various questions regarding the draft policy.

Lisa Poppen - expressed support of updating the policy.

Scott Wagner, Director of Housing and Services at Abode Services - thanked staff and Council for their efforts in addressing homelessness. Shared concerns with high cost of living in Napa and lack of housing inventory.

Jim McNamara - shared various concerns, questioned why the City doesn't seek more assistance from the state legislature.

Deputy City Manager responded to questions posed during public comment.

Discussion was turned over to Council. Individual comments and questions ensued.
