Authorized the Public Works Director to execute on behalf of the City agreements with three engineering consulting firms: (1) Willdan Engineering; (2) Coastland Civil Engineering, Inc.; and (3) CSW/Stuber-Stroeh Engineering Group, Inc., for on-call private development review and engineering plan check consulting

services, each in an amount not to exceed \$300,000.







Dear Mayor Sedgley and City Councilmembers Alessio, Luros, Painter and Narvaez,

We are writing to you on behalf of Napa Climate NOW!, an organization of concerned citizens in Napa County, to urge you to adopt a Climate Emergency Resolution.

Such a resolution will put the city of Napa in good company with more than 2,000 cities and counties in the Bay Area, California, and around the world who now recognize that the pace of climate change is accelerating, posing a major threat to our homes, lives, and livelihoods. For instance, the City of Calistoga's Climate Emergency Resolution, passed in August, calls for "immediate climate emergency action at all levels of government" and commits to joining "a growing list of communities committed to a goal of net zero climate pollution, measured in terms of net contribution to excess trapped heat, by or before 2030."

As you are aware, last summer, the Intergovernmental Panel on Climate Change declared in its Sixth Assessment Report that it is "unequivocal" that humans have caused climate change, and reaffirmed that we are rapidly approaching the point of no return as global temperatures continue to rise and the earth's natural systems which buffer the planet against further warming break down. UN Secretary-General António Guterres referred to the report as a "code red for humanity." This is a true emergency that impacts every jurisdiction, large and small, at every level of operations – housing, air quality, health care, infrastructure, social and environmental justice, open space, industry, and of course, operating revenues.

There is nothing comfortable about confronting this challenge, and it will take courageous action to reverse course. This means making a meaningful commitment to doing no more harm, and to achieving net zero climate pollution by 2030. Climate change should now be one of the filters through which all policy decisions going forward are considered. It is, in short, a true emergency.

Our kids get it. Their entire lives are being shaped by it. Indeed, as the increasing wildfires, intensifying storms, deepening droughts, and unparalleled die-offs of ocean and land species are signaling, all of our lives are being shaped by it, even as we wake up, go to work, and go about each day as if things were normal. The problem with exponential change is that it is difficult to see day-to-day, but it means that yesterday is no longer a good indicator of what's coming tomorrow.

There is particular power in declaring this as an "emergency." All of the other jurisdictions that have wrestled with this language and its implications have come to the same conclusion. The city of Calistoga is a case in point, providing for specific goals and actions within its resolution. By taking the lead on this important issue, the City Council of Napa will further empower the business community and its citizens to take the necessary steps forward.

In conclusion, we strongly endorse the Schools for Climate Action in its request for Napa to pass a Climate Emergency Resolution. NVUSD has already done so, and the science supporting urgent action with a goal of net zero climate pollution by 2030 is clearly on their side. Please take this step to reassure our next generation that Napa respects their right to inherit a livable world. We stand ready to assist you in any way we can to implement such a resolution in a way that benefits the residents of Napa.
