#### **SPECIAL MEETING - 3:30 PM**

**A Special Meeting for the City Council of the City of Napa was called on Thursday, January 9, 2025 at 3:30 p.m. to be held at City Hall Council Chambers, 955 School Street, Napa, California, for the purpose identified on this Agenda. This Special Meeting was called in accordance with California Government Code Section 54956.**

Mayor Sedgley outlined the interview process.

Applicants were given five minutes to provide a presentation. City Clerk Carranza randomly drew names to determine the order of the presentations, which were given in the following order:

City Clerk called the names of Chris Lundstom and Jose Llamas. Neither applicant was in attendance and therefore would not be considered.

Mayor Sedgley thanked all applicants. Mayor and Councilmembers voted on the applicants that would ask to move forward in the interview process.

The City Clerk delivered to new appointed Councilmember Christopher DeNatale his Oath of Office, which would be filed with the City Clerk.
