Dear Members of the Planning Commission

As a resident of the South East Vintage neighborhood, **ISTRONGLY OPPOSE** the plans of the Napa County Board of Supervisors, Napa City Council and the Gasser Foundation's plans to convert the abandoned Sunrise Assisted Living facility at the end of Valle Verde to become a residence for persons at high-risk of long term or intermittent homelessness as defined by the *No Place Like Home Program*. The basis for my opposition is that if approved, this project is inconsistent with current "uses" and would negative impact the quality of life for the those who live and/or work in the area.

As you know this facility is intended to provide a permanent housing solution for adults or older adults with a "Serious Mental Disorder "or "Seriously Emotionally Disturbed Children or Adolescents" who meet one or more of the criteria below.

- Persons exiting institutionalized settings, such as jail or prison, hospitals, institutes of mental disease, nursing facilities, or long-term residential substance use disorder treatment, who were Homeless prior to admission to the institutional setting;
- Transition-Age Youth experiencing homelessness or with significant barriers to housing stability, including, but not limited to, one or more evictions or episodes of homelessness, and a history of foster care or involvement with the juvenile justice system; and others as set forth below;
- 3. Persons, including Transition-Age Youth, who prior to entering into one of the facilities or types of institutional care listed herein had a history of being Homeless: a state hospital, hospital behavioral health unit, hospital emergency room, institute for mental disease, psychiatric health facility, mental health rehabilitation center, skilled nursing facility, developmental center, residential treatment program, residential care facility, community crisis center, board and care facility, prison, parole, jail or juvenile detention facility, or foster care.

While supportive services such as mental health care, crisis counseling, individual and/or group therapy are a required to be provided by the No Place Like Home Grant Program, THERE IS NO REQUIREMENT THAT THESE SERVICES BE PROVIDED ONSITE OR FOR RESIDENTS TO PARTICIPATE. NOR CAN ACCESS TO OR CONTINUED OCCUPANCE BE CONDITIONED ON A RESIDENT'S SOBRIETY.

Besides our concerns regarding confrontations with individuals suffering from chronic or acute psychiatric issues while they are outside the confines of the facility and the supervision of the 'staff'. We are also concerned about incidents of public intoxication, public drug use, and discarded drug paraphernalia litter (needles/syringes) and increases in petty crimes in nearby neighborhoods.

Because of the aforementioned our elderly and children who will no longer be able to access and/or benefit from the use of the many walking paths and open spaces unique to our neighborhood. Review of Napa City Police Department crime statistics in the area around the South Napa Homeless Shelter demonstrate that these concerns are not unfounded.

Additionally, the mix of 24 affordable housing units for extra low-income families mixed in with 66 assisted living units for residents with serious mental health and substance abuse issues is a recipe for disaster. It seems unfair and unsafe to subject families with children to be required to live alongside persons who will not be required to participate in mental health and/or sobriety programs. We are also concerned about the negative impacts this intensified use will have on the Salvador Creek ecosystem

The neighborhoods that comprise the South East Vintage area do not have suffer from the problems associated with persons who are chronically homeless. By warehousing these people at this location will negatively affect our quality of life and believe that this location could be put to a better use such as homeless seniors or young adults graduating from the foster care program. The Heritage House project as sponsored by the County, City and the Gasser Foundation will create problems in our area that currently do not exist.







Subject: Climate Action Proposal

Brief Summary of the Primary Reasons for our Climate Crisis......

- i) Misbehavior and political mismanagement by elites.
- A catastrophe has occurred: global population has increased to 7.5
 billion with the resulting depletion of resources, notably water.
- iii) There has been insufficient response to these circumstances. Change is rarely in the interest of the ruling group.
- Social and economic dysfunction has ensued. The control of our fossil fuel resource by elites has resulted in a very conservative approach to mitigation of global temperature rise. Government response to this phenomenon is shocking and inadequate.

There is no time for further planning or discussion. The danger is clear and present. The crisis has become a public safety issue and here are the steps to take now......

 Declare a climate emergency. This has more than just rhetorical value. It will do two things; first, pave the way for future necessary measures to ensure public safety, and second, this will enable the city to redirect effort and money otherwise expended on non-essential and low return activities. As of today, 722 American cities, towns and other jurisdictions have declared us to be in a climate emergency.

- ii) Immediately divest from fossil fuels all city pension and other funds.
 Require police and fire unions to do the same. This will help reduce the influence of fossil fuel money in our public and political institutions.
- iii) Replace all fuel vehicles in the city fleet with electric cars, ASAP. Police,Building, HHS, Public Works, Parks and Rec., the whole fleet.
- iv) Purchase and start to plant 5,000 (five thousand) Redwood trees to help re-grow our urban canopy and sequester CO2. Encourage Napa citizens to plant trees in their yards by supplying a five gallon Redwood tree to anyone who will plant it and grow it. This should be a high priority.
- v) Government action is required to assure that we don't lose control of our climate system, and we are not getting any. We are now leaving the Holocene Period. All of the climate characteristics which fostered our civilization and its' achievements are rapidly changing due to human activity. Please take action now as outlined in this proposal. It will prove to be the best kind of start.
