Dear Napa City Clerk,

I have read in the Register that the planned budget cuts from the Pandemic effects are to cut 70 positions and 20 million dollars.

1. What specific cuts to service will be implemented, such as closing the Senior Center, access to parks, summer camps, road paving projects, Sidewalk program, call wait time average increases and longer police/fire response times, hours of service at City Hall, construction inspections, fire safety building inspections?

2. How did Finance estimate a \$20 million shortfall, using what formula for lost revenue? The cut is 12.5% of total FY 2020-21 budget per
