Dear Mayor & City Council members:


I am writing in my concern regarding the proposed cutbacks and dissolution of the Parks & Rec department.

As a native Napan, I am very concerned about the news articles regarding our Napa Park and Recreation Department and the cutbacks that they could be experiencing.

I grew up working for our Park and Rec Department. I began working as a swim instructor for 3 summers at Ridgeview Jr. High in the mid 1960's - moved on to being a Summer Playground Leader for 3 summers. I was hired to run the Tiny Tots program for many summers after I received my Elementary teaching credential. I was fortunate to keep working for Park and Rec for years teaching the Crafts for Me and Mom or Dad classes to bring art into children's lives without the mess at home. Overall, I worked as a part-time employee for about 40 years of my life. I currently volunteer for your Park committee -evaluating the local parks in Napa.

Napa needs to have a visible and viable park and Rec program! My late mother, Juanita Gonsalves, worked for Glenn DuBose, director of Napa Recreation Office in the 60's. My late father, Al Gonsalves and my late husband, Mike Jack volunteered their time and energy as Directors of the Park and Rec committee. They fought to make Napa's program one that worked for the community. Over the years, the program has grown and needs to be able to continue serving all community residents.

Back in the 60's residents were given the opportunity to have children learn to swim free of charge. Instructors were paid \$1.25 per hour to teach swim lessons and lifeguard during the afternoon free swim. The School District, the City, and the county had their tri-powered agreement to use facilities. I realize commitments change and people move on. Our Napa residents now pay for everything that's involved with Park and Rec.

Please consider what effect losing our Park and Rec Department will have on 79,000 people in Napa. Children need activities to keep them motivated. The City brochure is full of wonderful activities for all walks of life. Our life in Napa is something that many people seem and want for their families. It's a great place to live while growing up. The Park and Recreation Department help make Napa a very appealing place to live.

Please think about what living in Napa means to you and your family and how this department has helped you. Thank you for your time as Mayor and Council Members. Make the decision that keeps Napa a special place to live, work, and play!
