I read about the budget cuts and was shocked to hear Parks and Rec could possibly lose half of their staff. I feel a need to express my concern as a local who depends on Napa Parks and Rec for so much. And I'm only referring to their parks-not all the recreation (including the Senior Center) or their activities that have helped downtown thrive BC. (Before Covid).

We all know how important public parks are to the health and well being of locals and visitors, both mentally and physically. What some may **not** know is how devastating a filthy and littered park is to its locals. Many don't think about the impression left on tourists' mind while visiting Napa local parks.

I worked for the Napa County Open Space District for the last 13 years, and during that time I worked and volunteered with the City Parks and Rec folks at Westwood Hills with weed management and trail maintenance. This has allowed me to witness just how dedicated and hard working these Park and Rec employees are-despite being understaffed.

As outreach coordinator with the Open Space District, I fielded many calls, texts and emails from both locals and tourists complimenting on the cleanliness of our parks. I was also made aware of downed trees, trail erosion, homeless encampments and garbage in parking lots. These calls need to be answered immediately. Without adequate staff, who will address these issues?

Just my 2 cents and my plea to please reconsider putting Parks and Rec on the chopping block. I think we **all** agree that this pandemic has demonstrated how important our parks and open spaces are for our community.
