I would first like to mention that the method by which you are requiring the public to comment: Via telephone before 1:00 PM on the day of the meeting or in less than 500 characters during the meeting with a very specific subject line, is unreasonable and potentially a violation of the Brown Act. In terms of the financial forecast, I hope that council has requested detailed financials. A powerpoint presentation is not going to provide the essential fiscal data to make an informed decision. Council members, at the very least you should require raw financial data to make such substantial and impactful decisions.
