Training that all police receive regarding how to communicate with all community members, suspects and people taken into custody;

Training that all police receive regarding how to de-escalate and communicate in a non-violent manner with all community members, suspects and people taken into custody;

Training that all police receive regarding use of force with community members, suspects and people taken into custody;

Policies and procedures related to crowd control, as well as training that all police receive regarding crowd control.

I also urge Council to make public all of the above, and hold a community town hall so we, as a community, can look at these, give our input, and talk about how to move forward.

I also urge Council to make public demographics related to arrests within the last 5 years, so we can see trends and patterns related to arrests in our community.

It's imperative that we create a new blueprint for moving forward.

I understand that Chief Plummer has been talking with some of the youth leaders in our community about policing and possible changes. That's great. Let's inform the entire community about what current policies, procedures and training so we all understand where we've been, and can support our youth leaders, be part of the dialog and part of the solution that ensures nonviolent interactions by police with community members.

Who amongst you Councilmembers will commit to bringing these policies out in the open in a Council meeting or Town Hall?

As a concerned citizen and business owner, I need to say that I am concerned about the future of downtown Napa; I have been in Napa during both rallies put on for Black Lives Matter, and understand that they are going to continue these protest/rallies each and every weekend thru June. What I would like you all to think about from a business perspective, is that Napa businesses, restaurants and wine tasting rooms have been closed, with no income coming into them for over 80 days, this is very hard on many of us, then we have to take into account that these protests are happening every weekend, which is the time that we have Napa citizens and tourists come downtown to shop and have dinner and go into tasting rooms, most of us have closed our businesses due to the concern of looting and rioting in addition to citizens being concerned for their safety.

I can further tell you that yesterday we saw some friends from Vacaville having dinner during the protest and they were sitting outside at the restaurant, the protestors stopped in front of the restaurant and stood there for about ten minutes with megaphone blaring and chanting, and this frightened our friend very much, we assured her this is not the normal for Napa. We also, have some neighbors who I had informed about the march and they were coming into town from Southern California to see how their house was coming that is being remodeled, and were staying at a hotel on First St, they arrived at six o'clock right when the sit in was happening down towards City Hall, she called me this morning and asked if they could come stay with us as she was scared all night long and did not want to be in downtown Napa. These protestors are taking the streets over, sitting down in the middle of the intersections, not staying on the sidewalks, they are disrupting the cars who can no longer utilize the streets, and are disrupting our citizens. Do they even have permits for this? And if so why are you allowing this?

I am concerned that if this continues and people are afraid to come to Napa, what with what we citizens and businesses have gone thru, that this will be the "nail in the coffin" for the majority of businesses downtown, and I know that this is not your wish, so please take into consideration the businesses and citizens who live here and pay taxes, also.

I have always been in favor of peaceful protests, but when they are threatening to loot our local businesses, as was the case yesterday, then I believe that it is up to the city government to step in and say you have had your time we need to move on and get this town back and alive again.

Dear Jill Techel, all of Napa City Council, & all of Napa Police Department:

We know America is in the midst of uncertainty right now. Dealing with an unprecedented pandemic with limited resources has been taxing and, to be frank, scary. Thankfully this city has not been overwhen ned with cases.

More importantly, the Black Lives Matter movement is retaliating against injustice by protesting yet again, despite the fear of a deadly virus. That is how angering it is to continue seeing innocent people being murdered by the ones who are supposed to protect and serve our communities. It is a shame that it took so many tragedies to get here, and your people are outraged. Yes, the people of Napa are outraged. George Floyd and Breonna Taylor were not from Napa, but Napa has welcomed and allowed racism to thrive in its streets for too long, and it was racism that killed those two and countless other innocent Black lives. We did not forget that Oscar Grant's murderer, Johannes Mehserle, was raised in Napa. We cannot allow another tragedy at the hands of a Napa-raised police officer be the reason we start paying attention and making the necessary changes to prevent it from ever happening again.

First and foremost, our goal is for this message to be clear: Napa's Residents want justice for George Floyd and for his murderer to be charged with first degree murder.

To create a positive change in our own community, we want Napa's Police Officers to go through a mandatory anti-racism program, in addition to a lecture about Napa's history of racism and the KKK's involvement in our city. We all learned in school why we must learn from our past to avoid making the same mistakes now. Here are our clear requests:

- Napa County issues a statement standing in solidarity with George Floyd, Breonna Taylor, Oscar Grant, and every unarmed innocent Black man, woman and child who has died at the hands of racist police officers.
- Napa Police Department issues an accessible list of actions they are taking to avoid police brutality and eliminate racism in our own communities, not just toward Black people but towards Latinos and other marginalized people as well.
- An immediate implementation of an anti-racism program Napa Police Officers must go through; such as teaching them and emphasizing how to de-escalate situations without unnecessary force and aggression, holding their peers accountable when they're unjustly targeting a Black person or person of color, and teaching exactly why this program needs to be implemented. To be short; how to not be racist.

Please understand that we, Napa residents, will remain having a peaceful, though probably inconvenient protest as long as we are treated with the same level of respect and peace, until there is an agreement in place with Napa on the right side of history. I am confident these requests will be easy to fulfill as long as the city of Napa is working against racism. Change is long overdue and it is time Napa joins the fight.

Estimada Jill Techel, el Ayuntamiento de Napa, y el Departamento de Policía de Napa:

Sabemos que los Estados Unidos se encuentra en tiempos de incertidumbre en este momento. Hacer frente a una pandemia sin precedentes con recursos limitados ha sido agotador y, para ser sincero, aterrador. Afortunadamente, esta ciudad no ha sido abrumada con casos de COVID-19.

Más importante aún, el movimiento Black Lives Matter está tomando represalias contra la injusticia al protestar una vez más, a pesar del temor a un virus mortal. Es molesto tener que seguir viendo a personas inocentes asesinadas por quienes se supone que protegen y sirven a nuestras comunidades. Es una vergüenza que haya sucedido tantas tragedias para llegar aquí, y su gente está indignada. Sí, la gente de Napa está indignada. George Floyd y Breonna Taylor no son de Napa, pero Napa ha dado la bienvenida y ha permitido que el racismo prospere en nuestras calles por demasiado tiempo, y fue el racismo el que mató a esas dos e innumerables vidas inocentes.

No hemos olvidado que el asesino de Oscar Grant, Johannes Mehserle, fue criado en Napa. No podemos permitir que otra tragedia a manos de un oficial de policía criado en Napa sea la razón por la que comenzamos a prestar atención y hacer los cambios necesarios para evitar que vuelva a suceder.

En primer lugar, nuestro objetivo es que este mensaje sea claro: los residentes de Napa quieren justicia para George Floyd y para que su asesino sea acusado propiamente ante el peso de la ley.

Para crear un cambio positivo en nuestra comunidad, queremos que los oficiales de policía de Napa pasen por un programa obligatorio contra el racismo, y atender una conferencia sobre la historia de racismo de Napa y la participación del Ku Klux Klan en nuestra ciudad. Todos aprendimos en la escuela por qué debemos aprender de nuestro pasado para evitar cometer los mismos errores ahora. Aquí están nuestras solicitudes:

- 1. El condado de Napa emite una declaración solidaria con George Floyd, Breonna Taylor, Oscar Grant y todos los hombres, mujeres y niños de piel negra inocentes desarmados que han muerto a manos de policías racistas.
- 2. El Departamento de Policía de Napa emite una lista accesible de acciones que están tomando para evitar la brutalidad policial y eliminar el racismo en nuestras propias comunidades, no solo hacia la gente con piel negra sino también hacia los latinos y otras personas marginadas.
- 3. Una implementación inmediata de un programa contra el racismo debe pasar por los oficiales de policía de Napa; como enseñarles y enfatizar cómo reducir las situaciones sin fuerza y agresión innecesaria, y asegurar que sus compañeros tomen responsabilidad de sus acciones abusivas contra una persona negra o de color, y enseñar exactamente por qué este programa debe implementarse. Ser breve; Cómo trabajar sin llevar acabo el racismo.

Por favor, comprenda que nosotros, los residentes de Napa, seguiremos teniendo una protesta pacífica, aunque probablemente inconveniente, siempre y cuando seamos tratados con el mismo nivel de respeto y paz, hasta que haya un acuerdo con Napa en el lado derecho de la historia. Estoy seguro de que estas solicitudes serán fáciles de cumplir siempre que la ciudad de Napa esté trabajando contra el racismo. El cambio está muy lejos y ya es hora de que Napa se una a la lucha.

We are concerned that the same communities that are most vulnerable to the health impacts of the COVID-19 virus are doubly at risk of being evicted from their homes due to their inability to pay rent. A crises of this scale requires a community response and we urge the City to take swift action to provide immediate relief for low-income tenants.

At St. Joseph Health, we believe health is a human right and that safe, secure housing is essential to health and well-being. The record number of unemployment claims and businesses in crisis have placed financial pressures on both renters and landlords alike. While Americans of all backgrounds are feeling the economic pain, renters represent some of Napa's most vulnerable communities, including low-income families, disabled individuals, seniors, and a substantially disproportionate portion of the County's Latinx households.

These communities also represent over a quarter of Napa's workforce, many of whom are employed by sectors hardest hit by COVID-19 (restaurants, hospitality, retail, entertainment, transportation & warehousing). At least 73% of workers in the hardest-hit sectors earn less than \$3,333 per month. At full time, this is equivalent to \$39,996 per year, compared to the median household income of \$84,753 per year. In Napa, 5,223 of 16,614 renters are considered severely cost burdened and spend 50 percent or more of their household income on housing.

We are now three months into this crisis and there is no indication at this time that the state will enact protection measures to prevent evictions. On May 29, Governor Newsom issued an extension of local authority to enact protections regarding evictions. However, until a local provision is issued, landlords in Napa will still be able to serve eviction notices, even if a tenant has notified them of their inability to pay rent due to COVID-19 related issues. Therefore, we are calling on the City of Napa to enact the following local policies:

- COVID-related nonpayment of rent cannot be a cause for eviction.
- 12 months to pay back rent related to COVID-19.
- Terminate late fees as a cause for evictions.
- Assume COVID-19 as a reason for non-payment of rent.
- Allow tenants with emergency-related causes to break their leases.



Community Outreach

St. Joseph Health believes that in these trying times, short-term solutions such as these will provide immediate relief and support to low-income residents. Queen of the Valley is committed to finding ways to ensure this crisis does not further exacerbate our housing challenges. Several Bay Area Cities and Counties have enacted moratoriums covering residential tenants unable to pay because of COVID-19 financial hardships and we encourage you to do the same. We appreciate your attention to this request on behalf of the poor and vulnerable in our community.

I am writing today to express my support for the Black Lives Matter and Defund the Police movements. As a 33 year old white woman, I believe that racism will not end until white people like me start acting like racism is an issue they need to help SOLVE rather than something they need to just *empathize* with. Black people in communities all across the world and here in Napa are *screaming* for help. Will you choose to help them?

Have you heard of the *8 Can't Wait* campaign? It is my understanding that Napa only has 2 of the 8 policies that have been shown to reduce killings by police: warning before shooting and duty to intervene.

I urge you to do everything in your power to enact the following 6 policies here in Napa:

- 1) Ban chokeholds and strangleholds
- 2) Require deescalation whenever possible
- 3) Exhaust all other options before resorting to shooting
- 4) Ban shooting at moving vehicles
- 5) Require use of the **force continuum**
- 6) Require comprehensive reporting

As far as Defunding the Police goes, it is clear to me that our current system is broken. Weekly, and for over a year, my nextdoor neighbor, with whom I shared a wall, would call 911 because she needed help coping with her alcohol withdrawls. She would go into withdrawal if she drank less than 1.75L of vodka a day! On average, 4 police officers and 4 firefighters would show up when she called 911, sometimes more(!) even though it only ever took 2 people to handle the situation. The rest of the men would end up standing around doing nothing while my neighbor drunkenly pleaded to go to rehab. Ridiculously, it took the better part of a year for there to finally be **space** for her in the County's rehab facility. This was incredibly frustrating to watch play out. I would be very happy if some of the police budget was reallocated to services that could have helped my neighbor the first time she asked for it. Instead, who-knows-how-much money was wasted on her countless calls to 911 and the excessive show of support from police and fire. She wanted help, but inexcusably, our local government was not set up to give it to her. I would like to see funds taken from the police and given to programs that focus on helping alcohol and drug abusers.

I urge you to do everything in your power to get Napa on the right side of history and show strong leadership for the rest of the Valley.

The Issue: Evictions and COVID-19

- Due to the economic impact of COVID-19, a surge in evictions following the pandemic would substantially de-stabilize the rental housing market in Napa and ultimately result in the displacement of many (primarily low-income) Napa households.
- With an eviction on their tenancy record, impacted residents would be significantly impeded from obtaining, or even being considered for, needed alternate housing following the emergency.
- Additional protections can "flatten the curve" of evictions Napa residents face as a result of the pandemic

Recommended Tenant Protections

- No Residential Evictions for Unpaid Rent Due to COVID-19
- No Late Fees for Unpaid Rent during COVID-19
- Up to 12 months to Repay Unpaid Rent
- Right to Break Lease due to COVID- related cause
- Tenant Education and Awareness

Why Napa Needs to Act

- <u>Keep Tenants Housed!</u>
 - Public safety
 - Viability of re-paying rent (more realistic when tenant is housed)
 - Homelessness due to COVID-19
- Urgency and desperation- many tenants are now 3 months behind on rent, with no clear guidance on how to address unpaid debt(s)

Hello Mary, Again thank you for the follow up. I thought I should share my response with your fellow Council members.

Craig Smith has informed me that the Downtown Merchants Association is in support of a street closure. As well, the Napa Chamber of Commerce seems to be willing to raise funds to cover the cost of the \$900 weekly cost of the street closure. Personally I am not sure why the private sector should cover any associated costs of a street closure.

\$900 to close a street is a strange cost associated with a weekly closure. I understand the economic structure of labor but perhaps I am not understanding a staffing structure at a government level. At \$100 an hour for a city worker, it will take them 9 hours to put up signs and place the bollard in infrastructure that already exists. If these costs are accurate this dictates that a seasonal closure would be far more cost effective.

If all of the restaurants on the 800 block of Main were to participate in seating on the sidewalk there is capacity for about 120 seats. It was clear with ZuZu and La Taberna over the weekend that people are leary of dining indoors and far prefer to dine outdoors. The taxed income of sidewalk dining should offset any costs to the city for closures.

My sincere frustration is based on the fact that ZuZu and La Taberna will only be able to run at half capacity, however none of our fixed costs have changed, the math does not work for viability on a restaurant's razor thin bottomline. The blunt of this regulated business closure and the reopening capacity falls on the operator, not the landlord nor the city of Napa. For us rent, taxes and insurance and all associated costs are due. Tramer of Gran Electrica made the SF Chronicle today, which is just a small window of the plight we are facing, this one just happens to be in your city. (https://www.sfgate.com/food/article/Bay-Area-restaurant-owner-closed-again-15341979.php)

I watch as other communities roll up their sleeves and get outdoor seating done in public spaces. I watched as my home town of Santa Barbara closed State Street for 8 blocks the week that they were able to reopen so that restaurants were able to get traction on opening and helping them to stay soulvent.

(https://www.edhat.com/news/downtown-state-street-closes-to-vehicles-for-outdoor-dining). We are 12 weeks into when we were forced to close our business and now it is still just talk-talk from the City of Napa on helping us merchants. It seems to me that

no one on the staff level of this city wants to get dirty, we can always find reasons not to do something such as this closure, but it takes real leaders to get these things done, if there is the will. I have reached out to the department heads and the city managers to discuss this issue, yet to hear back from any of them.

Over the weekend we had so much positive energy on this block with some outdoor seating, loads of pedestrians and the park full of people. The city of Napa has a chance to create a great spot for pedestrians with such a closure but seems to be dragging the discussion out in the typical bureaucratic BS.

I see you trying your best and I say this with my best intentions. Over the last few weeks I have witnessed a race to the narrative that Napa is somehow special, that we have found a way to peacefully protest and work with our police department. You have said something in your own way as best you can. However, in racing toward this narrative of "Napa protests are peaceful," you are building blockades to healing. I know this is not your intention.

Some of you are very vocal in your support of our police and military. I am not writing to shame, I do believe that those who support these institutions do so because you believe in them, but in your public support, as public leaders, you are ignoring hundreds of years of pain inflicted by these government institutions.

It is potentially a very sadistic way of thinking, to expect generations who have been so badly abused by our police and military to never fight back. Our historically marginalized are asking for equity, not revenge, but as leaders I call on you to validate their anger. We must face these discomforts, head on, before we can claim peaceful society.

Many more have joined the national conversation on race that so many of us have already been having for decades. Shelter in place has been an introspective time. George Floyd reminded me that the most racism I ever experienced was in 1970's and 80's Napa as a racially mixed child that everyone deemed their business to inquire. My birth father told me a story of playing with his white friends in the vineyards. The cop asked only him for his papers, not realizing my family are First Americans.

The national conversation dates back 400 years to the kidnapping of Africans, brought here for our economy. You must remember, our local conversations concern history that is much younger at just 170 years old. Napa was the oldest inhabited place in all of North America. The last "bloody run" of forced marches of our first people was in 1851, when military forces abused and marched them north. The reservations where the people were placed and whose relatives remain, like Napa's farmworker housing of today, are not places where any of you would feel comfortable living.

Napa is special to us all, Napa has unique issues, but Napa is no more special than any other city. Napa has pain. Napa is suffering from the monoculture that will eat us alive in the name of a product that is responsible for many deaths and a whole lot more violence. A monoculture that has bought our politicians. Napa has a long and ugly history of police and military abuse. Napa has a lot of work to do and I call on you to say so. We can do this, together, but we cannot race to the "all is well" narrative until we address, head on, the

inequities in our Valley. You cannot fast forward healing.





As you know, I'm a climate activist and I try to walk--and cycle--my talk as much as possible. The Slow Streets program is a win-win-win proposition: It makes active transportation safer. It reduces auto emissions, especially along the routes selected. And it costs practically nothing and can be rolled out tomorrow.

It doesn't require a study or report. Just put up some barricades as a pilot project. Let people know how to comment on it via the City's website and let's see what happens.

I think the proposed route near my house--Pickwick to Kent Street--is a perfect choice. It's a corridor on the way to two schools (Harvest to the north and Snow to the south) and contains 7 basketball hoops facing into the street--so residents are already recreating in the street. I spoke with a Pickwick St. homeowner when I was cycling the route. He said that he would love to have his street closed to through traffic and he told me that residents have complained for years about fast traffic due to parents dropping off students at Harvest. Wouldn't it be great if those students had a safer route to ride their bikes to school?

You as a Council have done an excellent job of listening to residents as you've dealt with the COVID situation and its financial fall-out. I hope you will listen again and find a way to bring Slow Streets to Napa.

Since retiring, I ride my bike almost every day. I hate riding in places that have poor or no bike lanes such as the two streets I mentioned above. Since the Covid-19 pandemic, I have seen a sharp increase in people bicycling and walking around the city of Napa. In light of the pandemic, it is quite evident that the city needs to address this increase in non-automobile traffic. By blocking off several streets within neighborhoods, we can provide people with "safe zones" for walking and bicycling to and from highly used places. These safe streets would encourage even more people to use these alternative modes of transportation. Therefore, the need to walk and ride without endangering each other from close contact would become even greater.

As an example, by blocking off Central and Yajome, people would be able to have a safe route all to and from Soscol Ave., via McPherson Elementary School and O'Brien Park. These are areas that serve numerous families, many with small children. Most of Central Ave., from Soscol to Yajome, has no sidewalk or bike lane, currently making it very dangerous to pedestrian and bike traffic. I have witnessed many cars traveling way above the 25-mile an hour speed limit. Dozens of my ex-students and their brother and sisters, many of whom are economically disadvantaged, live on or near these streets and need them to make their way safely to either Napa High, McPherson School, or the school bus stops where they get picked up to be driven to Silverado Middle School. By closing these two streets, many of my neighbors would be much safer, happier and healthier.

I also think the City of Napa should consider closing many more streets to car traffic in the heavily used restaurant area in downtown Napa. In closing off parts of Main St. and First St. for example, more people would be able to enjoy walking, riding, and eating outdoors in a much safer way. It certainly would be better for those businesses.

Lastly, by "slowing down" certain streets to through traffic, we will help to make our neighborhoods safer not only from cars, but by keeping the spread of the corona virus lower. We would also be helping our neighbors stay healthier by breathing better quality air while getting much needed exercise. And when the present crisis is over, Napa can be well on its way to combating another danger: the Climate Change Crisis.

I believe that implementing the program on East Avenue would be a huge benefit to the increasing number of adults who, in order to keep socially distance, often walk with one person in the street and one on the sidewalk (in the few places that have sidewalks), and to the many children who walk and bike to Alta Heights school. The other proposed slow streets would reap the same benefits.

June 16, 2020 Update:

Our thanks to Mayor Techel and Council for agreeing to hear more information about our Slow Streets proposal. Since our initial request one month ago, NCBC staff have been overwhelmed by the positive show of support for this concept. Our Change.org petition requesting adoption of Slow Streets has over 900 signatures, and we have received dozens of comments from local residents expressing why Slow Streets is so vitally important to ensure that their families can safely walk and bike in Napa. Many of those individuals have also reached out to you.

NCBC staff have also prioritized a series of phone interviews with other communities that recently implemented similar programs, to better understand the opportunities and challenges they faced. Details of those interviews are shared below, and support our initial assessment that adoption of Slow Streets can be done quickly, safely, and at very low cost.

We have also heard from Council and staff that while there is broad support for this program, that the unknown costs associated with City staff time and budget make this infeasible under the current economic crisis. Recognizing the unprecedented strain on City staff and budgets, NCBC welcomes the opportunity to work closely with City staff to address any concerns about the impacts of Slow Streets, and identify possible cost savings through the use of volunteers, online tools, and the existing capacity of our organization.

Response to Staff Report:

We have had a chance to review the Staff Report, and wish to respond to several assertions to both clarify the intent behind our original request, and to further inform staff and Council based on significant work NCBC has done to evaluate the potential for implementing Slow Streets in Napa.

Our May 15th memo identified eleven corridors which we felt would warrant consideration for Slow Streets treatment. This list was developed with the intention of starting a dialogue with City staff about Slow Streets, and is neither exhaustive nor limiting. We believe that a pilot program consisting of 3-4 corridors with the lowest ADT (Average Daily Traffic) and that avoid emergency routes would give our community a chance to experience Slow Streets, as well as limit the staff burden of evaluating a longer list of possible locations.

Staff asserted that "the timing for the temporary closures of streets...has passed," due to Napa County entering Phase 3, presumably because many locals are returning to work, and traffic volumes are increasing. Nevertheless, social distancing guidelines remain in place, many parks and trail systems continue to experience near-record levels of use, and the influx of tourists from outside the County only further support the need for neighborhood-level opportunities to get outside, be active, and limit unnecessary travel. With the recent end of the school year and severely limited opportunities for kids to participate in structured activities, safe places to be active have never been more important.

The primary objection raised by staff is one of severely limited staff time and financial resources, something we do not dispute. In an effort to minimize the burden on staff to implement Slow Streets, NCBC staff have been in touch with officials from numerous communities across California and beyond that have adopted Slow Streets or similar programs since the start of the pandemic.

Some of our learnings are outlined below, and we would be delighted to partner with the City to address any outstanding concerns, and assist in any way possible with addressing program implementation and ongoing management.

Learning From Other Communities:

NCBC contacted City staff from numerous communities, including Alameda, Redwood City, Foster City, Petaluma, and Bend (Oregon), as well as advocacy organizations that have worked with numerous other communities on implementation and ongoing maintenance of the program. Communities were selected due their rough approximation to the City of Napa in both population and density.

- Legal Authority Several cities cited Vehicle Code 21101(e), which allows local
 authorities to close a street under their jurisdiction, "temporarily...for celebrations,
 parades, local special events, and other purposes when...the closing is necessary for the
 safety and protection of persons who are to use that portion of the street during the
 temporary closing." Staff also identified existing COVID-related emergency declarations
 as supporting the need for and authority to enact soft closures of streets in the
 program.
- Staff Hours for Implementation City of Alameda staff (among others) expressed concerns about limited staff capacity, and started with a pilot program with 2 streets. Estimated 10-15 hours per week to launch program, plus some ongoing maintenance needs. Foster City program (closure of 2 lanes of 4-lane collector) required 8 hours of staff time and was implemented in 3-4 days. City of Petaluma staff indicated program took "less than 20 hours" to launch, including involvement from Public Works Director, Police & Fire, and City traffic engineers.
- Staff Hours for Ongoing Maintenance City of Alameda has recruited volunteers via local nonprofit to check on signs and barricades, reducing staff hours. City of Oakland has also begun working with volunteer groups. Ongoing hours largely dependent on number/length of streets in program.

- Maintaining Emergency Access & Transit Routes All communities notified first
 responders and transit partners, but because closures do not limit access by vehicles,
 there were no issues identified. City of Alameda staff addressed the question of
 whether police would be asked to enforce the closure; absent other calls for service,
 closures are not actively enforced. NCBC also spoke directly with NVTA Vine Transit
 staff, who did not express any concerns about Slow Streets programs.
- User Conflicts None of the communities surveyed identified any user conflicts, and several identified the program as reducing conflicts due to greater room for nonmotorized users. All use some mix of on-street signage, social media, and website to educate community members. Redwood City includes a webform and FAQ on a dedicated webpage here. Nearly all Slow Streets programs avoid commercial and retail zoned areas.
- Public Input on Corridor Selection Most communities surveyed adopted a pilot program of 2-4 streets, and evaluated community feedback prior to expanding, using that feedback to inform location of future Slow Streets. City of Oakland was the outlier, adopting 74 miles of current and planned neighborhood bikeways (Class III) for their program. NCBC was unable to identify any jurisdiction that went through a Committee/Commission process prior to program rollout.
- Community Feedback City of Petaluma expressed "huge support" and comments from
 many community members to adopt some version of program permanently. City of
 Alameda has received over 800 responses to an online survey, with "lots of positive
 feedback." Foster City identified that walkers "appreciate the feeling of safety." All
 agencies identified continued engagement with residents via online tools and social
 media as central elements of program success.

In summary, we believe that an 8-week Slow Streets Pilot Program of 3 to 4 streets can be implemented by the City of Napa with a total staff time investment of less than 30 hours, and less than 10 hours per week of ongoing staff time, divided across several departments. With the exception of printed signage, no new purchases would be required to implement the program, as Public Works already has an ample supply a-frame barricades, traffic cones, and other traffic control equipment. And based on our research, we believe a program could be implemented within 7-10 days.

Dear Councilmember Luros,

We are all facing unusual and difficult times and one simple, healthy way to clear the weight of our thoughts is to go outside for a walk. Sadly, many neighborhoods in the City of Napa don't even have sidewalks to walk on and are forced to walk in the street, or if they do have sidewalks, they are so narrow in order to keep a safe distance to comply with public health orders, they have no choice but to use the streets.

What the Napa County Bicycle Coalition is requesting is a soft closure of a small number of streets to allow more space for people to get outside and maintain a healthy distance from others without the fear of a speeding vehicle. Many cities across the nation and several in the Bay Area have stepped up to manage this situation by implementing slow streets in their cities.

While City staff is ultimately concerned over finances and focusing on staff shortages and managing their current workloads and projects, Slow Streets does not have to be expensive, nor would it require significant staff time. Under the lead of the Napa County Bicycle Coalition and local neighborhood volunteers and community organizations, soft street closures could be easily implemented under the guidance of the city. The coalition is not asking for full street closures as suggested in the staff report, but rather soft closures to still allow local residents, city services and public safety through.

While there are fewer cars on the roads today, speeds have become significantly higher do to less traffic. School campuses and parks are closed and many people who live in multi unit housing are not afforded the luxury of having their own yards to get outside in.

Please consider working with the Napa County Bicycle Coalition to implement Slow Streets in Napa.

Dear Napa City Council Members and staff,

My name is Linda Brown. I have lived in downtown Napa for 21 years with my husband, and it was here that we raised two daughters. I want to strongly raise my voice in support of the Slow Streets Program. Here are a few reasons why:

Having lived in San Francisco and the East Bay, where traffic can be unbearable, I was anxious to get out of my car when I moved to Napa. We purposely chose this neighborhood, a few blocks from downtown and Fuller Park, so that we could walk or bicycle to just about everything. Our kids regularly walked or biked to school, setting up healthy habits that will last them a lifetime.

One of the scariest days was the call we got that our daughter had been hit by a careless driver while riding her bike. Fortunately, it was a slow-motion accident, and the injuries were minor, but it was a wake-up call that we need to do more in this city to promote safe bicycling and walking.

Another factor impacting cyclists is the debris that gets tossed out of moving cars or dropped off the back of pick-up trucks. If you've ever bicycled in this city, you've seen for yourself how this debris, which includes everything from broken bottles to screws and bolts, collects on the sides of the road surface where we are supposed to ride, threatening to puncture tires or worse.

A third issue is the number of times I've seen speeding cars race through the neighborhood to avoid main thoroughfares. Stop signs help, but there's more we can do.

Finally, the pollution from our cars is everyone's responsibility. It not only diminishes our air quality and makes life miserable for asthmatics and others with respiratory difficulties, but it contributes directly to climate change. We have an urgent need to address these issues.

The Slow Streets Program is a simple, low-cost step toward sanity. The initial proposed scope will encourage safe walking and bicycling in neighborhoods throughout the city. My hope is that this scope will be expanded over time to encourage even greater active transportation access. I would also like to see the program extended into the downtown shopping district. Research demonstrates the connection between slow streets and increased retail foot traffic, which could be a boon to our economy in this tough time. And the large majority of residents in other cities who have adopted Slow Streets initiatives remain in strong support of these measures.

My name is Carlotta Sainato, and I am the Program Coordinator at the Napa County Bicycle Coalition. Thank you for considering our Slow Streets Napa proposal on this afternoon's agenda. I am greatly appreciative of the work you do to serve the City of Napa and its residents.

I am writing today in support of the Slow Streets proposal. Implementing this program would have numerous benefits for our community. In partially closing a selection of residential streets to through traffic, this program provides the necessary space for residents to maintain a safe social distance while recreating or commuting by bicycle or foot. It prioritizes residents' health and wellbeing by creating an active space that immediately serves them while greatly reducing the risk of traffic conflicts. This is especially impactful now that schools have been released for summer vacation and students are home with extremely limited summer activity opportunities. By encouraging the utilization of active transportation, this program may also contribute to greenhouse gas reduction by decreasing the number of vehicle trips taken.

Several communities, both in the Bay Area and nationwide, have successfully piloted and expanded similar programs, with the majority of responses being positive in many of those communities.
