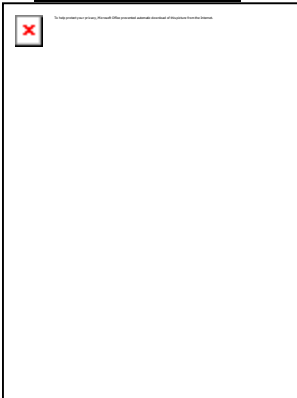

PROCLAMATION NO. P2020-002

PROCLAMATION OF THE DIRECTOR OF EMERGENCY SERVICES OF THE CITY OF NAPA, STATE OF CALIFORNIA, AUTHORIZING THE LIMITED WAIVER OF OUTDOOR DINING PERMIT FEES IN RESPONSE TO THE LOCAL EMERGENCY RELATED TO THE CORONAVIRUS PANDEMIC (COVID-19)

WHEREAS, on March 15, 2020, the City Manager (acting as the Director of Emergency Services) issued Proclamation No. P2020-001 to proclaim the existence of a “local emergency” based on the existence of conditions related to the novel coronavirus known as “SARSCoV-2,” named “coronavirus disease 2019” and abbreviated “COVID-19”; and

WHEREAS, Proclamation No. P2020-001 was issued based on the facts and law summarized therein, including the legal authority set forth in California Government Code Section 8630, and Napa Municipal Code Section 2.89.020; and

WHEREAS, the City Council has subsequently reviewed and ratified the actions taken by the City Manager related to the local emergency described in P2020-001 during multiple public meetings of the City Council, notably including March 16, 2020 (R2020-037), March 31, 2020 (R2020-039), April 21, 2020 (R2020-055), the most recent prior ratification on June 2, 2020, and the planned recommended ratification of this proclamation on June 16, 2020; and

WHEREAS, due to the severe impacts of COVID-19 on the health, safety, and welfare of the community, and the revenues of the City, as described in R2020-039 and R2020-055, the City Manager has determined that it is in the best interests of the City to facilitate the issuance of Outdoor Dining Permits to allow restaurants to open and operate on a larger outdoor footprint, which will allow the restaurants to comply with the social distancing protocols required by the State (through Executive Orders of the Governor) and required by Napa County (through orders and guidelines issued by the Napa County Health Officer); and

WHEREAS, the City Council has established the fee amount to be paid by an Applicant for an Outdoor Dining Permit, to cover the costs of City staff in reviewing each application, establishing appropriate site-specific conditions of approval, and issuing the permit, as set forth in the Master Schedule of Fees, Fines, and Charges (effective January 1, 2020), line 10.10, at \$620; and

WHEREAS, the City Manager has determined that the circumstances of the COVID-19 local emergency support the City's use of general fund revenue to subsidize the cost of allocating City staff resources to process each outdoor dining permit application, which will allow the City to waive the Outdoor Dining Permit fee of \$620 that would otherwise be owed by each Applicant, under the terms set forth in this Proclamation.

NOW, THEREFORE, BE IT PROCLAIMED by the City Manager of the City of Napa, in the capacity of the Director of Emergency Services of the City of Napa, as follows:


1. The City Manager hereby authorizes the Community Development Director to waive the Outdoor Dining Permit fee of \$620 (as described in the Recitals of this Resolution) for each complete application that is received by the Community Development Department between March 15, 2020, and September 30, 2020, in accordance with the application and permit requirements published by the City (see: <https://www.cityofnapa.org/937/New-Outdoor-Dining-Permit-Process>).

2. This proclamation shall expire if not confirmed and ratified by the City Council within 21 days of the proclamation.

3. The City Manager hereby finds that the facts set forth in the recitals to this proclamation are true and correct, and establish the factual basis for this proclamation.

4. This Proclamation shall take effect immediately upon its execution.

This proclamation is hereby issued by the City Manager, Director of Emergency Services.
