Dear Mayor Techel and Napa City Council Members,

On August 18, 2020, all of the members of the City Council and the Mayor voted to approve the agreement between Napa Valley Unified School District and City of Napa in sharing the costs of services for school resource officers for the 2020 thru 2021 school year.

From our understanding of Government code 81705, an elected official such as a City Council member should not only disclose about oneself if the official has an existing conflict of interest with voting on an item, but also should make a consideration with or without the government agency's legal counsel to disqualify oneself from voting on the item if the elected official has even a *potential* conflict of interest (source is League of California Cities: Providing Conflict of Interest Advice pages 32, 34, 35 and 41).

Some of us community members are aware that there is a city council member who holds a seat at this dais, has a family relationship with a school resource officer that had provided services at our local high schools this past year 2019, and on August 18, this same city council member went ahead and voted on this specific item. Even if it was found there is no legal basis of this city council member having had an existing conflict of interest, some of us nevertheless think that it would have been appropriate and ultimately fair for the City Council member to disclose about this to the public at the meeting BEFORE having made any action at the dais on an agreement which stated that the shared total cost is up to \$494,284 to have 3 school resource officers for this school year.

This comes at a time after earlier this year about 100 or so full time instructors were laid off and when the school district continued to lay off those such as those in food

services, in maintenance, with office positions etc. due to the school district's budget deficits. The public- the community of Napa County at large- deserves transparency especially from all our elected officials at all levels.

Dear Napa City Council,

I wanted to revisit an item from August 18th that I feel is still relevant at this time. On August 18th, the Napa City Council and Mayor approved an agreement between the City of Napa and Napa Valley Unified School District on sharing costs for School Resource Officers to be present at various upper/middle grade school sites for the 2020-2021 school year.

It is clear to me and many within the community that our schools do not need police. We are woefully understaffed in key positions such as nurses, counselors, psychologists, and academic specialists. Layoffs have been numerous recently amongst administration personnel, teachers, staff, and operations. This is the harsh reality. And all this as schools prepare to open later this month in the middle of a pandemic. I would like to state that again. In the middle of a pandemic!

Maintenance/custodial staff are spread thin and are tasked with cleaning and sanitizing to keep our school communities safe. I wonder if hundreds of thousands of dollars would have been better spent truly addressing the needs of our students? Meanwhile, I am struggling to find many members of the community that support having police in our schools. Numerous teachers think they are not needed. Parents and community members are increasingly surprised and opposed to having them when presented with the facts. Numerous scientific studies have pointed to serious issues with having School Resource Officers in schools:

-This paper linked shows the presence of police negatively impacts both graduation rates of students and a decrease in college enrollment.

-This national study found that "arrest rates of children increased substantially after schools received federal grants to hire police officers, starting in 1999."

Are the police bringing safety to the school or are they simply entering more students, most often needlessly, into the justice system? People do not realize how much potential and

needless harm is caused when school discipline escalates into arrestable offenses when officers are involved.

-This study shows “aggressive policing can thus lower educational performance for some minority groups. These findings provide evidence that the consequences of policing extend into key domains of social life, with implications for the educational trajectories of minority youth and social inequality more broadly.”

There are numerous more studies, all showing that low-income students and BIPOC students experience the highest rate of discipline and negative consequences.

Where was the community input aspect to your decision making? Where was the critical thinking, and was research based science used to help inform your decision?

Now, couple this with the fact that it recently came to light that one council member has a familial relationship with a School Resource Officer. It is disappointing and concerning to me that this was not disclosed to the public or a vote abstained. In any Democracy, transparency is so very important. We must do better.

Recommended Code Changes

- Broadens Napa Municipal Code's (NMC) purpose statement on smoking regulations to include the protection of public health, safety and welfare
- Introduce definitions that identify the wide variety of tobacco products covered by this section
- Identify 21 as the minimum age for purchase of tobacco products (California Penal Code Requirement)
- Updates other chapters of NMC to consolidate smoking regulations and clarify language

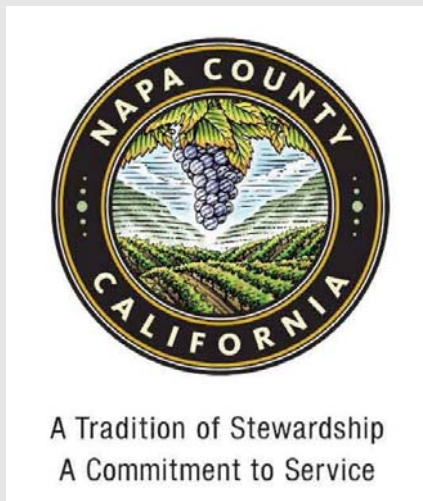


Recommended Code Changes, con't.

- Recent State Law Changes
 - SB 793 – Governor Newsom signed
 - Effective 1/1/21
 - Bans the sale of flavored tobacco products **with exceptions** for flavored pipe tobacco, premium flavored cigars and hookah products
- Recommendation to City Code mirror the state law changes

I am a Napa resident, a former vape user and a parent of young children and I strongly oppose flavor based regulations and bans of nicotine containing products such as vapes. My personal experience with quitting nicotine was simple and painless due to the variety of flavors and nicotine strengths offered in vapor products. I do feel that something should be done to reduce the problem of youth vaping but flavors are not the problem. As someone intimately familiar with the world of vaping I can say with absolute certainty that the best way to reduce underage abuse of nicotine is to regulate the amount of nicotine in vape products. Teens chase the nicotine rush that comes with high concentrations. People actually trying to quit do not need 6% nicotine, 3% is more reasonable but 2% concentration is where I would cap what is available in my community if I were to have any say. Highly restrictive regulations on vape flavors are only going to send people back to cigarettes. Please do not fall in to the hysteria of the current witch hunt and listen to people who have lived through nicotine addiction and come out the other side. 2% (20mg/ml) should be enough to get any smoker off cigarettes. **Regulate nicotine strength, not flavors.** Please, for the health of smokers and vapers everywhere.

RE: Proposed Flavored Tobacco Products Ban

Dear Mayor Techel, Vice-Mayor Gentry, and Councilmembers Alessio, Luros and Sedgley:

As the Executive Director of the National Association of Tobacco Outlets (NATO), a national retail trade association that represents more than 60,000 retail stores throughout the country including several Napa retail store members, I am writing to submit our comments and concerns regarding the proposed tobacco products flavor ban on your October 6, 2020 agenda. These changes would prohibit the sale of all flavored tobacco products, excluding only shisha, premium cigars, and loose-leaf pipe tobacco.

Federal and State Actions on Tobacco Make Proposed Ordinance Unnecessary: Congress and the State have responded to increased use of electronic cigarettes by underage persons. These actions are broad in scope and should be allowed to work to reduce tobacco product usage before an outright local ban on flavored tobacco products is considered and include:

- The FDA published a Guidance in February 2020 banning the sale of flavored electronic cigarettes with a removable cartridge or pod in response to increased use of such products by underage individuals.
- In 2016, California became the second state to raise the legal age to purchase tobacco products from 18 to 21. This law addressed access to and use of tobacco products by 18 to 20-year olds.
- The Legislature passed and the Governor signed SB793, which, effective January 1, 2021, prohibits the sale of all flavored tobacco products, excepting shisha, premium cigars and loose-leaf pipe tobacco, items that are not used by youth to any significant degree.
- The Vapor PACT bill moving through Congress would restrict online sales of electronic cigarettes to prevent underage individuals from obtaining these products over the Internet.
- Manufacturers were required to file Pre-Market Tobacco Applications with the FDA by September 9, 2020, or their products can no longer be sold, removing many products from retailers' shelves.

Pandemic Impact and Economic Crisis Will Be Magnified by a Flavored Tobacco Product Ban:

During the current Coronavirus emergency caused is not the time for the City to consider prohibiting the sale of legal products. Our convenience store members have experienced losses of 45% in gasoline sales and 20% or more in grocery, snack, beverage, and tobacco product sales, significant numbers because convenience stores usually rely on tobacco product sales, including the three products exempted by the State, for approximately 36% of in-store sales. These retailers have done everything possible to survive the pandemic, but this would require the removal of even more products than the State law requires.

The Ban Does Not Consider All the Facts: We ask that the City Council consider these facts:

- Based on the California Healthy Kids Survey of 11th Graders in the Napa Valley Unified School District, use of tobacco products are at historic lows and, in two categories, almost zero:
 - 93% had never smoked a cigarette and only 1% said they had smoked any cigarettes or smoked regularly in the past 30 days
 - 95% had never used smokeless tobacco, only 1% reported having used any smokeless tobacco in the previous 30 days and none reported using smokeless tobacco regularly
 - Cigar and pipe tobacco are not even surveyed, suggesting their usage is even less
- Napa retailers have a near perfect 99% compliance check passing rate in retail tobacco compliance checks conducted from 2012 to 2019 according to the Food and Drug Administration (see accompanying FDA retail compliance check report).

NATO and its Napa retail members share everyone's interest in keeping tobacco products out of the hands of persons under 21 years old, but the ordinance overreaches by banning virtually all flavored tobacco products when these products are almost entirely used by adults 21 and over.

We urge the Napa City Council not to move forward with any attempt to impose a ban on flavored tobacco products, and to certainly not even consider making any such changes under the existing state of emergency in which we find ourselves.

Dear Mayor and Members of the Napa City Council,

We are looking forward to the application of SB793 to Napa County. As the state government bans the sale of flavored tobacco products in California, we are pleased with Deputy City Manager Liz's work in bringing this ordinance to the council. In the upcoming months, we will see the positive effects of this ban towards youth. As we know, vaping has negatively impacted our community especially in the last few years - according to the Journal of the American Medical Association, "In the last 2 years, vaping has increased by 218% among middle schoolers and 135% among high schoolers."

Policies that restrict the sale of flavored tobacco have the potential to curb youth tobacco use in as few as six months. A study from Massachusetts Department of Public Health compared the impact on youth tobacco use between two towns with similar demographics, one that had a flavored tobacco ban and one that did not. Data was gathered before the policy was implemented and approximately six months after the ban. The results found that current use of both flavored and non-flavored tobacco decreased among teens in the community with the ban.

We are looking forward to this first step towards a healthier community. This is only the beginning. We can't wait to get back to work with you in the near future as we hope the results inspire implementing more restrictions.

We are members of Friday Night Live chapters here in Napa County and we want to share with you some information

- Disposable flavored e-cigarettes use among high school students increased 1,000% over last year.
- Flavored e-cigarettes are continuing to drive the youth vaping epidemic with more than eight in 10 young users (82.9%) reporting they use flavored e-cigarettes, according to the 2020 National Youth Tobacco Survey.
- People claimed they use vapes to quit smoking, but only 3% of adult smokers used JUUL to quit in the past year.
- Nicotine is poison for the adolescent brain. It changes the way connections form in the brain, which can interfere with kids' attention and learning. It can increase anxiety, mood swings, and irritability at a developmental time when life is hard enough.
- Youth and young adult vaping is associated with 5-7 times greater risk of testing positive for COVID-19
- 99 California jurisdictions have passed ordinances to ban flavors, this is 25% of the State of California, we are hoping the city of Napa finally can be added to this list

Thank you for including my comments in your meeting today. I want to introduce myself. I'm Gary Mehrok, owner of Cigarettes and More in Napa. As you consider a ban on flavored tobacco, I'd like for you to consider how this will impact retailers, their employees, and the community.

If the goal of this amendment is to stop kids from vaping, you are misguided. If you ban the sale of vape products in the city, adult users will go to another town, another county, or go online to purchase these legal products. Why are our small businesses being targeted instead of focusing on online sales? The ban would increase the criminal market, and the city council should not be taking actions that promote more crime in the community. If any action needs to be taken I think it has to be against the kids who doesn't follow the law. They have to be punished so they don't break the law again. We are suffering as it is due to Covid and other taxes. restrictions by the state and Fed.

Since the federal government increased the age limit to 21 for tobacco sales, many credible studies show that teens' and even adults' tobacco use is down. Those of us positioned at the cash register day in and day out work hard, taking time to check IDs and follow these new guidelines. I ask you to please give these updated regulations, along with education programs, an opportunity to work. Because from what we see at the retail level, and recent studies show, tobacco use is at historically low levels. We all want to protect our children from harm. My employees are parents too and all of us take the importance of our role at the point of sale seriously.

And during a time when the economy is struggling, and Covid has impacted everyone's revenues, why do you want to make a move that will lower tax revenue and kill jobs?

I appreciate all the work you do serving the community in this role. I also ask you not to pick on

Napa small businesses and employees with this governmental overreach. Banning sales of these adult products at convenience stores will not stop teens from trying to buy nicotine products online, from older friends and family members, or the black market. However, it will hurt local businesses and our employees, who are desperately trying to survive during this difficult time. Please look for other solutions.

We are asking the city council tonight to hold off from making a decision tonight on Agenda Item #11.A on behalf of your city's retailers. The council and staff have taken multiple private meetings with Tobacco Control and various anti-tobacco groups in the past few months to develop multiple times a draft flavor tobacco ban.

Many cities in California have invited retailers to a workshop (online or in person) to work with retailers on finding solutions together to prevent youth tobacco usage before drafting and voting on an ordinance with the input of the retailer community. The City of Napa has ignored its own business community and has met with only one group of stakeholders. This is not democratic!

We ask the council to direct staff to meet with the retail community at least once and to get their feedback on solutions to stopping youth vaping usage and hear about current retailer "best practices" that are working and supported by the State and FDA. Napa retailers have been 99% successfully compliant on youth sting operations in the past 7 years as reported by the FDA.

Please do not ignore your own Napa business community who have invested its livelihood to the community of Napa for decades. We have been protecting our community's youth and want to continue protecting our youth. Allow us to continue being part of the solution!

Dear Mayor Jill Techel and Members of the City Council:

I am writing to you today on behalf of the American Petroleum and Convenience Store Association (APCA) representing owners of 1,400 businesses who are providing jobs, essential services, and products to Californians. Each day, 165 million people visit their favorite neighborhood market resulting in sales that allow the average convenience store to collect \$1.28 million in property, payroll, and sales taxes for local, state, and federal governments every year. Here in Napa, our members are investing in the community and have recently delivered much-needed masks to coronavirus frontline workers and donate to nonprofits like Tri City Volunteer Food Pantry and Second Harvest Silicon Valley who are providing [healthy food](#) to Bay Area residents.

The sale of tobacco and e-cigarettes products is a critical part of our retailers' business model, driving the ancillary sales and if we lose the ability to sell tobacco and e-cigarettes products, our customers will go elsewhere. These significant income drops would lead to necessary staffing adjustments and closures of essential neighborhood markets. The ban would take away an entire category of products from our shelves that adults in this country have the right to buy and enjoy.

Banning legal products at licensed retail locations undermines the city's and the state's tobacco and e-cigarettes retail licensing program, which has successfully limited youth access to tobacco and e-cigarettes, protected consumers from altered products, and given local government the enforcement tools they need. Moreover, local bans on tobacco and e-cigarettes products create an illicit market and an enormous profit margin driving illegal sales in those locales.

The current COVID-19 crisis is unprecedented, but California has seen its fair share of catastrophes. Whether it was the Camp Fire in 2018 or the Valley fire in 2015, our stores have always been there. We continued to provide fuel, bottled water, and other essential items to those who needed it most. If cities like Napa continue to attack our ability to remain profitable, there will be a day when no one is left at neighborhood markets to provide much-needed supplies to meet critical needs.

Because California's SB 793 passed, it created a level playing field for all retailers statewide. The ordinance you are proposing is unnecessary, goes too far, and it will hurt hard-working, law-abiding business owners and employees in Napa who are on your side of this issue.

We appreciate your consideration of our comments on this issue and urge you to oppose any ordinance that would restrict our ability to sell flavored tobacco and e-cigarettes products and devices in our stores to adults over the age of 21. We are responsible retailers who provide jobs and essential goods.

APCA Provides Masks, Food and Funds to Frontline Workers

The organization donated over \$20,000 in collective funds and distributed 12,000 masks to frontline workers, nonprofit staff and volunteers across California in response to the COVID-19 pandemic.

Members of the American Petroleum and Convenience Store Association (APCA) delivered masks, food and donations to frontline workers, nonprofit staff and volunteers across California in response to the COVID-19 pandemic.

The industry group found that, besides health care workers, police officers and food bank staffers were in desperate need of gear to help prevent transmission of the virus.

“During our conversations with these organizations, we heard supplies of masks were extremely low or nonexistent. We recognized that we were in a unique position to identify alternative sources for some of these supplies, and we got to work,” said Jivtesh Gill, chairman, APCA. “Deemed ‘essential businesses’ by the Department of Homeland Security, our members’ 1,400 convenience stores and gas stations have remained open, and they’ve maintained access to suppliers. Despite catastrophically low fuel sales and an inside sales decline, our members displayed their resilience and desire for community wellbeing and were able to distribute much-needed supplies to meet critical needs.”



The organization distributed 12,000 masks to the Catholic Charities Family Support Center in Santa Rosa, Sonoma County Sheriff’s Office, Solano County Emergency Services, Sacramento Police Department, Tri-City Food Pantry and Thrift Store in Fremont, Second Harvest Silicon Valley, and the Modesto Police Department.

Additionally, members of the association collected funds to donate \$12,500 to the Central California Food Bank in Fresno, \$5,000 to the Sacramento Food Bank and Family Services, \$5,000 to Second Harvest Food Bank serving San Joaquin and Stanislaus counties, and \$1,000 to the Twin Lakes Food Bank in Folsom.

Every day, 165 million people visit their favorite neighborhood market. This activity results in sales that allow the average store to collect \$1.28 million in taxes for local, state and federal governments every year.

“The COVID-19 crisis is unparalleled, but just like during the Camp Fire in 2018 and the Valley Fire in 2015, APCA members and our employees remain committed to serving our customers and our communities,” said Gill.
