RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
NAPA, STATE OF CALIFORNIA, AUTHORIZING THE
APPOINTMENT OF JONNA INTOSCHI AS A RETIRED
ANNUITANT PART-TIME EMPLOYEE (ACCOUNTING
SUPERVISOR), TO BE EMPLOYED WITHIN 180 DAYS
OF THE EMPLOYEE'S RETIREMENT

WHEREAS, the City may not hire a retiree before 180 days has passed since his or her retirement date, unless the City Council makes the certifications to CalPERS in compliance with Government Code sections 7522.56 and 21224, as set forth in this resolution; and

WHEREAS, Jonna Intoschi, CalPERS ID 2129311769, is retired from Town of Corte Madera effective September 20, 2021; and

WHEREAS, section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is March 20, 2022; and

WHEREAS, section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement related incentive; and

WHEREAS, Jonna Intoschi has not and will not receive a Golden Handshake or any other retirement-related incentive; and

WHEREAS, the City Council hereby appoints Jonna Intoschi as an extra help retired annuitant to perform payroll related duties of Accounting Supervisor for the City of Napa under Government Code section 21224, effective January 4, 2022; and

WHEREAS, the entire Retired Annuitant Agreement (attached hereto as Exhibit "A" and incorporated herein by reference) between Jonna Intoschi and the City of Napa has been reviewed by the City Council; and

WHEREAS, no matters, issues, terms or conditions related to the City's appointment of Jonna Intoschi to the Retired Annuitant Agreement have been or will be placed on a consent calendar; and

WHEREAS, the employment shall be limited to 960 hours per fiscal year; and

WHEREAS, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate; and

WHEREAS, the maximum monthly base salary for this position is \$10,881 and the hourly equivalent is \$62.77 per hour, and the minimum monthly base salary for this position is \$9,007 and the hourly equivalent is \$51.96; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Napa, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct and establish the factual basis for the City Council's adoption of this Resolution.

2. The City Council hereby certifies that the nature of the City's appointment of Jonna Intoschi will be as set forth in the Retired Annuitant Agreement (attached hereto as Exhibit "A," and incorporated herein by reference), and that this appointment is necessary to fill the critically needed position of Accounting Supervisor by January 4, 2021 to complete critically needed payroll related functions and other duties as needed.

3. The City Council hereby certifies that Jonna Intoschi has specialized skills needed to perform these services, and the duties performed cannot be performed by current staff (as described in more detail in the public report to Council that accompanied this resolution).

4. The City Council hereby certifies that Jonna Intoschi has not received any "Golden Handshake," or any other retirement-related incentive, consistent with the requirements of Government Code Section 7522.56(g).

5. The City Council hereby approves the appointment and authorizes the City Manager to appoint Jonna Intoschi to provide services to the City of Napa as an Accounting Supervisor under the terms set forth in the Retired Annuitant Agreement (Agreement). Under the terms of the Agreement, the services shall be performed for the limited duration of January 4, 2022 through January 3, 2023; Jonna Intoschi shall be limited to working no more than 960 hours per fiscal year; the City shall pay Jonna Intoschi \$62.77 per hour; and Jonna Intoschi has not and will not receive any compensation in addition to this hourly pay rate.

6. The City Council hereby authorizes the City Manager to execute and implement, on behalf of the City, the Retired Annuitant Agreement with Jonna Intoschi.

7. This Resolution shall take effect immediately upon its adoption.
