1) What is the nature of the common social or economic interest of your community? You can describe what the common interests of your community are and why or how they are important.

Rohlffs Manor, within District 2: a 55+ residence for ca 300 'seniors,' many of whom are still employed and the remainder retired. Because of Covid, not much is happening in the way of socializing at this time. Maybe the greatest common interest is in maintaining the city's currently very satisfactory transit service and the prompt and very frequent visits by EMTs and ambulances. Living within walking distance of one of the city's largest 'county islands' seems not to be of concern to anyone, and I realize that topic is not necessarily within the scope of this survey. Note our proximity to The Vintage at Napa and Redwood Retirement Center on the north side of Redwood Road, which are within District 1 but which most likely have the same interests as residents of Rohlffs Manor.

Here is where I fall short on comments. As I mentioned above, we mostly appreciate transit and EMTs! However, it would be wise to have a better water usage plan at this site and that is something that only management can address--way too much water is being used by residents for personal plantings in areas designated to be left as 'common areas.' This results in a lot of color and beauty, but it also costs a lot of water. Beyond that, our residents live within the rules (well, more or less), established by EAH, the owner of Rohlffs Manor.

My only comment about current district lines is that it seems The Vintage at Napa and Redwood Retirement Center (and even Aegis), with addresses on the north side of Redwood Road, should be included in the same district as Rohlffs Manor given the purpose of all these residences. There is strength in numbers.... I can see that using Redwood Road as a dividing line between Districts 1 and 2 is not inappropriate but perhaps that dividing line can be adjusted to wend around the north side of The Vintage and Redwood Retirement parcels.
