ORDINANCE OF THE CITY COUNCIL OF THE CITY OF
NAPA, STATE OF CALIFORNIA, AMENDING NAPA
MUNICIPAL CODE CHAPTER 10.20.040 RELATED TO THE
ESTABLISHMENT AND ENFORCEMENT OF SPEED LIMITS

WHEREAS, the State has asserted broad authority over, and a statewide interest in, the entire field of regulating vehicles and traffic (as set forth in the California Vehicle Code, particularly Section 21), and unless expressly authorized by the State legislature, a California city shall not enact or enforce any ordinance or resolution on matters regulated under the California Vehicle Code; and

WHEREAS, under this broad authority, California State law generally provides for a set of statewide and uniformly applicable traffic controls, including a set of prima facie speed limits, which are the speed limits that apply on streets and highways when no other speed limit is posted; and

WHEREAS, State law expressly authorizes the legislative bodies of local authorities, such as the City Council, to establish declared speed limits that deviate from the otherwise applicable prima facie and maximum speed limits established under State law when supported by an engineering and traffic survey performed in accordance with traffic engineering practices; and

WHEREAS, the City has previously adopted ordinances, as codified in Napa Municipal Code Chapter 10.20, to implement this authority to establish declared speed limits based on engineering and traffic surveys; and

WHEREAS, the City Council wishes to update previously established declared speed limits, based on updated engineering and traffic surveys, through an amendment to Chapter 10.20 as set forth in this ordinance; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meeting of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Napa as follows:

SECTION 1: Amendment. Napa Municipal Code Section 10.20.040, “Declared Speed Limits,” is hereby amended by repealing the previous language in its entirety and replacing it with a new Section 10.20.040, “Declared Speed Limits,” to read as follows:

10.20.040 Declared Speed Limits.

The City Council hereby determines and declares, based on a resolution adopted in accordance with this chapter, that the declared speed limits for the following streets or roadway segments shall be as set forth in this section, below. No person shall drive a vehicle at a speed greater than the declared speed limit for the street segment:

ATTACHMENT 1

The City Council hereby declares that it would have passed each section, sub-section, subdivision, paragraph, sentence, clause or phrase of this Ordinance, irrespective of the fact that any one or more sections, sub-sections, subdivisions, paragraphs, sentences, clauses or phrases may be declared invalid or unconstitutional.

SECTION 3: Effective Date. This Ordinance shall become effective thirty (30) days following adoption.
