AMENDMENT NO. 1 TO COOPERATIVE AGREEMENT 04-2549 (4-17-18, AH)

This Amendment No. 1 to Agreement (AMENDMENT 1), entered into, and effective on, 2018, is between the State of California, acting through its Department of Transportation, referred to as CALTRANS, and:

City of Napa, a body politic and chartered city of the State of California, referred to hereinafter as CITY.

RECITALS

- CALTRANS and CITY, collectively referred to as PARTNERS, entered into Cooperative Agreement 04-2549 (AGREEMENT) on June 23, 2015, defining the terms and conditions for cooperating on all phases of a highway improvement project in Napa County. The project consists of three separate but interdependent roundabouts in close proximity in CITY, one belonging to CALTRANS and the other two belonging to CITY, all three roundabouts having been scheduled for construction under one construction contract. Under AGREEMENT, CITY and CALTRANS are sole SPONSORS for CITY's and CALTRANS' roundabouts, respectively, but are jointly funding PROJECT. Also, under AGREEMENT, CITY is the IMPLEMENTING AGENCY for PA&ED, PS&E and R/W components, while CALTRANS is the IMPLEMENTING AGENCY for the CONSTRUCTION component of PROJECT. Finally, under AGREEMENT, CITY is the CEQA lead agency, and CALTRANS is the CEQA responsible and NEPA lead agency for PROJECT.
- 2. In January of 2018, the PROJECT team, during the preparation of the final PS&E package and evaluation of the PROJECT risks, determined that additional budget for CONSTRUCTION CAPITAL and CONSTRUCTION SUPPORT would be necessary to construct and administer PROJECT during the construction phase. The revised dollar amounts are documented in a Project Change Request (PCR), approved on March 1, 2018.
- 3. PARTNERS now wish to enter into AMENDMENT 1 to increase the funding obligations on PROJECT as discussed above and agreed upon by PARTNERS.

IT IS THEREFORE MUTUALLY AGREED:

4. PARTNERS hereby amend AGREEMENT by replacing Exhibit "A" FUNDING SUMMARY in its entirety with FUNDING SUMMARY NO. A1, attached hereto and made a part of AMENDMENT 1. Any reference to FUNDING SUMMARY in AGREEMENT will now be deemed a reference to FUNDING SUMMARY NO. A1.

- 5. All other terms and conditions of AGREEMENT shall remain in full force and effect.
- 6. AMENDMENT 1 is deemed to be included in, and made a part of AGREEMENT.
