

I have been personally active daily in the preservation, restoration, and historical research of the two homes on the property for over four years. This has been a hands on project from the very beginning. Having been involved personally on this project for all these years as provided experience at a professional level. I have been working on homes for over 45 years and gaining knowledge at each project. I have been always eager to share the knowledge I have acquired as others approach me for advice.

- Studying the Secretary of Interiors Standards to insure work or changes are compliant is a priority.
- Used my art background and research knowledge to design architectural features such as the front portico on the
  Gothic Revival house, create floor plans, select materials best suited for historical structures, choose historical paint
  colors, use sensitivity in incorporating current building standards with historical buildings.
- Sourcing appropriate replacement vintage items at bay area businesses such as surplus warehouses, eBay and Craigslist provided insight on recognizing and understanding possibilities.
