Thank you Esteemed City Council Members for cancelling the March 27th Public Hearings due to the threat of Coronavirus. I would urge you to cancel the remaining Public Hearings through April as well.


I have a right to run for city office as an American Citizen, just as every Latino has the right to vote. In America, one person one vote.

Good afternoon, Napa City Council.

I want to thank you for your commitment to finishing the process of shifting to district elections in time for the presidential election.

I also want to take a moment to thank city staff who have been conducting the organizational and outreach efforts— putting together the flyer with the dates of the various public hearings, packets of information for each meeting, and headsets for the simultaneous translation, organizing the community workshop, posting information online, and fielding emails. If anyone should have been upset by the compressed timeline it is city staff; yet in all of my interactions with them they have been positive, friendly, and gracious. They are true professionals, and I am sure you are very proud of them. There is a concern, however, as Scott Rafferty mentioned at the last meeting, about the sequence proposed by city staff, as it clearly has the effect of benefitting incumbents over Latino voters. As he mentioned, it is important that the demographer review the sequence and propose a new one based on objective data and in line with the purposes of the California Voting Rights Act.

While I have appreciated the demographer's commitment to not knowing where incumbents live, city staff know where incumbents live, and they work for the city council. Asking them to create the sequence is a conflict of interest and puts them in an untenable position. Please take them out of the middle of this highly political process.

Finally, the issue of the sequence makes clear why a citizens' redistricting commission should be put in place with its members chosen by a neutral body or person, such as a retired judge, in time for redistricting after the decennial census. In the meantime, the demographer should act as that neutral person, again both in terms of a map recommendation as well as its corresponding election sequence. Thank you.
