8. COMMENTS BY COUNCIL OR CITY MANAGER:

Councilmember Narvaez spoke regarding the resolution that Council previously adopted affirming that discrimination and systemic racism is a public health crisis. He asked that the City highlight the resolution on the website and continue to have conversations with the community regarding the matter.

Councilmember Painter highlighted that many cities across the Country were shining lights that evening in memorial of over 400,000 souls who lost their life to COVID-19. She also spoke regarding the event that took place at the US Capitol on January 6th, and shared that she supported efforts to impeach President Trump and acknowledged the need to protect democracy. She also acknowledged and thanked the previous public speakers for bringing forth their requests for future agenda items.

Vice Mayor Alessio shared the desire to establish a Diversity Inclusion Commission. She also thanked her fellow Councilmembers for their personal contributions towards a Ben and Jerry's Ice Cream Day in which over 400 scoops were delivered to the front line workers at the Queen of the Valley Hospital.

Mayor Sedgley provided Council with a copy of a handout from a previous Napa County League of Governments (NCLOG) meeting titled " Principals for Creating a Healthy and Vital Sustainable Napa County".

Can City Government Fix Traffic Problems During Covid 19?

Here is an all too familiar conundrum facing Napa since the Coronavirus arrived to mess up just about everything: I'm referring to speeding on neighborhood streets. The conundrum is should neighborhoods ask the city to address a problem that typically requires staffing and money to fix? Or do we sit back and wait for better times?

My neighborhood has had a traffic problem (speeding) for years on our street (South Jefferson between Old Sonoma Rd and Imola). Some of us have spoken with Napa Police complaining that vehicles exceed the 30 mph limit. Most times the officers said they were part of the patrol division and if they saw a problem they would respond. Otherwise it's the job of the Traffic Unit (since disbanded).

Napa's Traffic Calming Process

Created in 2005, the plan is designed to offer a variety of traffic management alternatives to citizens. I filled out the forms, measured the street and counted about 700 vehicles per hour around 4:30 to 5:30pm. I was fortunate to meet with Napa's Transportation Engineer, Ed Moore to go over my submission. He tried to find a workable solution for S. Jefferson but at every turn city and/or state policy overrode my suggestions. Here are the highlights or should I say low lights from my submission to Traffic Calming:

- Lower the speed limit to 25 mph. State Law prevents lowering the limit.
- Only accidents reported to police are considered. I saw seven or eight in 2020, but the two that were reported didn't reach the unsafe standard.
- I suggested adding sidewalks but Napa generally opposes them. Vehicles not pedestrians have the right away on Jefferson St.
- I recommended solar radar. It was a non-starter given the severe budget shortfall.

•

In short, my Traffic Calming request was more frustrating than fruitful. Vehicles 1 Neighborhoods 0.

My Next Stop: Napa's Police Department

Napa's five position Traffic Unit was disbanded earlier in 2020. When it was eliminated the unit was down to three officers. The Patrol Division has not picked up the slack in terms of traffic enforcement. It's not a priority for Patrol Officers and the impact shows it.

Here's what my public records request found:

1354 total moving traffic citations issued in 2019 852 citations for speeding issued in 2019 145 total moving citations for same period in 2020 83 citations for speeding issued in 2020

2020 citations for speeding on S. Jefferson 0

How About Applying for a State Grant for Traffic Enforcement?

Good idea but its been done before. A previous state grant had to be forfeited because Napa failed to meet staffing requirements included in the grant.

In Summary

The Police Department does not have traffic enforcement as a priority. City Council does not have reducing speeding as a 2021 goal and the City Manager's Office is quiet in the background.

Unfortunately, citizens have insufficient leverage to reduce speeding.

The worse thing Napa can do is nothing!

SUBJECT: Agenda Item 5.I – Equipment and Vehicle Replacement Purchases

Staff recommends modifying the proposed resolution to authorize the Public Works Director to negotiate and execute a contract for the purchase of the backhoe. The Fleet Division within the Public Works Department has the responsibility for the process of procuring City vehicles and equipment. The original resolution in the packet would have authorized the Utilities Director instead of the Public Works Department to make the purchase.

The following is a minor modification to section 2 of the proposed resolution for the purchase of the backhoe for the Utilities Department:

2. The City Council hereby authorizes the <u>Public Works Director</u> <u>Utilities Director</u> to negotiate and execute an agreement with Pape Machinery in the amount of up to \$165,000 for the purchase of a backhoe loader for the Utilities Department.

The title of the Resolution also needs to be modified as shown below.

WHEREAS, an amendment to the vehicle and equipment replacement schedule set forth in Exhibit D of R2020-084 and a budget adjustment are required to make these purchases in the current fiscal year; and

WHEREAS, funding for the purchases is available in the Fleet Replacement Funds; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Napa, as follows:
