## 7. COMMISSION INTERVIEWS AND APPOINTMENTS:

It was noted that applicant Jessica Penman was unable to attend the meeting, however, she submitted a letter providing details of her interest in serving.

After the interviews, each Councilmembers voted, by paper ballot, to identify the two preferred candidates to be appointed to the Commission. City Clerk Carranza announced that: (A) the greatest number of votes were

received by Sarah Van Giesen Clark (3 votes) and Deborah Macdonald (2 votes); and (B) the vote of each Councilmember for the candidates was as follows:

- · Sedley: Macdonald and Van Giesen Clark.
- · Luros: Macdonald and Van Giesen Clark.
- · Gentry: Wesson and Van Giesen Clark.

A motion was made by Councilmember Luros, seconded by Councilmember Gentry, to re-appoint Sarah Van Giesen-Clark and Deborah Macdonald, to the Cultural Heritage Commission; with Ms. Van Giesen-Clark designated as a Preservation Professional, with terms effective July 1, 2019 through June 30, 2021. The motion carried by the following vote:

#### 8. COMMENTS BY COUNCIL OR CITY MANAGER:

Vice Mayor Sedgley requested that staff report back on the feasibility of reinstalling bronze plaques that had originally been installed on the 3rd Street Bridge in 1932, dedicating it as the George M. Francis Bridge. He noted that staff had located the plaques and, while the bridge was no longer named the George M. Francis Bridge, he hoped to keep that piece of history and to also recognize Mr. Francis who was the previous owner of the Napa Valley Register and journalist, previous Postmaster, and former Director of the Napa Asylum. Councilmembers Gentry and Luros supported his request.

Councilmember Gentry acknowledged the passing of Michael Lane and asked if the City Manager could work with staff to provide a status update on his project located on Silverado Trail. Vice Mayor Sedgely and Councilmember Luros supported her request.
