Valerie Wolf - read submitted comment from Ron Rhyno which provided observations of the transition to district-based elections and the redistricting processes noting concerns regarding community representation.

Amy Martenson, on behalf of the Napa County Progressive Alliance provided comments regarding the redistricting process and shared frustration that the West Pueblo/Linda Vista Island had not been annexed and that boundary lines were not drawn so that some of the unincorporated island could be added to District 4 upon future annexation.

A motion was made by Councilmember Alessio, seconded by Councilmember Painter to close the public testimony. The motion carried unanimously.

Discussion was brought back to Council; brief comments ensued.

A motion was made by Councilmember Painter, seconded by Vice Mayor Luros, to approve the second reading and final passage, and adopt Ordinance O2022-005 adopting the final map of district boundaries for district-based election of Councilmembers in accordance with the redistricting process for the 2020 Federal Decennial Census (California Elections Code Sections 21620-21630), and amending Napa Municipal Code Section 1.10.010 to implement the district-based elections. The motion carried by the following vote:

Quite simply, Vladimir Putin had no other choice but to invade The Ukraine. The Russian Federation's very existence likely depended on it, probably in his way of thinking. The idea that the leaders in capitol Kiev were hesitant in consenting to Moscow's campaign for a neutral Ukraine was intolerable. Self preservation is the number one rule in nature and in nations, therefore Putin made the safe and sane decision to be proactive in that regard. Folks may not like it, but apparently he saw that the elimination of any chance of a nuclear re-arming of The Ukraine was required. Walk with me please down a road in the fictional futurescape, where the newly formed "Russia/China Alliance ", (RCA) has chosen our northern neighbors to join its ranks. Canada gleefully accepts the invite, and the military brass at the Pentagon are beside themselves in trying to figure out how this can be nipped in the bud. No way, Jose, the crimson maple leaf can not adorn the letterhead of the RCA's proclamations in this strange, albeit fictional, new world. Scott/Steve and Council members, attached are comments based upon observations over two redistricting processes.

- Napa City has grown from approx. 4000 residents in 1900; to 13,500 in 1950; to 62,000 in 1990; to over 80,000 in 2020.
- The Council membership has been 4+1 since the 1950s 4 Council members & 1 Mayor
- There is a difference between being a District Representative and Representing a District. The latter actively involved in communication to and from District residents.
- During the City's existence there have been 3 "new majority" members -Chew, Pedroza, and now Narvaez post-redistricting.
- During the last redistricting, members of the Progressive Alliance and others including myself and students submitting maps to increase representation from 4+1, to 5 with a rotating Mayor position; and 7 districts within which 2 districts had numerical "new majority" number advantages.
- The reported lack of participation is not because of lack of interest, but because it's been made clear that the past and current Council want to limit voice [i.e. control] by limiting the Council Napa City's community representation.
- The GIANT in the City is the ongoing unwillingness to incorporate the decades-long Unincorporated Islands, a contemporary form of redlining.
- The Council begs the question of what actions our Communities need to be take to receive real representation?





I'd like to thank Tony Valdez, the Parking Manager, for taking the time to explain the current abandoned car process and the Napa Police Department for getting the abandoned cars tagged within 4 hours of my call.

Current program for abandoned cars.

- Citizen observes abandoned car for 72 hours

- If and when car is tagged, there is another 72 hours waiting period(minimum 144 hours of abandonment)

- priority for abandoned car enforcement
  - 1-damaged, full of trash obviously non-operable vehicles
  - 2-oil leakage resulting in storm water contamination
  - 3- no real set of priorities after this point for abandoned cars
- once car tagged, it MAY be towed 72 hours later
- currently, the parking enforcement is made up of 2 people
- back log of 350 cars

- as is the system does not work. The city does not have a working program. Lack of staffing and resources indicates the city has no intention of improving the situation for the parking manager.

The parking problem is only a symptom of the larger systemic situation. Too many high density housing projects surrounding single family homes in a few Napa locations. No thought is or was given to mitigating the consequences of high density housing and providing relief to the surrounding homes. At this time the city has shown no intention to distribute the high density housing to other locations, such as Alta Heights or Browns Valley. The brunt of high density housing is felt by a few, while the outlying areas are unaffected.

Establishing a Resident Permit Parking Program, is an option, However, the Public Works Department has no funding for the required studies as outlined in the program. Again the brunt of the high density housing is only felt by those homes adjacent to the projects. Areas of the city that have successfully avoided high density housing are not subject to funding studies nor taking time to write numerous emails on parking violations. For the current families who are in this situation the only recourse is to support future council members who support distribution of high density housing across the entire city and who agree that relief is needed to those currently feeling the impact from existing projects.

The cars mentioned below <u>do not</u> belong to our neighbors. We have witnessed drivers park their cars, wait till picked up by another car and drive away. Or the driver walks to a house on Pueblo, or the apartments at Pueblo and Soscol or the apartments on Soscol. A few homes in our neighborhood watch the cars for the driver in their absence. This is based on the fact of the four cars tagged at noon on 3/7, two moved in 4 hours and the third was gone by 9pm.






Unfettered parking at the Pueblo Beecham intersection has resulted in the loss of visibility to oncoming traffic when going from Beecham onto Pueblo. Numerous times the cross walk has been blocked, and when cars are parked on both corners, there is no room for a car to safely. exit and another to safely enter Beecham Street.





The silver Kia was red tagged, then moved 100ft and tag was partially removed. See Photo below. This is anincidental move and the 72 hour clock should not start again. The truck has been there since 2/26 and was first reported on 3/3.

Napa City Council:

Since the beginning of this process, we have come to you, not because we expected you to do anything differently than what you will do tonight, approve the existing district map, but for posterity and to document the Council's unwillingness to take any meaningful steps to include the underrepresented residents of Napa's largest county island— the West Pueblo/Linda Vista county island— in a meaningful way.

There was enough time to annex this large county island to include its residents in the redistricting process, both in terms of their numbers and their input. The City Council refused.

As a compromise, to again give voice to these residents, we encouraged the Council to attach the six precincts between the eastern border of the county island to the central district, District 4, so that upon annexation the entire island or at least the eastern half, which has demographics that are similar to the central district, could unite with its voters to elect their candidate of choice, rather than having their votes diluted by automatically being included in District 2, dominated by Browns Valley voters. The City Council refused.

Two council members could not get over a district crossing Highway 29, perhaps forgetting that districts are not for incumbants but are for voters: to increase their voting power, especially that of underrepresented voters, when possible.

We believe the lack of participation this time around is not a sign that citizens are happy with the current districts but rather that citizens are savvy and understand that representatives will always be married to the system under which they were successful in getting elected. Perhaps District 2 and District 4 incumbents, Painter and Narvaez, feel that adding almost 1,800 working class and a majority Latinx residents to their district could hurt rather than help their re-election, especially if a grassroots candidate came along who would better represent their interests.

As much as we were criticized by some members of this Council for forcing the City to change to districts by applying legal pressure, there is no doubt in our minds that this Council would not have changed any other way. We foresaw the Council's unwillingness to make changes to the new district map during redistricting, which is why we, along with other organizations representing voters pushed for an independent citizens redistricting commission. The Council's refusal to relinquish power and control over the process by refusing to approve such a commission and Council comments made early in the redistricting process made it abundantly clear that the Council had no intention of changing anything, desiring to maintain the status quo. It is for this reason, we believe that there was a lack of community interest and participation in the process.

What will it take for the Council to annex all of the county islands that are completely surrounded by the city, so their residents have a city representative they can lobby on issues effecting them? The threat of a lawsuit by a Latinx voter? What will it take to put into place an independent redistricting commission for redistricting ten years from now? A voter-led ballot initiative? Or will the Council start doing the right thing and begin making decisions that benefit average citizens on its own?
