RECOMMENDED ACTION:

Approve the second reading and final passage, and adopt an ordinance amending Napa Municipal Code Section 17.52.390 "Recycling/Solid Waste Areas" and determining that the actions authorized by this ordinance are exempt from CEQA.

DISCUSSION:

This is the Second Reading and Final Adoption of an ordinance amending Napa Municipal Code Section 17.52.390 "Recycling/Solid Waste Areas" and determining that the actions authorized by this ordinance are exempt from CEQA. The introduction and First Reading was held at the Regular City Council meeting on November 16, 2021.

Following the November 16, 2021 hearing, staff identified a typo on the proposed ordinance on page 4, forth line from the bottom, which read, "...based either or site constraints..." and has since been corrected, as reflected in Attachment 1, to read "...based on either onsite constraints..."

If approved the Ordinance will become effective thirty days following adoption.
