#### RESOLUTION R2025-

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NAPA, STATE OF CALIFORNIA, APPROVING THE 2025-2026 ANNUAL REPORT AND BUDGET FOR THE OXBOW **BUSINESS PROMOTIONS ASSESSMENT** DECLARING ITS INTENT TO LEVY ASSESSMENTS AND AUTHORIZING THE CITY CLERK TO SCHEDULE A PUBLIC HEARING ON JUNE 17, 2025 TO LEVY ASSESSMENTS IN ACCORDANCE WITH NAPA MUNICIPAL CODE CHAPTER DETERMINING THAT 3.29; AND THE ACTIONS AUTHORIZED BY THIS RESOLUTION ARE EXEMPT FROM CEQA.

WHEREAS, pursuant to California Streets and Highways Code Section 36500, et seq. and Agreement No. 9354 between the City of Napa ("City") and the Napa Downtown Association (NDA), Management of Assessment Districts, approved on June 19, 2007, the City Council reviews an annual report and budget for the Oxbow Business Promotions Assessment Area ("Oxbow BPAA") and authorizes the levying of assessments upon businesses within the Oxbow BPAA boundary as outlined in Napa Municipal Code Chapter 3.29; and

WHEREAS, the Advisory Board of the Oxbow BPAA caused to be prepared and delivered to the City the FY 2025-26 Annual Report, which is on file with the City Clerk, and is attached hereto as Exhibit "A" and the FY 2025-26 Budget, which is attached hereto as Exhibit "B;" and

WHEREAS, the FY2025-2026 Oxbow BPAA Annual Report and Budget contains a full and detailed description of the improvements and activities to be provided to the Oxbow BPAA, the boundaries of the area, and the proposed assessments to be levied upon the businesses in the Oxbow BPAA; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City staff, and any information provided during public meetings.

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Napa, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this resolution are true and correct and establish the factual basis for the City Council's adoption of this resolution.
- The City Council hereby determines that the actions authorized by this Resolution are exempt from CEQA, pursuant to CEQA Guidelines Section 15323 (normal operation of facilities for public gatherings). The City Council

also determines that the actions are exempt, on a separate and independent basis, pursuant to CEQA Guideline 15301 as the operation and maintenance of an existing business area with negligible expansion of use.

- 3. The City Council hereby approves the Fiscal Year 2025-2026 Oxbow BPAA Annual Report attached hereto as Exhibit "A" and the Budget attached hereto as Exhibit "B". As required by California Streets and Highways Code Section 36533, the Oxbow BPAA Annual Report includes the following information:
- (a) Any proposed change in boundary of area or benefit zone, or parcel classification: as identified in Exhibit A, no changes to boundaries or classifications are proposed.
- (b) Improvements and activities to be provided for Fiscal Year July 2025 June 2026: the activities include a multitude of special events to encourage the community to come downtown; marketing efforts to amplify the visibility of downtown merchants; and administration and support efforts to include management and staffing to the Napa Downtown Association and the Downtown Napa Property & Business Improvement District.
- (c) Estimated cost to provide the improvements and activities for the year: The estimated cost to implement the Oxbow BPAA work program is \$916,625 as set forth in Exhibit B.
- (d) Method and basis of levying the assessment in the Oxbow BPAA: The taxes for the DBPTA and Oxbow BPAA are levied in an amount equal to 40 percent of the business license tax for businesses in the benefit zone. Business license taxes are imposed on each business pursuant to Napa Municipal Code Chapter 5.04.
- (e) Amount of any surplus or deficit revenues to be carried over from previous fiscal year is estimated at: \$27,900.42.\_\_\_\_
- (f) Amount of any contributions to be made from sources other than assessment revenue levied pursuant to this part: The budget anticipates \$225,000 coming from PBID & TID to supplement funding of NDA events and programs and \$115,550 from the Napa Table. The NDA also anticipates revenue of approximately \$60,000 from the Downtown Napa Shop Guide, Pedestrian Sign Program, Alcohol Sales, and smaller event sponsorships.
  - 4. The City Council hereby declares its intention to levy and collect assessments upon businesses within the Oxbow BPAA for Fiscal Year 2025-2026.

- 6. The City Council hereby sets the time and date to levy assessments in the Oxbow BPAA at a public hearing on Tuesday, June 17, 2025 at 3:30 p.m. at City Hall Council Chambers, 955 School Street, Napa, CA, at which time written and oral protests may be made in accordance with Streets and Highways Code Section 36524 and 36525.
- 7. The City Council hereby directs the City Clerk to give notice of the public hearing by publishing said notice once in a newspaper of general circulation in the city not less than seven days before the public hearing.
- 8. This Resolution shall take effect immediately upon its adoption.
