City Clerk Carranza announced the scores and that with a score of 6, Thomas Gorton would move forward as one the recommended nominees for appointment. With a tie for the second nominee, Vice Mayor Luros and DeNatale shared their reasoning behind the scores. A brief discussion ensued, and the ballots were redistributed and second vote took place with Vice Mayor Luros and Councilmember DeNatale ranking applicants Kittle and Allison on a scale of 1-2 with two being the most qualified.
