### 1. PROBLEM STATEMENT

## Describe the city, county, or jurisdiction this grant will impact.

The City of Napa is in Napa County. The City of Napa is the seat of Napa County, within the heart of the Napa Valley wine region. The population is over 78,000 residents in an area of approximately 18.15 square miles. The City of Napa is located within the North Bay region of the Bay Area, triangulated between both San Francisco and Sacramento. The city has CA-29 which connects Vallejo and the East Bay Area to the Napa Valley Wine Country to the north. CA-12 runs through the south of Napa, connecting Fairfield and Interstate 80 to the east and Sonoma and US-101 to the west. CA-121 also connects Sonoma from the west to CA-29, through the city streets of Napa, and reconnects through the east hills of Napa County as a backroad commute from Lake Berryessa, Fairfield, and Winters. Napa is also home of Napa Valley College, Napa State Hospital, Syar Industries, UPS, Napa Premium Outlets, and numerous other corporations.

Several factors cause daytime traffic in Napa to be extremely heavy. CA-29 is a heavily traveled north/south freeway and highway that extends the length of the city. It is traveled by thousands commuter, tourist, and commercial vehicles daily to service the upper Napa Valley wine industry. Silverado Trail is also a north/south highway, which feeds travels through the east side of the city. It is highly traveled all day long due to the connection with Silverado Trail north, which feeds the east side of the upper Napa Valley wine industry. Imola Avenue, Trancas Street, Lincoln Avenue and Soscol Avenue are all major thoroughfares within Napa, which connect several highways from one side of the city to the other. They are all two lanes in both directions. Business, commute, commercial and tourism are the major factors for the city streets to swell during the day and into the evening. Weekend travel may slow on smaller city streets; however, it is consistently travelled on the larger streets due to tourism travel.

Motorcycle specific travel is common for commuters to and from the Bay Area. Motorcycle travel is also increased during the weekends due to several major connecting two-lane backroad highways popular for group and solo riding. The rides are commonly linked on popular motorcycle-based internet and magazine sources as rides through and around Napa Valley.

# Describe the problem(s) to be addressed, supported by current and relevant crash data. (most recent calendar year data/stats).

With the above-described jurisdiction and influx of citizens, including motorcycle riders, the Napa Police Department would like to address the need for rider to enhance their riding skills, which includes crash avoidance. With these skills, both new and experience riders can train to reduce the likelihood of crashes and the possibility of injury or death.

Our motorcycle involved crashes with injuries or fatalities over the past three years are as follows (most current data from Napa PD Crossroads crash reports):

In 2021 there were 16 motorcycles related crashes resulting in 17 injuries and 2 fatalities. Top Primary Crash Factors were Auto right of way violation (5), Unsafe Turning (4)

In 2022 there were 14 motorcycle related crashes resulting in 10 injuries and no fatalities. Top Primary Crash Factors were Auto right of way violation (4), Unsafe Turning (3), DUI (2), Failure to Yield (3) In 2023 there were 16 motorcycle related crashes resulting in 9 injuries and no fatalities. Top Primary Crash Factors were Unsafe Turning (6), Auto right of way violation (2)

In 2024 there were 8 motorcycle related crashes resulting in 3 injuries and no fatalities. Top Primary Crash Factors were Unsafe Speed (2), Traffic Signals and Signs (2) and Auto right of way violation (2)

Note:2024 was the first calendar year where Napa Police Department was administering the Motorcycle safety grant

According to the SWITRS summary for both the County and City of Napa, motorcycle crashes in 2021-2023 yielded the following statistics:

- 2021 61 injury crashes and 6 fatalities.
- 2022 51 injury crashes and 0 fatalities.
- 2023 55 injury crashes and 4 fatalities.

The Napa Police Department is looking to continue our partnership with OTS so we can continue to provide motorcycle safety courses available to the general public. These courses have been highly sought after and the Napa Police Department is receiving requests to offer more as the course popularity grows. The Napa Police Department is focused on fine-tune the course operation, with the goal of offering additional courses through the year. This course is based on the curriculum that law enforcement officers receive at Motor Officers Training Courses and Motor Officer Instructor Courses. In addition, OTS funding will allow current Motorcycle Officers and Motorcycle Training Officers to teach and participate in the trainings as demonstrators, further enhancing their motorcycle safety training.

Define the target population the grant intends to serve and how they are affected by the problem(s). The Napa Police Department will offer free motorcycle training courses to both newly licensed and experienced motorcycle riders. This course is designed to welcome all experience levels and used as an aid to keep riding skills at a high level. Riding a motorcycle is a perishable skill and should trained as such.

#### A. Goals:

- 1. Reduce the number of persons killed in traffic crashes.
- 2. Reduce the number of persons injured in traffic crashes.
- 3. Reduce the number of motorcyclists killed in traffic crashes.
- 4. Reduce the number of motorcyclists injured in traffic crashes.

The Final Evaluation should provide a brief summary of the grant's accomplishments, challenges and significant activities. This narrative should also include whether goals and objectives were met, exceeded, or an explanation of why objectives were not completed.
