Solid Waste & Recycling Proposed Rates to Meet Regulations

Residents can be proud of Napa's solid waste program that diverts approximately 65% of collected materials from landfill. Clean Compressed Natural Gas (CNG) vehicles collect materials that are processed at our robust recycling, food scrap and composting facility. **What has changed? State Senate Bill 1383 requires recovery of organic materials.** Initiatives have been implemented with Napa Recycling and Waste Services (NRWS) to ensure compliance.

Rates have not increased since 2022 and changes are proposed to meet the costs of the City's successful materials diversion program. If approved, residential customers can expect to see the following in their future monthly solid waste bills from NRWS:

Napa's Rates Will Remain Below Regional Average





How are solid waste and recycling rates used?


The cost to provide effective solid waste/recycling services and divert 65% from landfill is about \$52.6M per year. As shown in the chart below, a large portion of the cost is our contract with Napa Recycling & Waste Services to employ 87 employees, operate and maintain 30 refuse/recycling trucks and state of the art recycling, sorting, and composting equipment to collect and process all material. The revenue to support these services is also shown below. Increasing expenses to meet State legislative and environmental requirements, significantly higher fuel and energy costs, and major capital improvements necessary for the recycling and composting facility has left a \$5.2M gap that will be addressed by the proposed rates.

Collection



Why is a Rate Increase Needed?

Beginning in the 2024 fiscal year, expenditures began to exceed revenues. The three primary drivers of this change are outlined below.

SB 1383 Requirements

In 2023, the City executed an amendment to the contract with Napa Recycling and Waste Services (NRWS) to comply with SB 1383 (Mandatory Organic Recovery).

Key costs:

- \$2.6M in new organics processing equipment (\$1.5M paid by CalRecycle grant)
- \$523K NRWS commercial compost collection vehicle (\$113K paid by CalRecycle grant)
- 1,600 new composting carts focused on commercial and multi-family accounts
- New NRWS driver, two new compost equipment operators, two NRWS Recycling Outreach Specialists, and 1 ½ NRWS Customer Service Representatives (1/2 of position paid by Napa County)
- Quarterly Facility and annual Field Audits (as required by SB 1383)

Cost Increase = \$2.8M/year

Dramatically Increased Fuel and Electricity Costs

- The costs to fuel NRWS collection vehicles and power the City's recycling and composting facility have more than doubled since 2019 (\$1.2M in CY2019 to \$2.5M in CY2024)
- Over the 5-year rate period, fuel costs are projected to increase by over 5% per year while the cost of electricity is projected to increase by 11% per year resulting in a projected cost of \$3.5M by CY2029

Projected Expense = \$3.5M by CY2029





Capital Improvements

Proposed Rates include the cost of necessary capital improvement at the City's Materials Diversion Facility (MDF).

These include:

- Enhanced Composting system (\$13M) to comply with State regulations to process food scraps and air district regulations for emissions
- Installation of a 12 KV electrical system (\$2.8M) as required by PG&E for current and future facility power demands
- Improved Stormwater Management system (\$1.3M) to comply with Composting Order from Regional Board
- Deferred maintenance for facility concrete, scalehouse, storage and fencing (\$1.6M)

Average Cost Increase = \$3.7M/year

Reduce Exposure to Market Volatility & Invest in Recycling



Recyclable Material Sales produce a dual benefit to generate revenue that reduces rates and avoids cost and impacts of landfill disposal. It's great news the quantity of recyclable material has grown considerably, but the sale price per ton is very volatile. As shown in the chart below, over the last 10 years (CY2014 to CY2024), the market value of residential curbside recyclables has varied by 121% (from a low of \$121/ton to a high of \$268/ton).




Rate Stabilization Fund. The City projects \$10.6M in revenue for material sales in FY2026. If the global market for recyclables decreased by just 30%, the result would be a \$3.2M loss in revenue. Proposed rates establish a rate stabilization fund over the five-year period to be prepared to withstand market volatility in the future.

Good News for Napa.

SB 1013 added wine bottles and hard liquor containers to the California Redemption Value (CRV) system (aka "Bottle Bill"). This will significantly increase the value of glass containers and help insulate their value against wild market price swings.



Technology Investments. The City and NRWS have jointly invested in optical sorters, sorting robots, and other advanced technology at Napa's recycling facility that have already significantly increased recovery of mixed paper and other high value recyclables (e.g., aluminum cans, #1 PET plastic bottles/trays, etc.). The net effect of increased processing efficiency results in estimated materials sales revenue increase of \$3-4M annually into the future. This revenue helps offset other cost escalations that would otherwise have to be paid by rate payers.

NOTICE OF PUBLIC HEARING ON PROPOSED CHANGES TO RATES FOR COLLECTION OF SOLID WASTE

The Napa City Council will hold a public hearing at City Hall, 955 School Street, on Tuesday, June 17, 2025, at 6:30 pm, to consider proposed changes to the rates charged for collection of solid waste and recyclable materials from residential, multi-family, and commercial customers for the next five years. All rates are proposed to be increased 12.00% effective July 1, 2025; 10.00% effective January 1, 2026; 8.00% effective January 1, 2027; 8.00% effective January 1, 2028; and 6.00% effective January 1, 2029. These rate increases are based on (a) calculations for Operating and Capital Cost Payments to Napa Recycling & Waste Services as described in the Contract for the Collection and Transportation of Municipal Solid Waste, Recyclable Materials, and Compostables and the Operation of the Napa Materials Diversion Facility; (b) necessary capital improvements and maintenance of Napa Materials Diversion Facility, (c) increases in fees at the transfer station used by the City, (d) costs to repair street damage caused by heavy refuse and recycling vehicles; and (e) revenues and expenditures in the City's Solid Waste & Materials Diversion Enterprise Fund. The specific proposed maximum residential rates to be charged for each of the five upcoming years are shown in the tables below. The specific commercial, multi-family, and roll off rates proposed to become effective July 1, 2025, are shown in the tables below and on subsequent pages of this notice. Rate tables showing the specific maximum commercial, multi-family and roll off rates proposed to become effective January 1, 2026; January 1, 2027; January 1, 2028; and January 1, 2029 may be viewed on the City's web site at www.cityofnapa.org/SolidWasteRates.

As a result of the 2025 SWR rate study it was determined that MSW rates for roll-off debris boxes and certain temporary MSW service would be frozen at current rates. The rates for recycling roll-off boxes will be increased by 12.00% effective on July 1, 2025 and are shown below in detail. The recycling roll-off rates will be increased on January 1, 2026 by an additional 10.00%; on January 1, 2027 by an additional 8.00%; on January 1, 2028 by an additional 8.00%; and January 1, 2029 by an additional 6.00% and may be viewed on the City's web site at www.cityofnapa.org/SolidWasteRates.

Commercial and Multi-family Food Scrap Recycling, Yard Trimming Recycling, and Packaged Organics Rates

Commercial food scrap collection is currently offered at 75% of the equivalent MSW service and yard trimmings collection service is offered at no charge. As a result of the 2025 SWR study, the City will be implementing a 5-year phased in rate for yard trimmings collection service in which the rate will go from its current 'no charge' status to a cost-recovery model. Food scrap collection rates will also be phased down from the current 75% of MSW rate to a lower cost recovery rate over a five-year period. The City has introduced new costrecovery rates specifically for multi-family food scraps, multi-family yard trimmings, and commercial and multi-family packaged organics. Packaged organics service, which is reserved for food scrap generators with high levels of non-compostable contamination in the stream, is not currently offered, but may be activated by the City over the five-year rate adjustment period. Rate tables showing the specific maximum commercial and multi-family food scraps, yard trimmings, and packaged organics rates proposed to become effective July 1, 2025; January 1, 2026; January 1, 2027; January 1, 2028; and January 1, 2029 may be viewed on the City's web site at www.cityofnapa.org/SolidWasteRates. The proposed phase-in cost-recovery rate for these services over a 5-year period is shown in the tables. The food scrap compactor rate will not be adjusted from the current rate.
