RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NAPA, STATE OF CALIFORNIA; (1) ACCEPTING FOUR GRANTS FROM THE OFFICE OF TRAFFIC SAFETY, AND AUTHORIZING THE CHIEF OF POLICE TO SIGN THE GRANT AGREEMENTS: (2) AUTHORIZING REVENUE AND EXPENDITURE BUDGET INCREASES OF \$398,930 IN THE POLICE DEPARTMENT'S SPECIAL REVENUE GRANTS FUND FOR THE OFFICE OF TRAFFIC SAFETY GRANT PROGRAMS FOR FISCAL YEAR 2025-2026; (3) APPROVING AND AUTHORIZING THE CHIEF OF POLICE TO SIGN A SERVICE AGREEMENT WITH NAPA COUNTY BICYCLE COALITION IN AN AMOUNT NOT TO EXCEED \$93,930 TO PROVIDE PEDESTRIAN AND BICYCLE SAFETY IN NAPA COUNTY; AND (4) DETERMINING THAT THE **ACTIONS** AUTHORIZED BY THIS RESOLUTION ARE EXEMPT FROM CEQA PURSUANT TO CEQA GUIDELINE 15060(c)

WHEREAS, the Napa Police Department, in an effort to reduce the number of persons killed and injured in traffic crashes involving alcohol and other primary collision factors in the City and County of Napa applied for four grants from the State of California Office of Traffic Safety, including the Selective Traffic Enforcement Program, Motorcycle Safety Education and Training Program, Predictive Data to Enhance Enforcement Efforts Project, and the Pedestrian and Bicycle Safety Program; and

WHEREAS, the Napa Police Department was awarded the Selective Traffic Enforcement Program, Motorcycle Safety Education and Training Program, Predictive Data to Enhance Enforcement Efforts Program, and the Pedestrian and Bicycle Safety Program Grants totaling \$398,930; and

WHEREAS, for the Pedestrian and Bicycle Safety Program Grant, staff identified the Napa County Bicycle Coalition (NCBC) to deliver Pedestrian and Bicycle Education throughout Napa County in an amount not to exceed \$93,930; and

WHEREAS, the NCBC is the only known organization to have the required approvals from county law enforcement agencies and school districts, in addition to the experience and plan to deliver the education required by the grant during the grant period; and

WHEREAS, the City Council has considered all information related to this matter, as presented at the public meetings of the City Council identified herein, including any supporting reports by City Staff, and any information provided during public meetings.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Napa, as follows:

- 1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.
- 2. The City Council hereby accepts the State of California Office of Traffic Safety (OTS) Grants in the amounts of \$205,000 for the Selective Traffic Enforcement Program (STEP), \$30,000 for the Motorcycle Safety Education and Training Program, \$70,000 for the Predictive Data to Enhance Enforcement Efforts Project, and \$93,930 for the Pedestrian and Bicycle Safety Program for a total award amount of \$398,930 and authorizes the Chief of Police to sign the grant agreements on behalf of the City.
- 3. The City Council hereby approves the budget adjustment in the Police Department's Grants Special Revenue Fund for Fiscal Year 2025-2026 increasing both the revenue and expenditure budgets in the amount of \$398,930 as documented in City Council Budget Amendment No.3P3 attached hereto as Exhibit "A".
- 4. The City Council hereby determines that the Napa County Bicycle Coalition (NCBC) has the approvals, necessary experience and plans to deliver the training required by the Pedestrian and Bicycle Safety Program Grant and approves and authorizes the Chief of Police to execute the agreement with NCBC for an amount not to exceed \$93,930.
- 5. The City Council hereby determines that the actions authorized by this Resolution are exempt from CEQA pursuant to CEQA Guidelines Section 15060(c).
- 6. This Resolution shall take effect immediately upon its adoption.
