5. GRANT DESCRIPTION Best practice strategies will be conducted to reduce the number of persons killed and injured in crashes involving pedestrians and bicyclists. The funded strategies may include classroom education, bicycle rodeos, community events, presentations, and workshops. These countermeasures should be conducted in communities with high numbers of pedestrian and/or bicycle related crashes including underserved communities, older adults, and school-aged children. Coordinated efforts such as Safe Routes to School initiatives, Safe System Approach, and working with community based organizations are highly encouraged to prevent fatalities and injuries of vulnerable non-motorized road users.

1. PROBLEM STATEMENT

Describe the city, county, or jurisdiction this grant will impact.

Working in partnership with Napa County's Safe Routes to School initiative, and in agreement and partnership with law enforcement agencies throughout Napa County, the Napa Police Department is in the beginning stages of administering a second year of an Office of Traffic Safety Bicycle and Pedestrian Safety Education Grant county-wide through contractors, the Napa County Bicycle Coalition. The most recent local data again show increased bicycle crashes and therefore, a need for continuing best practice safety education that results in more behavior change.

The population of Napa County, located about an hour's drive north of San Francisco, is 133,216 (US Census, Population Estimates, July 1, 2023). A part of the greater Bay Area, Napa County enjoys a mild climate that makes walking and biking year-round a feasible option. Its climate, along with its world-renown reputation for fine food and wine, draws nearly 4 million visitors to Napa County each year (Visit Napa Valley).

There is a large amount of intra-county travel by residents. The 2019 Napa Countywide Bicycle Plan notes, "The majority of the local workforce live in the cities of Napa and American Canyon and commute to the 'Upper Valley' communities of Yountville, St. Helena, and Calistoga." As well, the 2014 Napa Valley Travel Behavior Study found that "55% of the study's sample traveled within the county" (both their origins and destinations were within Napa County). Both of these plans are currently being updated by the Napa Valley Transportation Authority; more current local data is expected early in 2026.

Napa County's school districts maintain an open-enrollment policy, allowing students to attend schools that are not their "school of residence." It is not uncommon for between one-third to two-thirds of students within one school's boundary to attend a school outside of that boundary in another neighborhood (in other words, not their school of residence) (see attached "Elementary School Attendance Matrix 23-24"). As well, all students in the town of Yountville attend schools in other jurisdictions, and many students in unincorporated areas do the same. Combined with Napa County's high rate of intra-county travel, it is reasonable to conclude that those going to school or working in a low crash neighborhood may live in a high crash neighborhood and vice versa.

Taking into consideration the Safe Systems Approach, it is important to note that local road designs lag behind those designed with best practice engineering countermeasures recommended by various traffic safety agencies. The county contains a mix of urban, suburban, and rural roads; only two segments of two roads contain a Class IV protected bike lane—installed for the first time in 2024. In 2023, Napa's first buffered bike lanes were installed on two approximately half mile road segments. While more plans are in the works to install low-stress bicycle facilities that incorporate a larger degree of separation between bicycle and vehicle traffic (a proven crash-reduction strategy), changes are slow moving. Until safer road designs can be implemented, the reduction of fatal and serious injury crashes must rely more on behavior change—also known a "safer people." Both safer roads and safer people are fundamental to reducing crashes, as noted by the call for redundancy by the Safe Systems Approach, but until Napa County implements safer road designs, a heavier burden will be placed on residents to reduce crashes by understanding and implementing safe practices.

Describe the problem(s) to be addressed, supported by current and relevant crash data. (most recent calendar year data/stats).

Local law enforcement crash data show a drop in the number of injury crashes of all types throughout Napa County in 2024 (see chart below), though the severity of those crashes, given an increase in fatalities, rose. There was a significant drop in pedestrian injuries; however, at 37, this is likely a return to a baseline that is itself high given OTS rankings. Most concerning is the continued increase in bicycle injuries, up to 41 in 2024 from 31 in 2023 and 33 in 2022. In a bright spot, however, injury of bicyclists under 15 dropped by 50% in 2024, continuing a promising downward trend. Given that the latest 2022 OTS Crash Rankings place

all but one of Napa County's jurisdictions in the worst one-third for bicycle crashes for cities of comparable size (13%-29%, except American Canyon at 67%), alongside Napa County's increasing number of bicycle crashes, it is probable that 2024 data, in comparison to similar cities, reflect a portrait of Napa County as an area with some of the worst rates of bicycle crashes in the state.

Over the 2022-2024 federal fiscal years, SWITRS data shows that the highest number of bicycle crashes occur between 3:00-6:00 pm. This is also the time when the second highest number of pedestrian crashes occur, with the highest number occurring in the following hours from 6:00-9:00 pm. Not only are traffic volumes high during these hours, but for much of the year they incorporate dusk or dark. As well, this data show that 59% of bicycle crashes are broadsides. Approximately 80% of bicycle crash victims are male, and 13% are 14 years old or younger. Males are also overrepresented in pedestrian crashes, and of note as well is that 100% of crashes involving pedestrians age 14-years or younger during this period were male. Napa Valley Transportation Authority's 2023 Vision Zero Plan identified the top three factors reflected in Napa County crash records: unsafe speeds, driving under the influence, and broadside crashes. The sixth, seventh, and eighth top factors, respectively, were: pedestrians hit in crosswalks at intersections, pedestrians hit crossing outside crosswalks or walking in the road, and bicycle crashes at intersections. These factors also point both to the need for safety education, as well as to messaging that incorporates these local considerations.

Define the target population the grant intends to serve and how they are affected by the problem(s).

Given local data on already high and increasing bicycle crashes throughout Napa Valley, the grant intends to serve bicyclists primarily, while incorporating pedestrian safety education as well. Bicyclists of all ages, and particularly those who ride in the afternoon and evening, can benefit from better information and tools that support safe riding. Both bicyclists and pedestrians are vulnerable road users that are disproportionately impacted by traffic crashes, in comparison to motorists. People walking and biking in Napa County accounted for 18% of fatal and serious injury crashes between 2015-2021 (Napa Valley Transportation Authority's 2023 Vision Zero Plan) but just 5% of residents commute by bike or on foot (2019 Napa Countywide Bicycle Plan).

Based on experience facilitating safety education in Napa County, providing programming to youth, especially when taking opportunities to involve their parents, provides the best return on investment. Adults, who are not regularly gathered in school sites or centers, require much more outreach and advertising to engage, and ultimately fewer resources are then dedicated to the actual safety intervention and learning. Still, data show a need to reach bicyclists of all ages, so the grant intends to directly target interventions to parents and other adults as well. Nearly everyone who rides a bicycle or drives is also a pedestrian, so while the data points to a need to emphasize bicycle safety, the grant will also address pedestrian safety techniques, especially when those techniques are applicable to both modes, such as increasing visibility and the importance of "hands-free" travel.

According to an EMC Research survey of Napa County parents in 2021, 4th grade is when there is a significant increase in the number of parents who feel comfortable with their children walking or biking for transportation (walking or biking to school). As well, from experience working with various grade levels, 3rd to 5th grade is when the number of youth who have learned to ride a bicycle increases. With more youth riding, it is key that they learn and incorporate practices that can prevent crashes and reduce crash severity and that they develop good habits early. Focusing on youth will not only reduce crashes in victims below the age of 15, it will hopefully instill safety habits and foundational learnings at a young age that a generation of walkers and riders will carry with them into adulthood, reducing crashes in later years in groups who are over 14-years-old, as these youth become adults. When students know how to walk and bike more safely, both students and parents will feel more comfortable doing so; 85% of Napa County parents said they would feel more comfortable with their children biking to school if their children were provided free bicycle safety courses.

According to the 2019 Napa Countywide Bicycle Plan, the category of bicyclists known as "interested but concerned" accounts for 50-56% of the general public. Those in this group tend to be less experienced riders for whom safety concerns are a larger barrier. Adults in this category will be targeted by proposed grant objectives, as both need for, and interest in, safety education tends to be higher than for those who identify as "highly confident" riders. As well, confident and highly confident riders tend to have a more developed cycling community and often enjoy the increased protection that comes with riding in groups ([Transportation Research Part F: Traffic Psychology and Behaviour Volume 91](#), November 2022, Pages 26-44.)

Data confirm that residents of Napa County of all ages are in need of countermeasures that reduce crashes, with a prominent need to reduce bicycle crashes and a need to reduce pedestrian crashes, particularly during evening and at night. Given the aforementioned lack of progress in best practice road engineering, along with the in- and out-migration of Napa County Students and high rate of intra-county travel, there is a county-wide need for intervention, more so than a need to target behavior change strategies in one jurisdiction or particular neighborhood. Knowing under-resourced schools and families may be more in need of additional safety resources, the grant intends to prioritize serving high needs schools and underserved populations.

With the support of Office of Traffic Safety funding, evidence-based strategies are being deployed countywide again in a consistent manner and at a dosage appropriate to bring about change. Given the documented need to continue providing bicycle and pedestrian safety education, we request the Office of Traffic Safety award the Napa Police Department a 2025-26 Bicycle and Pedestrian Safety grant to help ensure a measurable reduction in fatal and serious injury crashes.

2. PERFORMANCE MEASURES

A. Goals:

1. Reduce the number of persons killed in traffic crashes.
2. Reduce the number of persons injured in traffic crashes.
3. Reduce the number of pedestrians killed in traffic crashes.
4. Reduce the number of pedestrians injured in traffic crashes.
5. Reduce the number of pedestrians killed under age 15 in traffic crashes.
6. Reduce the number of pedestrians injured under age 15 in traffic crashes.
7. Reduce the number of pedestrians killed over age 65 in traffic crashes.
8. Reduce the number of pedestrians injured over age 65 in traffic crashes.
9. Reduce the number of bicyclists killed in traffic crashes.
10. Reduce the number of bicyclists injured in traffic crashes.
11. Reduce the number of bicyclists under age 15 killed in traffic crashes.
12. Reduce the number of bicyclists under age 15 injured in traffic crashes.
13. Increase bicycle helmet usage.

3. METHOD OF PROCEDURE

A. Phase 1 – Program Preparation (1st Quarter of Grant Year)

- Develop operational plans to implement the “best practice” strategies outlined in the objectives section.
- Conduct all training needed to implement the program, in the first quarter.
- Purchase all grant related supplies and materials to implement the program, in the first quarter.
- Items with a unit cost of \$5,000 or more (including tax and shipping) must comply with Buy America.

Media Requirements

- Issue a news release approved by the OTS PIO announcing the kick-off of the grant by December 31 and after the grant is signed and executed, but no sooner than October 1, the start of the grant year. The kick-off release must be approved by the OTS PIO. If you are unable to meet the December 31 deadline to issue a kick-off press release, communicate reasons to your OTS grant coordinator and OTS PIO.

Program preparation will include the activities listed above. Additionally, any needed MOUs will be updated and executed, and the Safe Routes to School Advisory Committee will do a review of stakeholder involvement and determine if further outreach and engagement in the committee is appropriate. Some outreach and school sign-ups for 2025-26 will begin during the 2024-25 grant period, as would preparations for the October 2025 Walk & Roll to School Day, given that it occurs immediately following the start of the grant period.

B. Phase 2 – Program Operations (Throughout Grant Year)

Media Requirements

The following requirements are for all grant-related activities:

- Send all media advisories, alerts, videos, graphics, artwork, posters, radio/PSA/video scripts, storyboards, digital and/or print educational materials for grant-related activities to the OTS PIO at pio@ots.ca.gov for approval and copy your OTS grant coordinator. Optimum lead time would be 7 days before the scheduled release but at least 3 business days prior to the scheduled release date for review and approval is appreciated.
- Send all PowerPoint presentations, online presentations and trainings for grant-related activities to the OTS PIO at pio@ots.ca.gov for approval and copy your OTS grant coordinator. Certified training courses are EXEMPT from the approval process.
- The OTS PIO is responsible for the approval of the design and content of materials. The agency understands OTS PIO approval is not authorizing approval of budget expenditure or cost. Any cost approvals must come from the OTS grant coordinator.
- Pre-approval is not required when using any OTS-supplied template for media advisories, news releases, social media graphics, videos or posts, or any other OTS-supplied educational material. However, copy the OTS PIO at pio@ots.ca.gov and your OTS grant coordinator when any

material is distributed to the media and public, such as a news release, educational material, or link to social media post.

- If an OTS-supplied template, educational material, social media graphic, post or video is substantially changed, the changes shall be sent to the OTS PIO at pio@ots.ca.gov for approval and copy your OTS grant coordinator.
- News releases, social media posts and alerts on platforms such as NextDoor and Nixle reporting immediate and time-sensitive grant activities (e.g. enforcement operations, day of event highlights or announcements, event invites) are EXEMPT from the OTS PIO approval process. The OTS PIO and your OTS grant coordinator should still be notified when the grant-related activity is happening (e.g. car seat checks, bicycle rodeos, community presentations, DUI checkpoints, etc.).
- Enforcement activities such as warrant and probation sweeps, court stings, etc. that are embargoed or could impact operations by publicizing in advance are EXEMPT from the PIO approval process. However, announcements and results of activities should still be copied to the OTS PIO at pio@ots.ca.gov and your OTS grant coordinator with the embargoed date and time or with "INTERNAL ONLY: DO NOT RELEASE" message in subject line of email.
- Any earned or paid media campaigns for TV, radio, digital or social media that are part of a specific grant objective, using OTS grant funds, or designed and developed using contractual services by a subgrantee, requires prior approval.
- Social media posts highlighting state or national traffic safety campaigns (Distracted Driving Month, Motorcycle Safety Awareness Month, etc.), enforcement operations (DUI checkpoints, etc.), or any other grant-related activity such as Bicycle rodeos, presentations, or events, are highly encouraged but do not require prior approval.
- Submit a draft or rough-cut of all digital, printed, recorded or video material (brochures, posters, scripts, artwork, trailer graphics, digital graphics, social posts connected to an earned or paid media campaign grant objective) to the OTS PIO at pio@ots.ca.gov and copy your OTS grant coordinator for approval prior to the production or duplication.
- Use the following standard language in all press, media, and printed materials, space permitting: Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.
- Space permitting, include the OTS logo on all grant-funded print materials, graphics and paid or earned social media campaign grant objective; consult the OTS PIO and copy your OTS grant coordinator for specifics, format-appropriate logos, or if space does not permit the use of the OTS logo.
- Email the OTS PIO at pio@ots.ca.gov and copy your OTS grant coordinator at least 21 days in advance, or when first confirmed, a short description of any significant grant-related traffic safety event or program, particularly events that are highly publicized beforehand with anticipated media coverage so OTS has sufficient notice to arrange for attendance and/or participation in the event. If unable to attend, email the OTS PIO and coordinator brief highlights and/or results, including any media coverage (broadcast, digital, print) of event within 7 days following significant grant-related event or program. Media and program highlights are to be reflected in QPRs.
- Any news releases, work plans, scripts, storyboards, artwork, graphics, videos or any educational or informational materials that received OTS PIO approval in a prior grant year needs to be resubmitted for approval in the current grant year.
- For additional guidance, refer to the [OTS Grants Materials Approval Process Guidelines](#) and [OTS Grants Media Approval Process FAQs](#) on the OTS website.
- Contact the OTS PIO or your OTS grant coordinator for consultation when changes from any of the above requirements might be warranted.

In addition to continued planning, the first month of the grant will be focused on implementing Walk to School Day, the administration of helmet usage surveys, and continuing classroom-based presentations with bike rodeo. Grant administrators will engage in a process of project management for each objective, guided by the timeline defined in the operational plan. This will generally include: developing and distributing communications, preparing materials and any undeveloped content, implementing the objective, evaluating the objective, and making refinements based on evaluation feedback and lessons learned. Publicity for the grant and grant activities will occur in accordance with OTS requirements. As well, through the Safe Routes to School Partnership, we will agendize exploring additional potential

funding streams that nonprofit and other partners may be able to access so that safety programming and funding can be diversified and reliance on OTS funding can be reduced.

C. Phase 3 – Data Collection & Reporting (Throughout Grant Year)

1. Prepare and submit grant claim invoices (due January 30, April 30, July 30, and October 30)
2. Prepare and submit Quarterly Performance Reports (QPR) (due January 30, April 30, July 30, and October 30)
 - Collect and report quarterly, appropriate data that supports the progress of goals and objectives.
 - Provide a brief list of activity conducted, procurement of grant-funded items, and significant media activities. Include status of grant-funded personnel, status of contracts, challenges, or special accomplishments.
 - Provide a brief summary of quarterly accomplishments and explanations for objectives not completed or plans for upcoming activities.
 - Collect, analyze and report statistical data relating to the grant goals and objectives.

In addition to the data collections activities mentioned above, helmet surveys will be administered prior to helmet distribution at schools and will be administered again late in the 2025-26 school year. This data will be compiled, analyzed, and uploaded in the final grant report. As well, participant and teacher evaluations will be administered for all grant objectives in which paper evaluations are feasible and appropriate.

4. METHOD OF EVALUATION

Using the data compiled during the grant, the Grant Director will complete the “Final Evaluation” section in the fourth/final Quarterly Performance Report (QPR). The Final Evaluation should provide a brief summary of the grant’s accomplishments, challenges and significant activities. This narrative should also include whether goals and objectives were met, exceeded, or an explanation of why objectives were not completed.

5. ADMINISTRATIVE SUPPORT

This program has full administrative support, and every effort will be made to continue the grant activities after grant conclusion.

Pedestrian and Bicycle Traffic Safety Education Program - Pedestrian and Bicycle Traffic Safety Education Program - Grantee will seek a contractor to assist with fulfilling the goals and objectives of this grant by conducting pedestrian and/or bicycle traffic safety education activities that may include presentations, on-foot safety trainings, bike rodeos, community bike rides, helmet fittings and distributions, bike repair workshops, and outreach at community events. Other activities may be conducted if approved by OTS.

Prior to finalizing the subcontract, grantee will work with the OTS to ensure all costs are allowable. Upon execution of subcontract, grantee will provide a copy to the OTS and will request a grant budget revision to include the detailed costs of the subcontract in the grant budget as a prerequisite for claiming these costs.

If a conflict of interest is found to exist, NHTSA may (a) terminate the award, or (b) determine that it is otherwise in the best interest of NHTSA to continue the award and include appropriate provisions to mitigate or avoid such conflict.
3. Conflicts of interest that require disclosure include all past, present, or currently planned organizational, financial, contractual, or other interest(s) with an organization regulated by NHTSA or with an organization whose interests may be substantially affected by NHTSA activities, and which are related to this award. The interest(s) that require disclosure include those of any recipient, affiliate, proposed consultant, proposed subcontractor, and key personnel of any of the above. Past interest shall be limited to within one year of the date of award. Key personnel shall include any person owning more than a 20 percent interest in a recipient, and the officers, employees or agents of a recipient who are responsible for making a decision or taking an action under an award where the decision or action can have an economic or other impact on the interests of a regulated or affected organization.

PROHIBITION ON USING GRANT FUNDS TO CHECK FOR HELMET USAGE (applies to subrecipients as well as States)

The State and each subrecipient will not use 23 U.S.C. Chapter 4 grant funds for programs to check helmet usage or to create checkpoints that specifically target motorcyclists.

POLICY ON SEAT BELT USE

In accordance with [Executive Order 13043](#), Increasing Seat Belt Use in the United States, dated April 16, 1997, the Grantee is encouraged to adopt and enforce on-the-job seat belt use policies and programs for its employees when operating company-owned, rented, or personally-owned vehicles. The National Highway Traffic Safety Administration (NHTSA) is responsible for providing leadership and guidance in support of this Presidential initiative. For information and resources on traffic safety programs and policies for employers, please contact the Network of Employers for Traffic Safety (NETS), a public-private partnership dedicated to improving the traffic safety practices of employers and employees. You can download information on seat belt programs, costs of motor vehicle crashes to employers, and other traffic safety initiatives at www.trafficsafety.org. POLICY ON BANNING TEXT MESSAGING WHILE DRIVING

In accordance with [Executive Order 13513](#), Federal Leadership On Reducing Text Messaging While Driving, and DOT Order 3902.10, Text Messaging While Driving, States are encouraged to adopt and enforce workplace safety policies to decrease crashes caused by distracted driving, including policies to ban text messaging while driving company-owned or rented vehicles, Government-owned, leased or rented vehicles, or privately-owned vehicles when on official Government business or when performing any work on or behalf of the Government. States are also encouraged to conduct workplace safety initiatives in a manner commensurate with the size of the business, such as establishment of new rules and programs or re-evaluation of existing programs to prohibit text

messaging while driving, and education, awareness, and other outreach to employees about the safety risks associated with texting while driving.
