**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA’s operations, programs, and services. They also inform HUD, families served by the PHA, and members of the public of the PHA’s mission, goals, and objectives for serving the needs of low-, very low-, and extremely low- income families.

**Applicability.** The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form. PHAs with zero public housing units must continue to comply with the PHA Plan requirements until they closeout their Section 9 programs (ACC termination).

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers (HCVs) and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, SEMAP for PHAs that only administer tenant-based assistance and/or project-based assistance, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or HCVs combined and is not PHAS or SEMAP troubled.

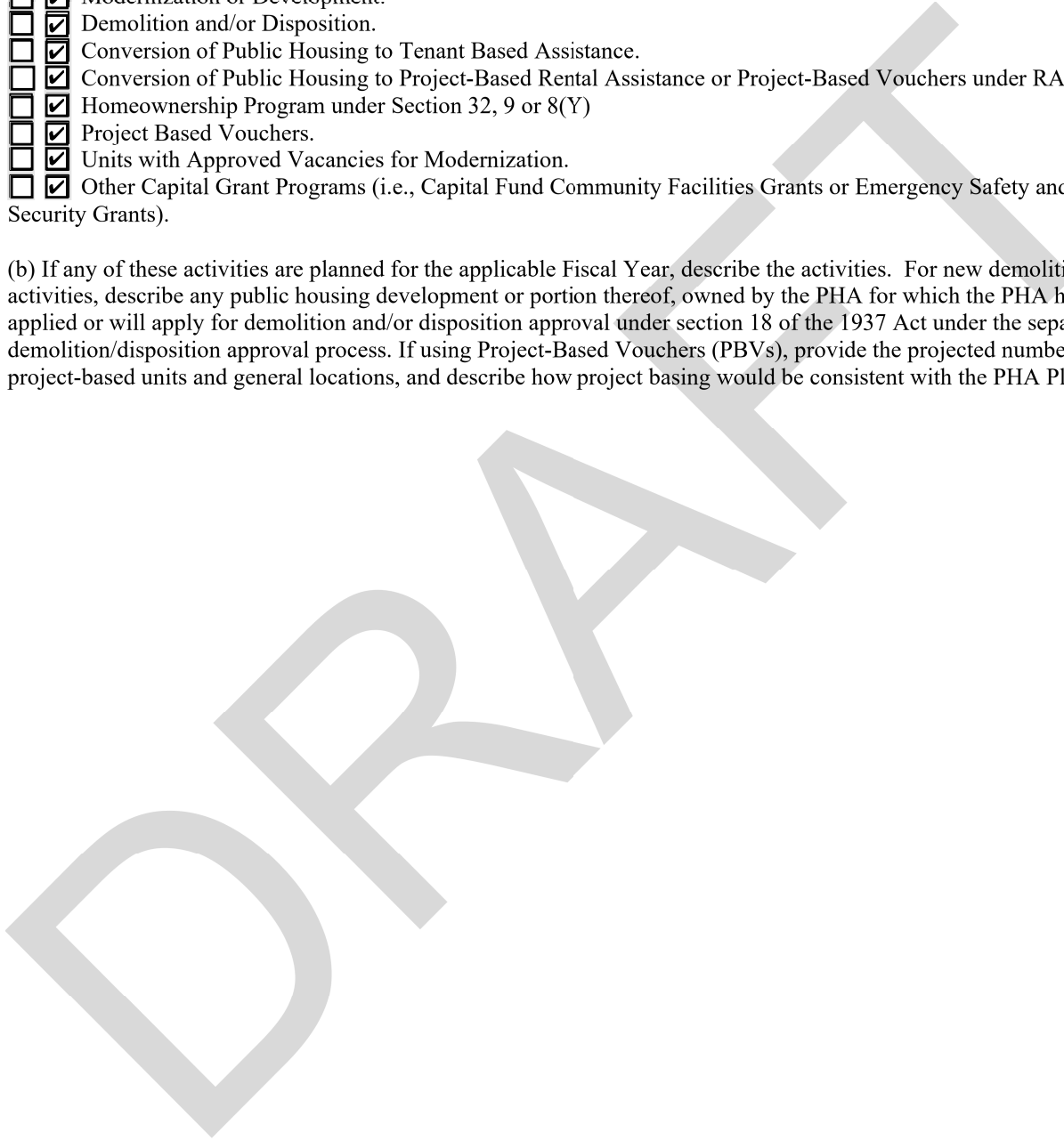

The following are the PHA's achievements in 2025 towards the PHA's mission and goals identified in the Five Year Plan for 2025-2030

1. The PHA currently has 48 families on the Family Self Sufficiency (FSS) Program. In FY 2025 ten FSS families graduated from the FSS program. The PHA is diligently working towards increasing the number of FSS participants and graduates from the program by developing relationships with community partners to expand supportive services and improve employability of participants.
2. The PHA continues to partner and contract with Fair Housing Napa Valley to provide fair housing assistance to help ensure equal opportunity in housing.
3. The PHA actively participated in Napa County Continuum of Care (COC).
4. The PHA continues to contract with Abode Services to assist voucher holders who are homeless, at-risk of homelessness, or who have an Emergency Housing Voucher to locate suitable housing. Participants receive housing search assistance and landlords can receive incentives and enroll in a mitigation program to offset the cost of tenant-caused damages.
5. The PHA received a Higher Performer designation for SEMAP for the fiscal year ending June 30, 2025.
6. The PHA was awarded an additional 15 VASH vouchers and issued 15, of which 14 have leased as of January 2026

The PHA certifies that it will carry out the public housing program of the agency in conformity with Title VI of the Civil Rights Act of 1964 (42 U.S.C. 2000d-2000d—4), the Fair Housing Act (42 U.S.C. 3601-19), Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794), Title II of the Americans with Disabilities Act (42 U.S.C. 12101 *et seq.*), the Violence Against Women Act (34 U.S.C. § 12291 *et seq.*), and other applicable civil rights requirements, and that it will affirmatively further fair housing in the administration of all HUD programs. In addition, if it administers a Housing Choice Voucher Program, the PHA certifies that it will administer the program in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, Section 504 of the Rehabilitation Act of 1973, Title II of the Americans with Disabilities Act, the Violence Against Women Act, and other applicable civil rights requirements, and that it will affirmatively further fair housing in the administration of all HUD programs. The PHA will affirmatively further fair housing in compliance with the Fair Housing Act, 24 CFR § 5.150 *et seq.*, 24 CFR § 903.7(o), and 24 CFR § 903.15, which means that it will take meaningful actions, in addition to combating discrimination, that overcome patterns of segregation and foster inclusive communities free from barriers that restrict access to opportunity based on protected characteristics. 2. Information provided to applicants and participants will consist of the following: a. information regarding the full range of areas where they may lease units both inside and outside the HACN's jurisdiction; b. a list of landlords or other parties who are willing to lease units or help families find units, including units outside areas of poverty or minority concentration; c. maps that show various areas with housing opportunities outside areas of poverty or minority concentration both within its jurisdiction and its neighboring jurisdiction with the characteristics of those areas which may include information about job opportunities, schools, transportation and other services in these areas; d. the briefing packet contains: 1) a list of Owners who are willing to lease properties outside areas of poverty and minority concentrations under the rental voucher program; 2) a current list of other organizations that will help families find units outside areas of poverty or minority concentration; 3) an explanation of how portability works including a list of portability contact persons for neighboring housing agencies, with the name, address and telephone number of each

### VAWA Attachment

This attachment responds to the requirements of the Violence Against Women Reauthorization Act of 2013 (VAWA). This Act requires Five-Year and Annual Plans to contain information regarding the PHA's goals, objectives, policies or programs that will enable the PHA to serve the needs of child and adult victims of domestic violence, dating violence, sexual assault, or stalking.

There are number of resources in Napa County for victims of violence and sexual assault, including the following:

Notification to Participants: The HACN provides all participants with notification of their protections and rights under VAWA at the time of admission and is available to participants at annual reexamination. Notification will also be provided when a tenant is notified of eviction or termination of housing benefits. This notice explains the protections afforded under the law and informs the participant of PHA confidentiality requirements. HACN provides contact information for local victim advocacy groups or service providers. HUD-50066 form also provided with notification brochure.

Notification to Applicants: The HACN provides to all applicants notification of their protections and rights under VAWA at the time they receive their Housing Choice Voucher and in all notices of denial. The notice explains the protections afforded under the law and informs each applicant of PHA confidentiality requirements. HACN provides contact information for local victim advocacy groups or service providers. HUD-50066 form also provided with notification brochure.

Notifications to Owners And Managers: The HACN informs property owners and managers of their screening and termination responsibilities related to VAWA. The
