RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NAPA, STATE OF CALIFORNIA, ESTABLISHING THE AMENDED 2025 CALENDAR FOR REGULAR AND SPECIAL CITY COUNCIL MEETINGS AND CITY HOLIDAYS BY APPROVING THE ADDITION OF JUNETEENTH (JUNE 19, 2025) AS A RECOGNIZED CITY HOLIDAY

WHEREAS, the time and place of regular meetings of the City of Napa City Council are governed by City Charter Section 60, Napa Municipal Code Section 2.04.050, and City Council Policy Resolution No. 19; and

WHEREAS, the regular meetings of the City Council are set for the first and third Tuesdays of every month, unless modified by a City Council resolution; and

WHEREAS, Napa Municipal Code Section 1.04.030 defines “working day” or “business day” to specifically exclude any Saturday, Sunday, or “City Holiday,” and the City Council intends to define each City Holiday (each date on which the office of the City Clerk is not open to the general public) as identified on Exhibit “A,” attached hereto and incorporated herein by reference; and

WHEREAS, on November 19, 2024, the City Council adopted Resolution R2024-107 establishing the 2025 Calendar for Regular and Special City Council Meetings and City Holidays, and approving the cancellation of the regular meeting of the City Council on July 1, 2025

WHEREAS, as a result of collective bargaining with the City bargaining groups, all groups have adopted Juneteenth as a recognized holiday, with one recognizing it through a floating holiday.

WHEREAS, staff has identified the need to include Juneteenth (June 19, 2025) as a recognized City Holiday as defined above and has prepared this resolution to amend the 2025 Calendar for Regular and Special City Council Meetings and City Holidays as set forth on Exhibit “A,” attached hereto and incorporated herein by reference, which is implemented through this resolution, including the additional holiday.

WHEREAS, the City Council of the City of Napa has considered all information related to this matter, as presented at the public meeting of the City Council identified herein, including any supporting reports by city staff, and any information provided during the public meeting.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Napa, as follows:

1. The City Council hereby finds that the facts set forth in the recitals to this Resolution are true and correct, and establish the factual basis for the City Council's adoption of this Resolution.
2. The City Council hereby approves the addition of Juneteenth (June 19, 2025) as a "City Holiday" as identified on Exhibit "A," attached hereto and incorporated herein by reference.
3. This Resolution shall take effect immediately upon its adoption.
